An increase of **1,290** over the whole year of 2021. Yet 2020 was supposed to be a pandemic year where many people died of covid19.

This increase in deaths is continuing into 2022 as more people die of covid19 vaccine injuries and illnesses.

There are currently **1309277** death events published between **Dec. 31, 1980** and **June 3, 2022**.

At the current rate of death, this is projected to increase to 9,300 deaths approximately over 13 weeks.

These 13 weeks are Quarter 2 of 2022. In Quarter 2 of 2021, 6,700 people died. So Quarter 2 of 2022 is projected to be 2,600 higher than Quarter 2 of 2021. This would be a 39% increase in deaths in Quarter 2 of 2022 compared to the same Quarter in 2021.

These are preliminary figures for deaths and will be adjusted upwards as more detailed information is provided by state authorities and Coroners.

The figures from April 1 2022 to April 8 2022 have not been included and are being sought from the GRO and [www.deathevents.gov.ie](http://www.deathevents.gov.ie). An estimate of around 600 deaths based on deaths during the whole second Quarter of 2022 would be reasonable.

For Quarter 2 of 2022, from April 1<sup>st</sup> to the end of June 2022, the preliminary figures are 8,787 deaths omitting deaths from April 1<sup>st</sup> to April 8<sup>th</sup> 2022. This figure of 8,787 is much higher than the figure of 6,700 for Quarter 2 in 2021. **The increase is 2,087 and is an increase of 31%** ( $2,087/6,700 = 31\%$ )

**This 31% increase is a massive increase in deaths in Ireland in 2022.**

Adding in an estimated 600 deaths figure from April 1<sup>st</sup> to April 8<sup>th</sup> 2022, the new figure is  $8,787 + 600 = 9,387$  people dead for Quarter 2, 2022. This figure of 9,387 is much higher than the figure of 6,700 for Quarter 2 in 2021. The increase is 2,687 and is an increase of 40% ( $2,687/6,700 = 40\%$ ).

**This 40% increase is a massive increase in deaths in Ireland in 2022.**

## Key statistics

- In 2022, there were 29,685 deaths that occurred by 28 February and were registered by 30 April, which is 5,052 (20.5%) more than the historical average.
- In February there were 13,692 deaths, 1,999 (17.1%) above the historical average.
- COVID-19 was the fourth most common cause of death certified by a doctor in February following cancer, dementia and ischaemic heart diseases.
- There was statistically significant excess mortality recorded in the first two months of 2022 (see article).

A 20.1% increase in excess mortality is very significant and points to something killing off large numbers of people in Australia. This coincides with the big rise in covid19 vaccinations from July 2021 up to March 2022 in Australia. 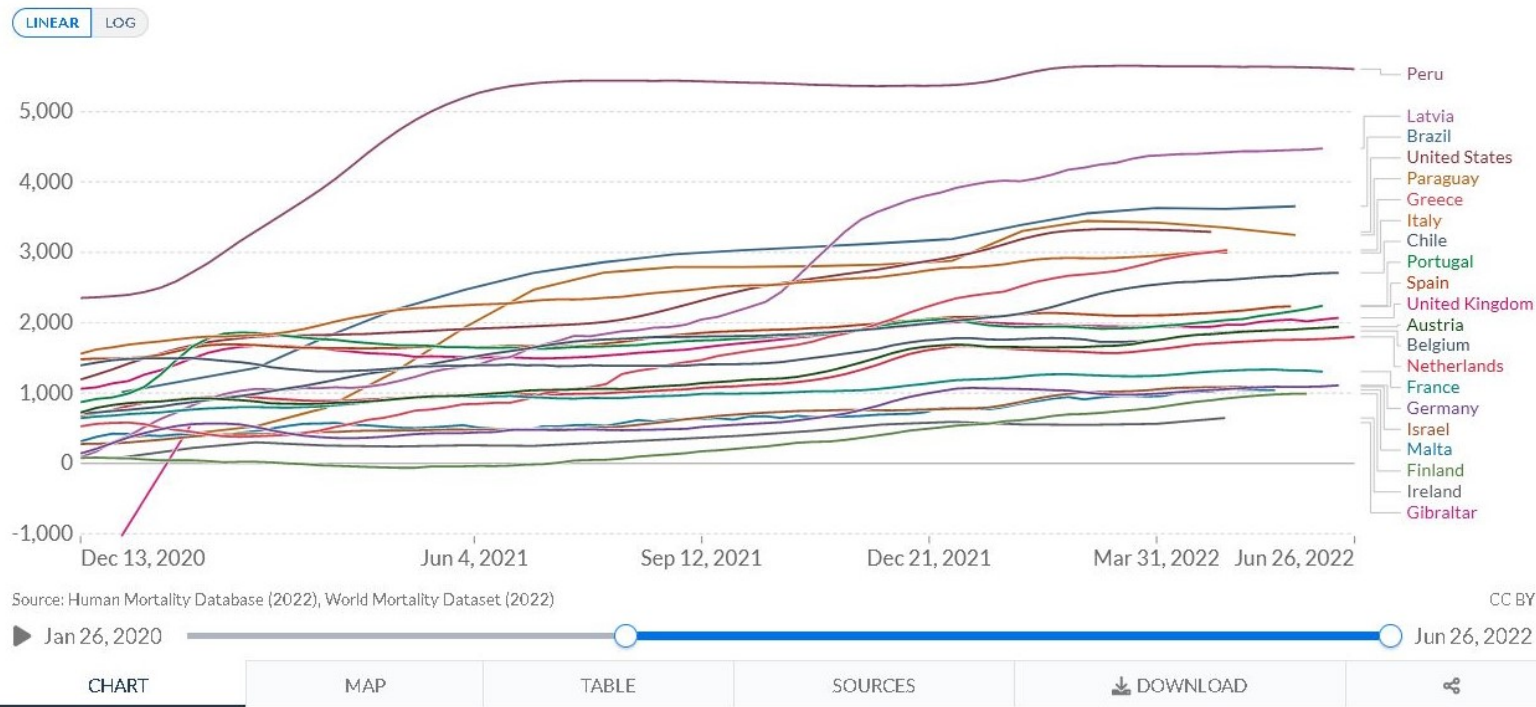


## Excess Mortality has risen significantly in all highly covid19 vaccinated countries since December 2020

### **Legal and Constitutional requirement for Autopsies not cover ups**

There is a need to carry out detailed autopsies of dead covid19 vaccinated people in order to establish how the vaccines and the spike proteins, large clots and new biological structures (see below) and known contaminants are killing vaccinated people. ## **First time detection of the vaccine spike protein and spike protein damage to organs in a person who died after covid19 vaccination – Important Information for all Pathologists and all autopsies of dead vaccinated people**

The suspicion that the spike protein formed in the body as a result of the "vaccination" against Covid-19 could be responsible for the pathologically observed inflammations and lesions of vessels has now been confirmed immunohistologically for the first time.

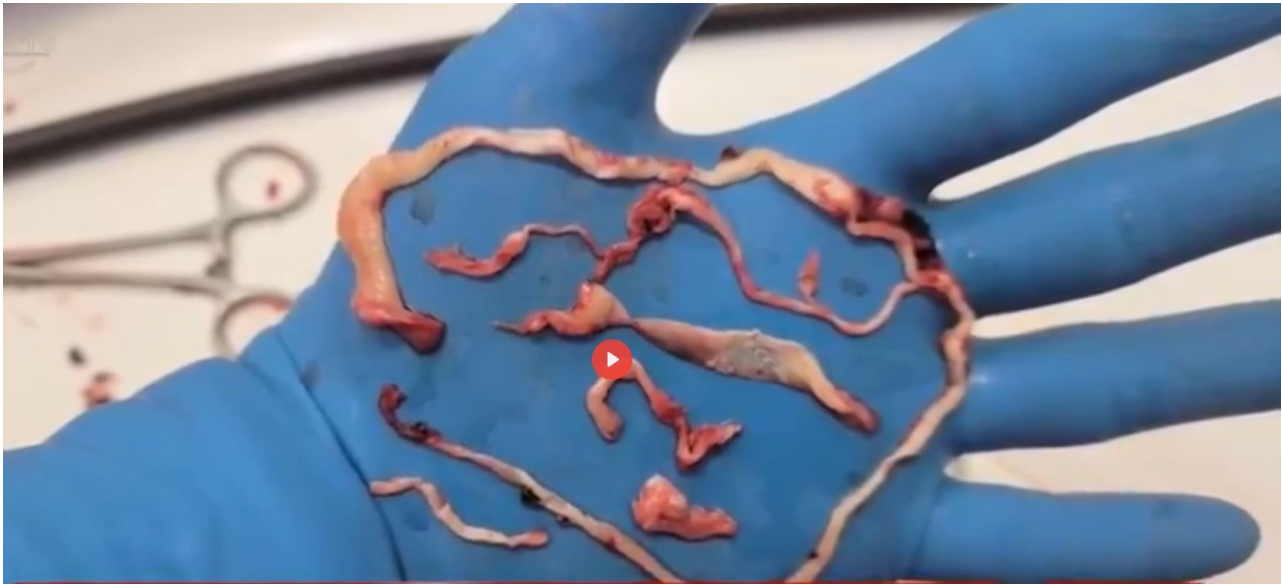

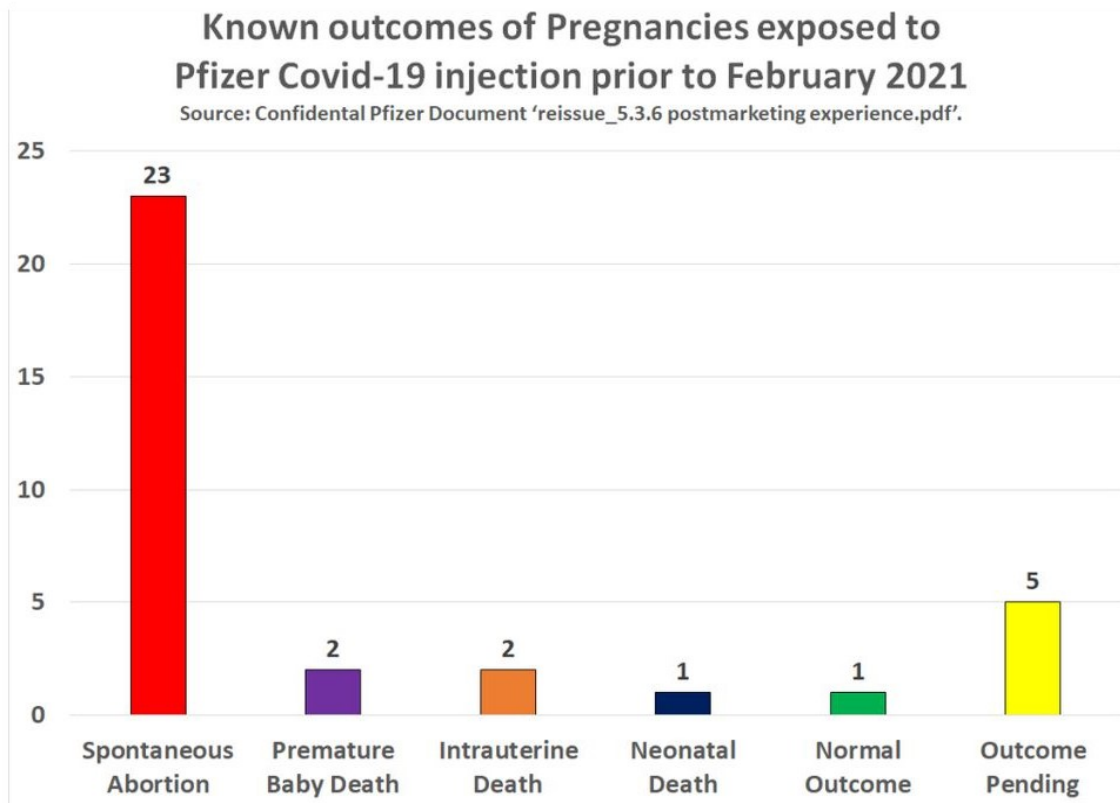

The section covering pregnancy and lactation on pages 12-13, reveals that 20% of the 413 reported cases of adverse events were “serious.” These included 25 miscarriages, 5 fetal deaths as well as uterine contractions during pregnancy, preterm deliveries, premature rupture of membranes and fetal growth restriction. Also included were serious and less serious adverse side effects of breast-fed babies that included infantile vomiting, fever, rash, agitation, and allergy to the vaccine. There were also 6 cases of women having adverse events who received COVID-19 vaccine while breast feeding; some of these include paresis (partial paralysis), suppressed lactation, breast pain, migraines and breast milk discoloration. 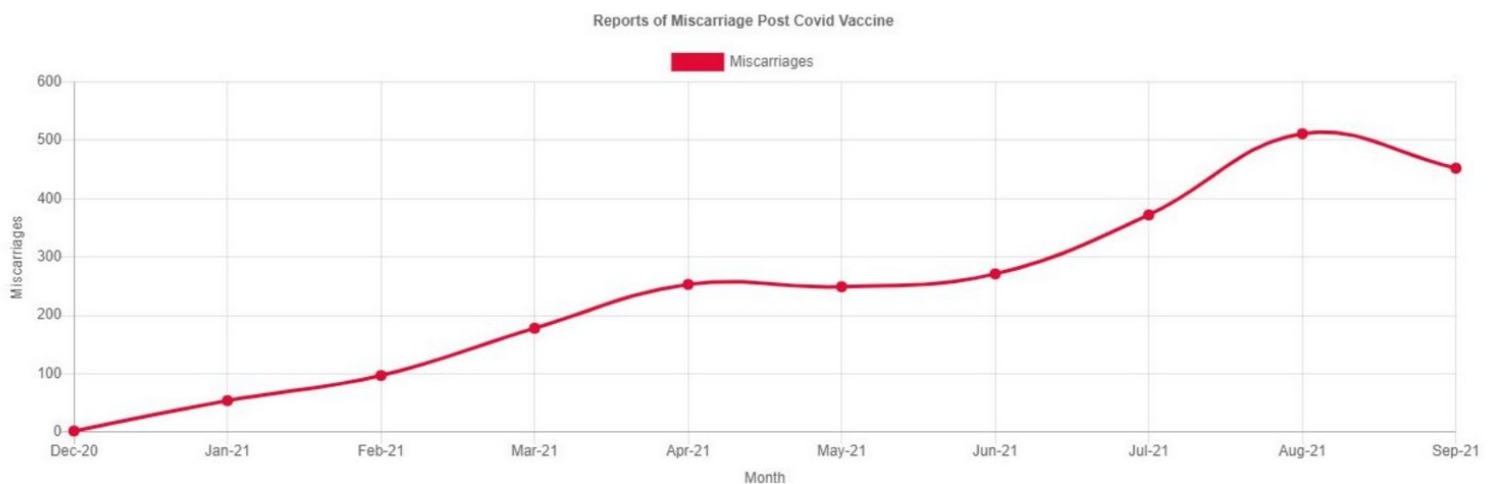


In the Pfizer vaccine trials, there were over 42,000 adverse events and more than 1200 people died. Four of the people who died, died on the day they were injected.

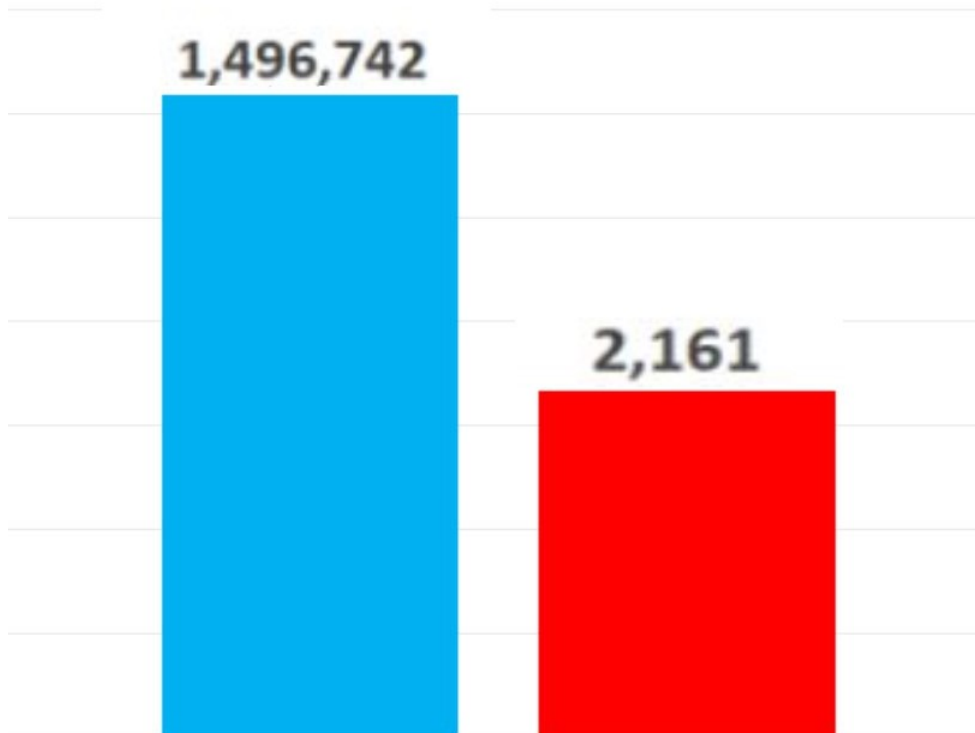

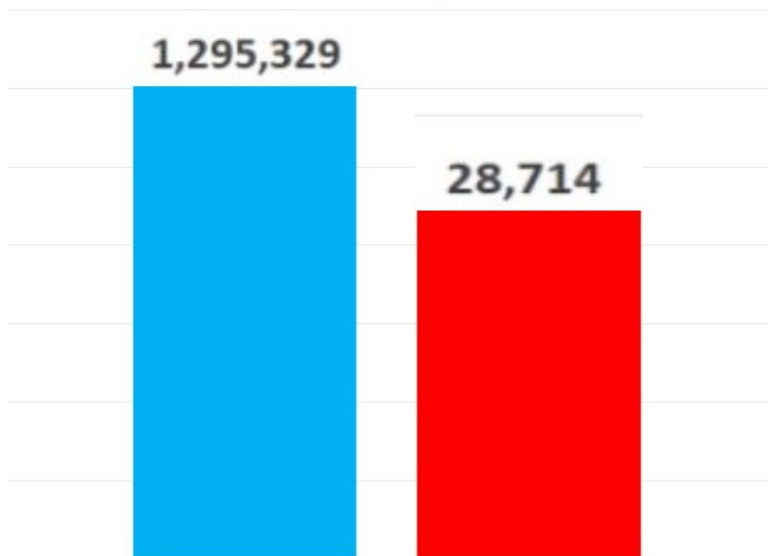

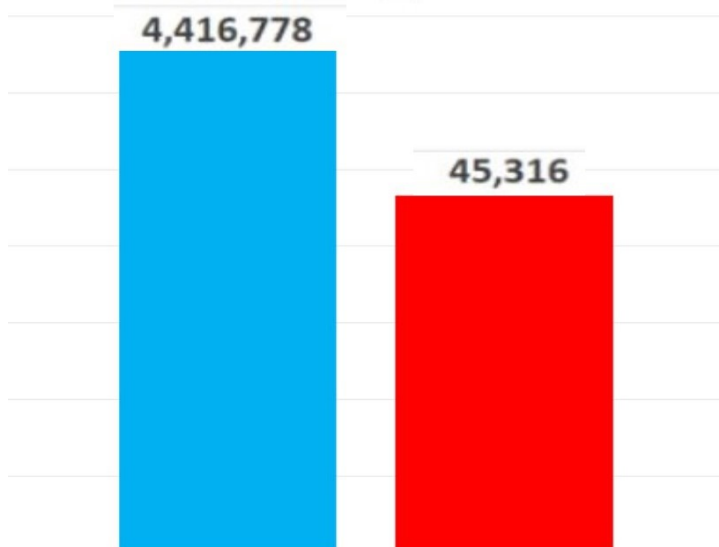

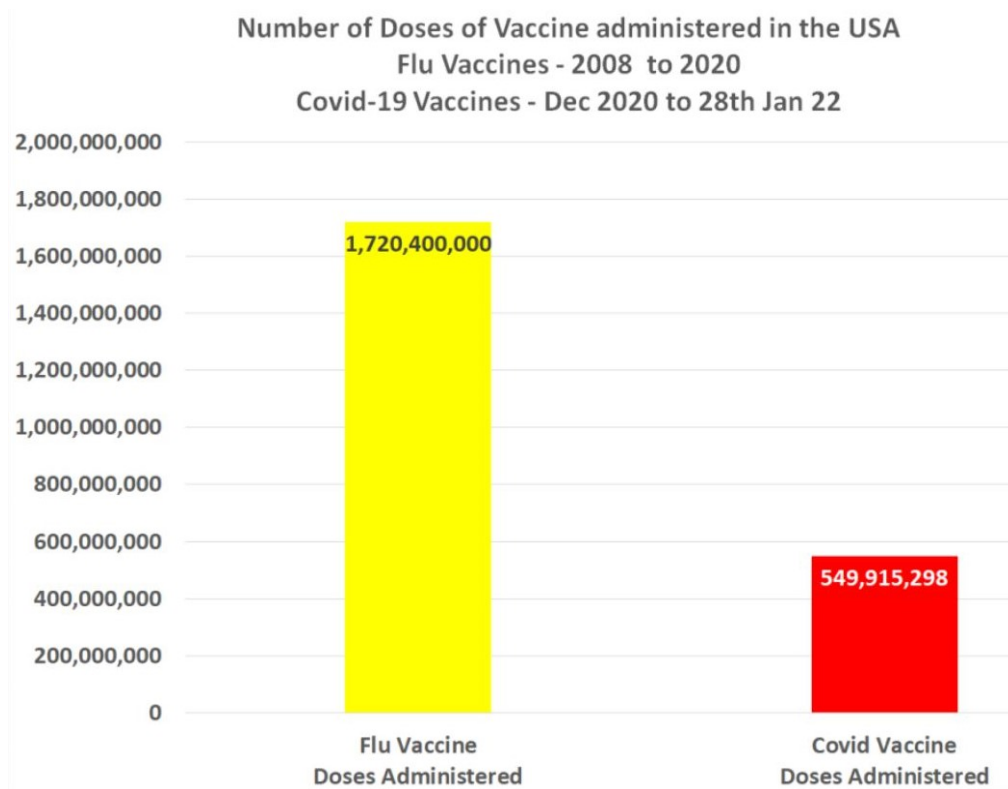

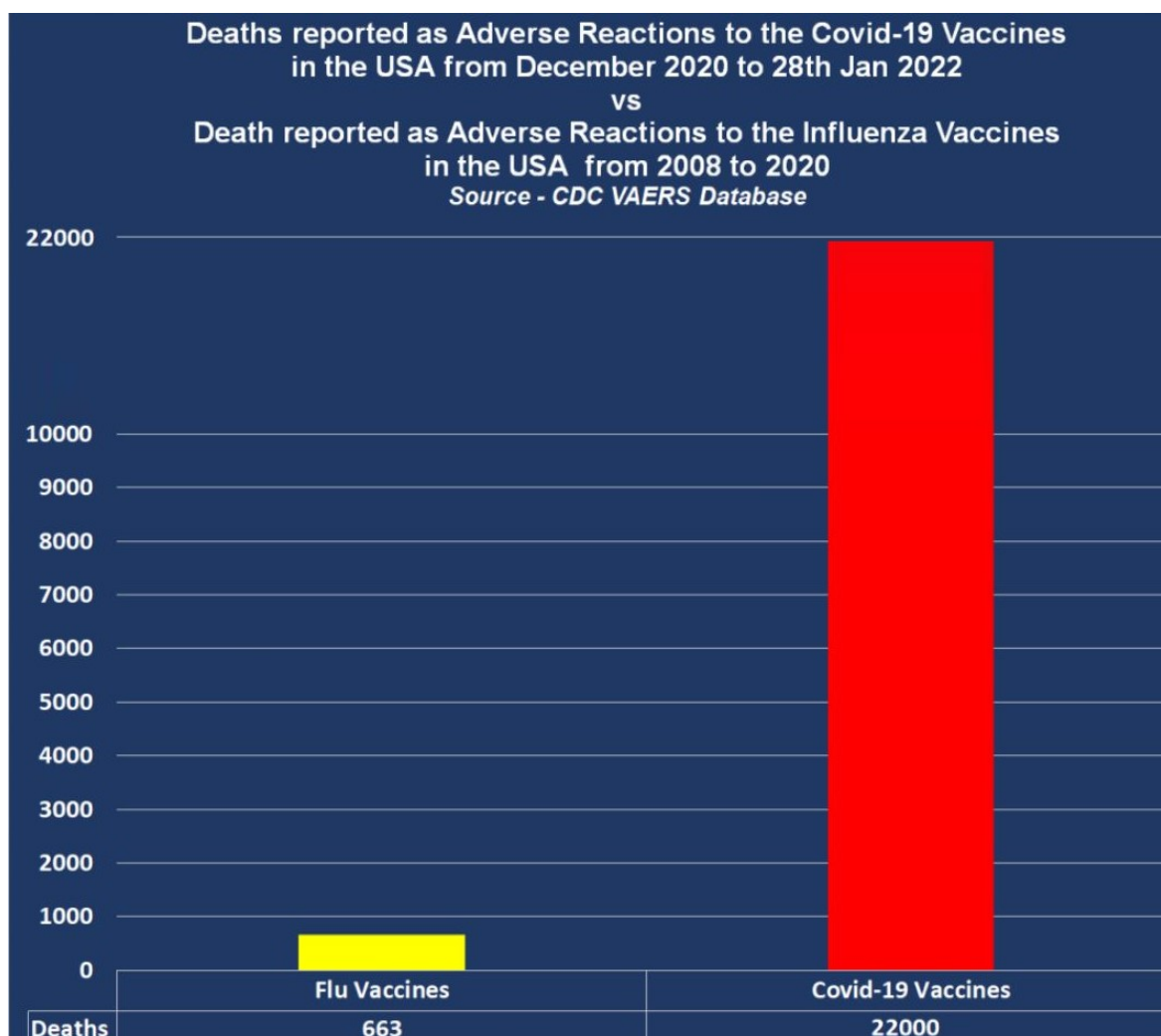
## Comparison of Flu Vaccine to Covid19 vaccine in terms of doses and deaths

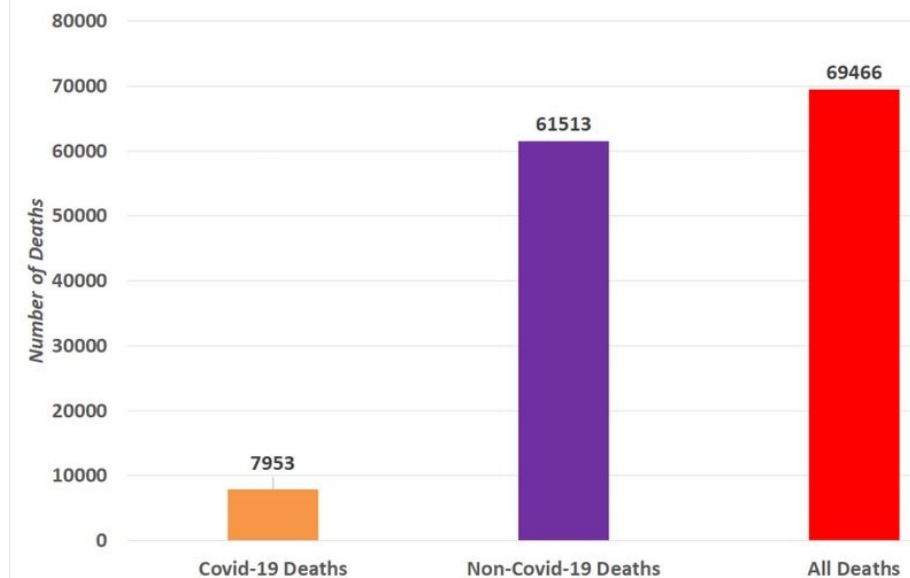
## **Deaths of covid vaccinated people in the UK**

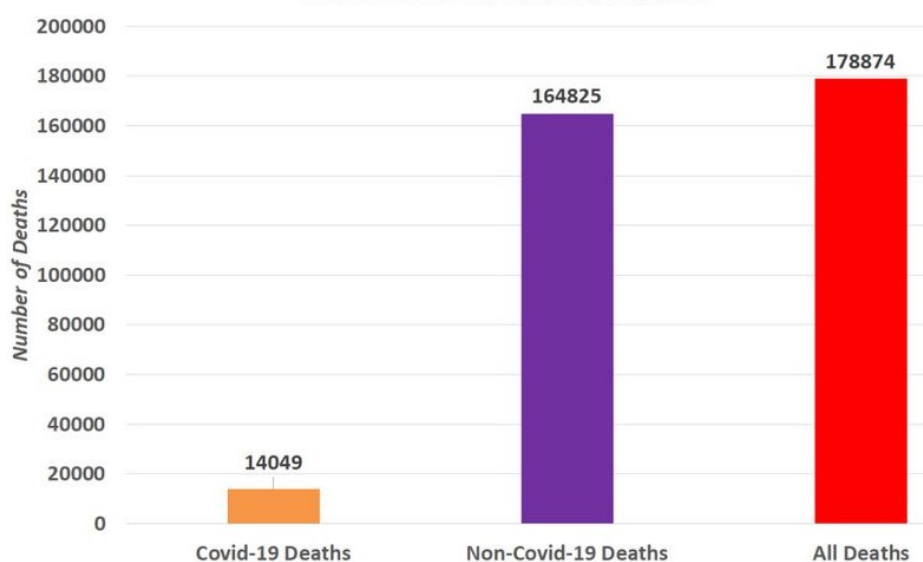

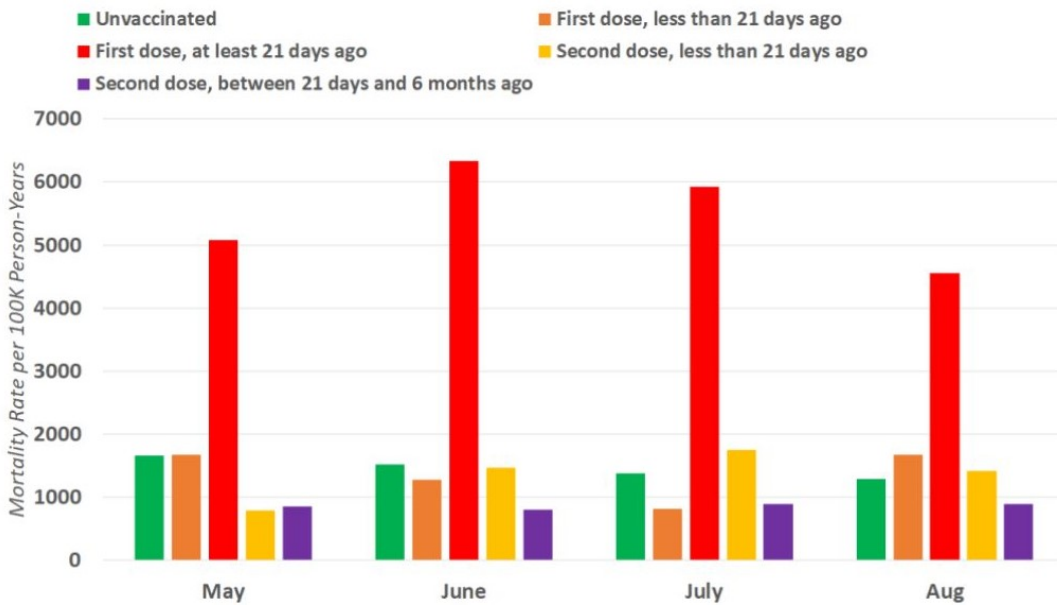

## Age-standardised Mortality Rates per 100,000 person-years by Vaccination Status for Non-Covid-19 Deaths

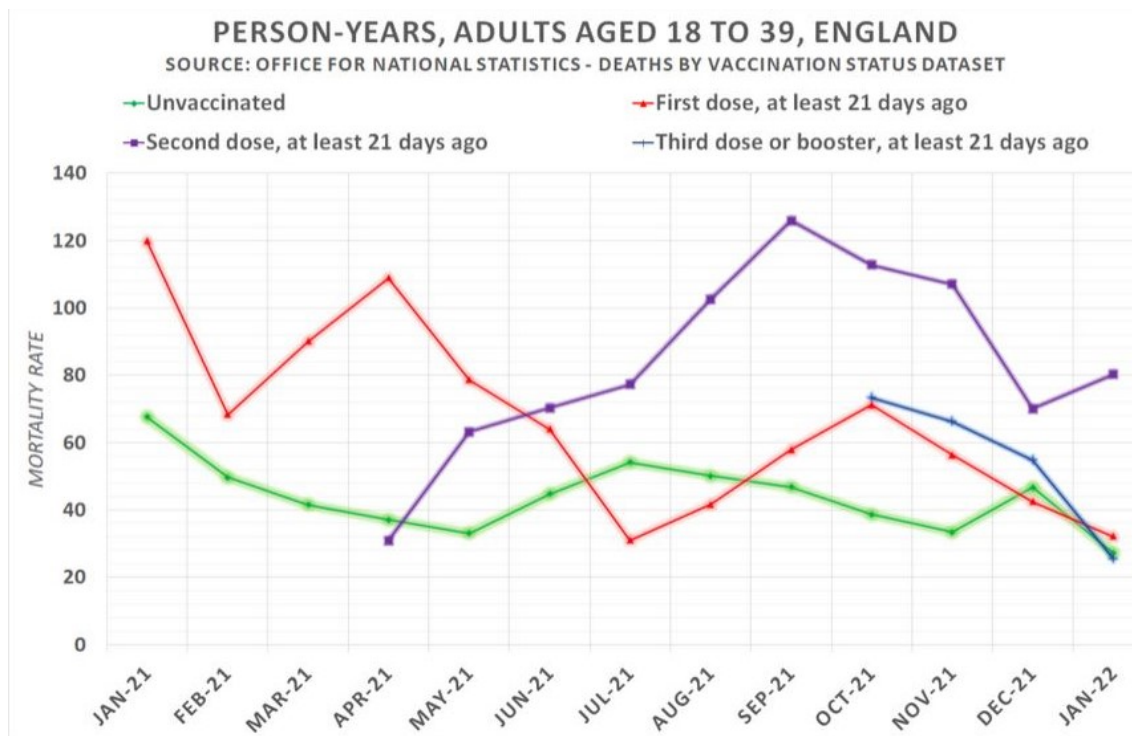

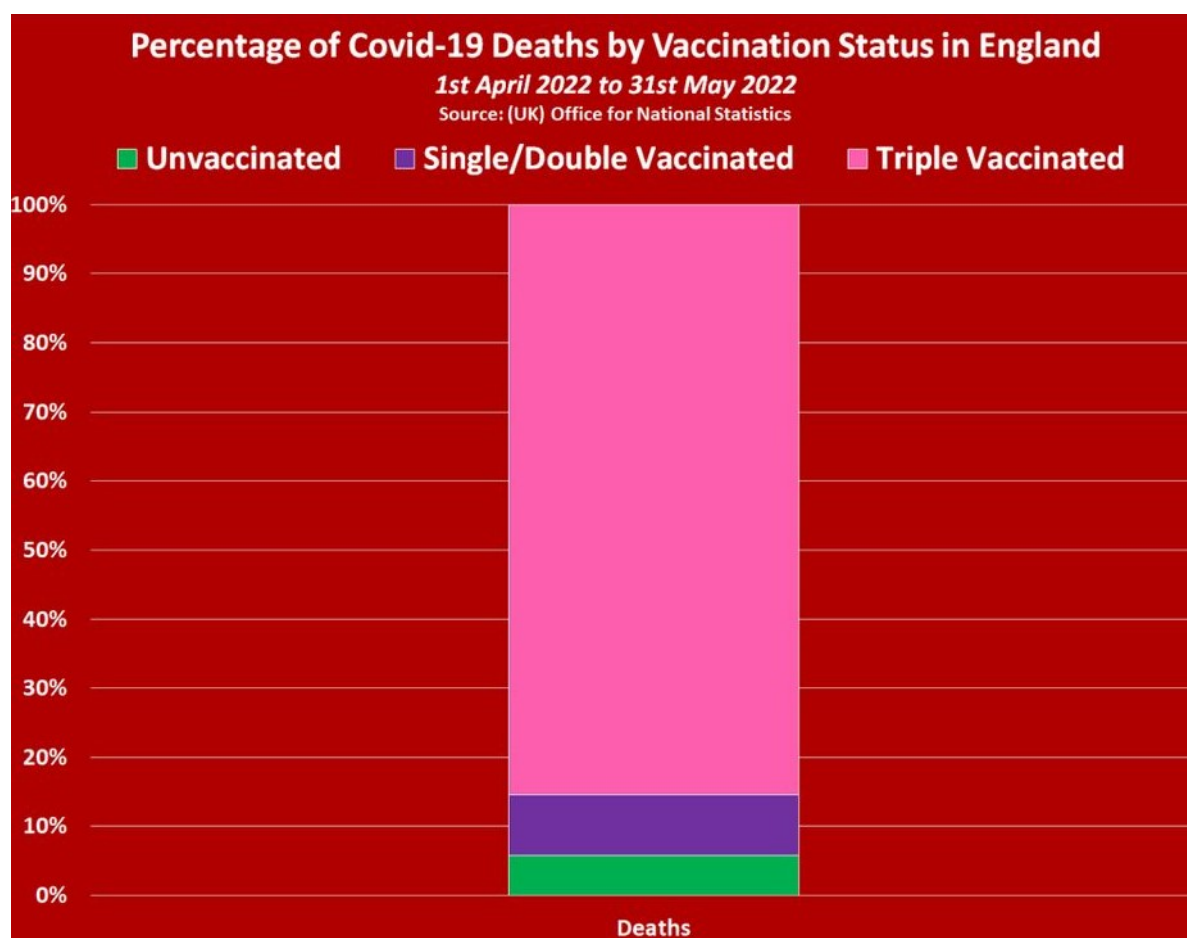

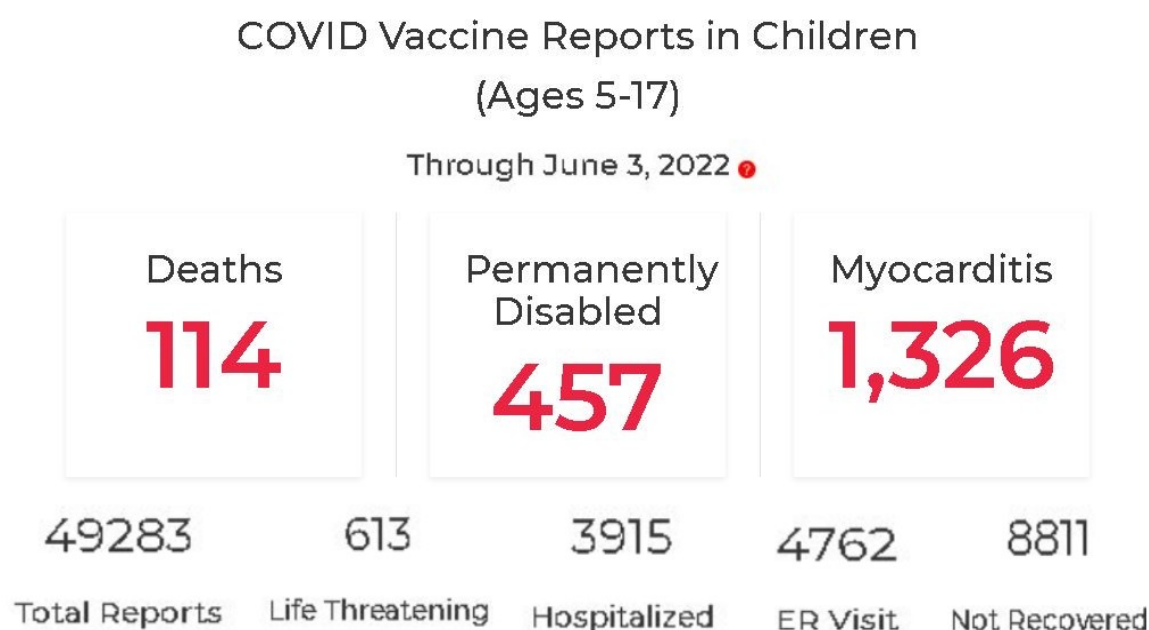

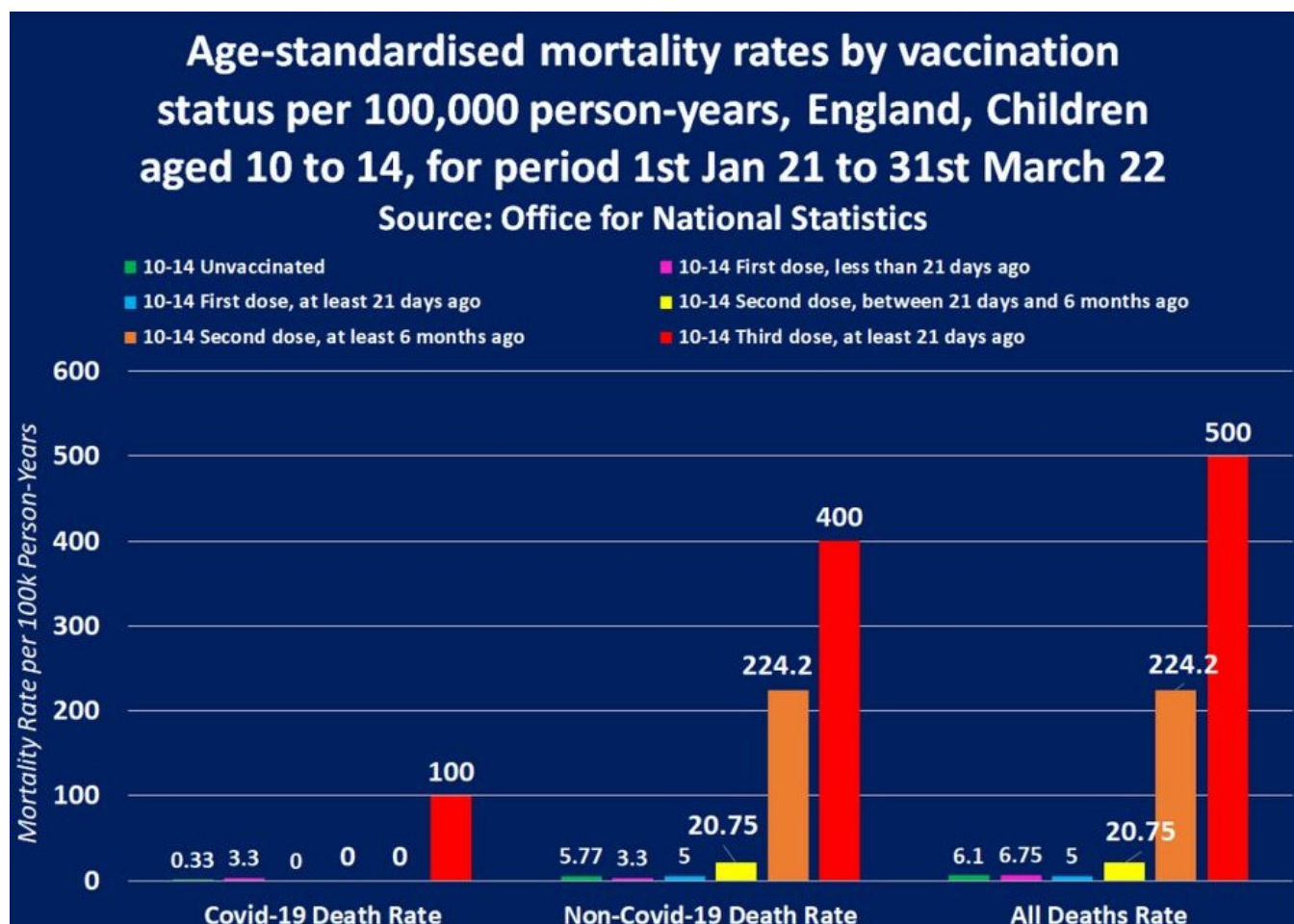
All we need to do is divide the person-years by 100,000, and then divide the number of deaths by the answer to that equation.

So for unvaccinated 10-14 year-olds we perform the following calculation to work out the all-cause death mortality rate –

$2,684,874 \text{ (person-years)} / 100,000 = 26.84874$

$164 \text{ (deaths)} / 26.84874 = 6.1$

Therefore, the all-cause mortality rate per 100,000 person-years among unvaccinated 10-14-year-olds is 6.1 deaths per 100,000 person-years between 1st Jan 21 and 31st March 22.

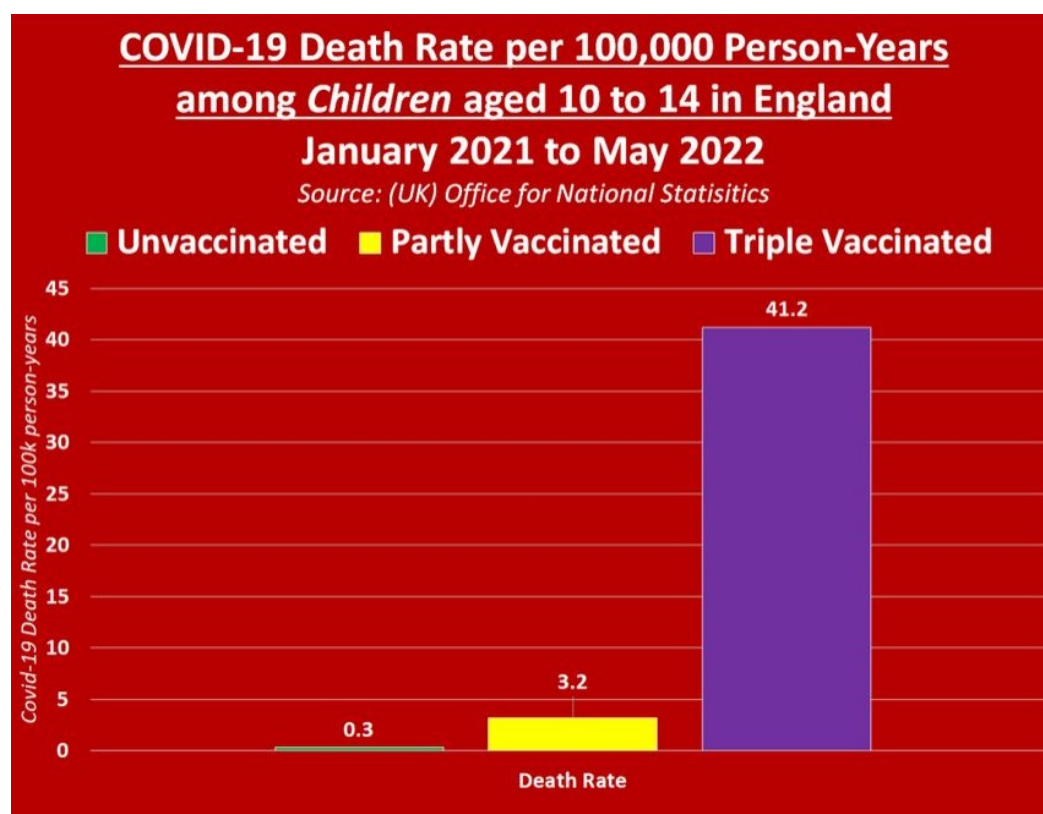

### **Pregnancy and Pfizer covid vaccine trial**

In prior books of evidence the harms and deaths caused to unborn babies of vaccinated mothers were detailed. About 270 women got pregnant during the study. The details of 238 of them were lost somehow. But of the 36 pregnant women whose outcomes were followed - *28 lost their babies*.

  - Migraines

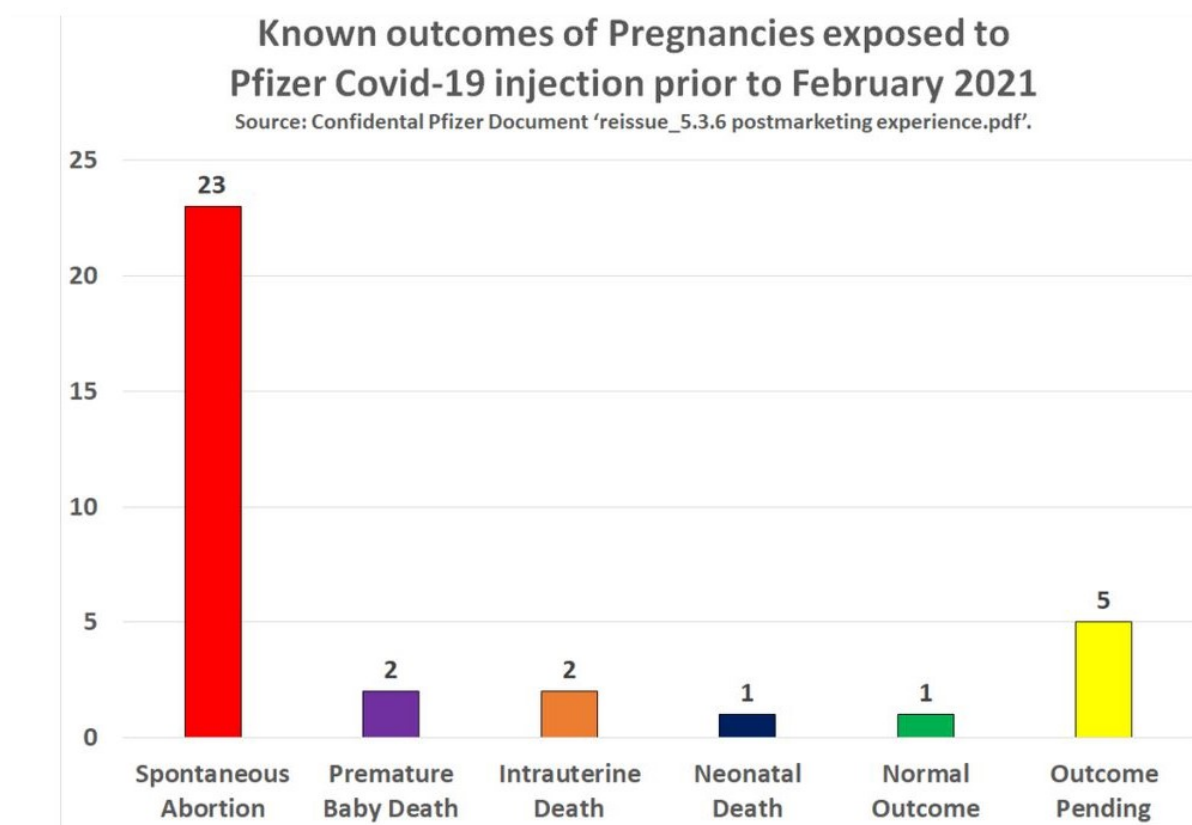

The Pfizer vaccine trial Confidential document (5.3.6 Cumulative Analysis of Post-authorization Adverse Event Reports at <https://phmpt.org/wp-content/uploads/2021/11/5.3.6-postmarketing-experience.pdf> ) contains case reports for the first 68 days of vaccine rollout (from 12/20/2020 to 2/28/2021). The section covering pregnancy and lactation on pages 12-13, reveals that 20% of the 413 reported cases of adverse events were “serious.” These included 25 miscarriages, 5 fetal deaths as well as uterine

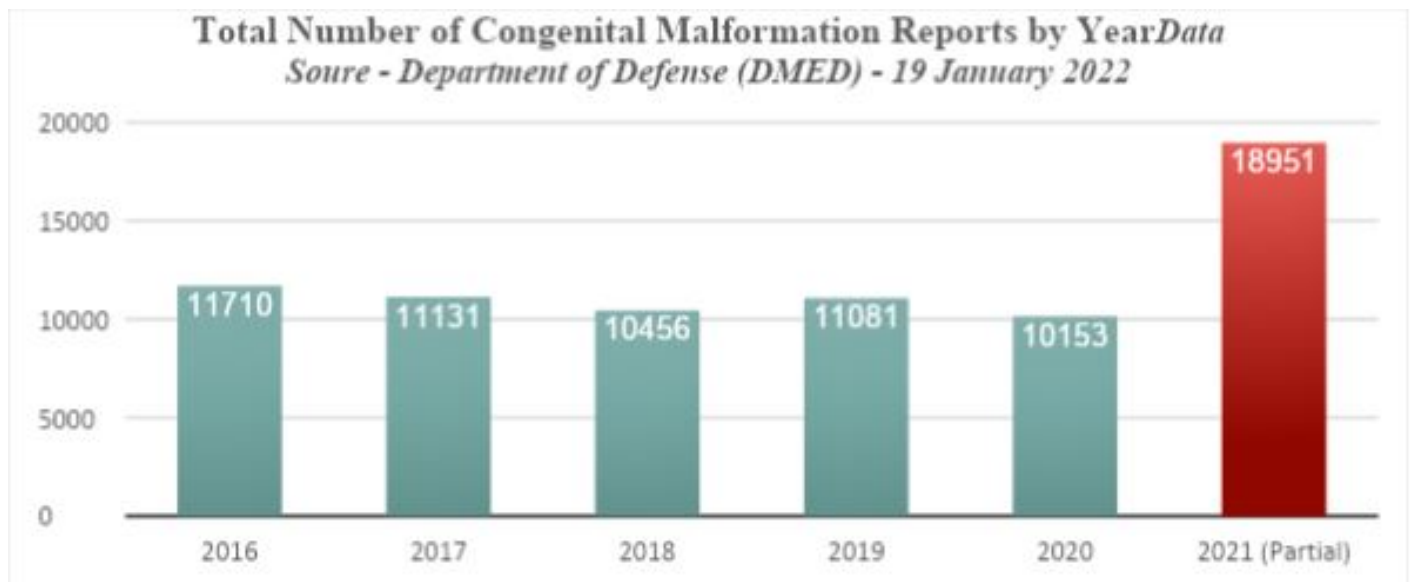


contractions during pregnancy, preterm deliveries, premature rupture of membranes and fetal growth restriction. Also included were serious and less serious adverse side effects of breast-fed babies that included infantile vomiting, fever, rash, agitation, and allergy to the vaccine. There were also 6 cases of women having adverse events who received COVID-19 vaccine while breast feeding; some of these include paresis (partial paralysis), suppressed lactation, breast pain, migraines and breast milk discoloration. Pfizer's response to the above alarming data was, "There were no safety signals that emerge from the review of these cases of use in pregnancy and while breast feeding."

Official figures reveal that the rate of neonatal deaths increased to 4.6 per 1000 live births in March 2022, a 119% increase on the expected rate of deaths. This means the neonatal mortality rate breached an upper warning threshold known as the 'control limit' for the second time in at least four years.

The last time it breached was in September 2021, when neonatal deaths per 1000 live births climbed to 5.1. Although the rate fluctuates month to month, the figure for both September 2021 and March 2022 is on a par with levels that were last typically seen in the late 1980s.

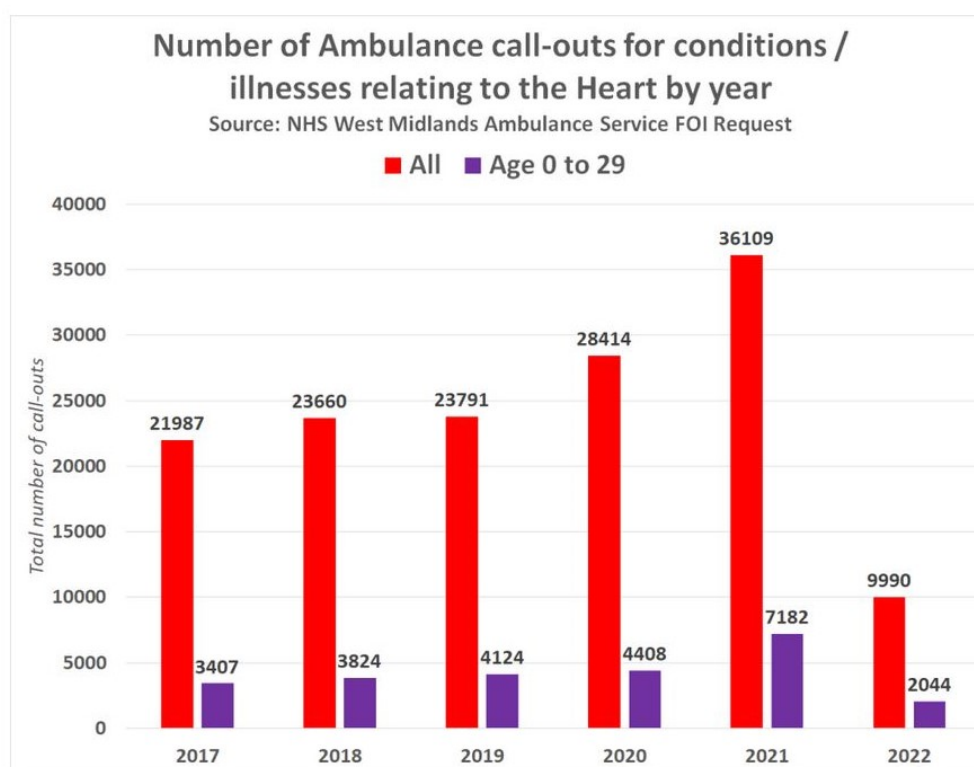

## Massive increase in ambulance call outs for heart related conditions in UK after covid19 vaccinations in 2021



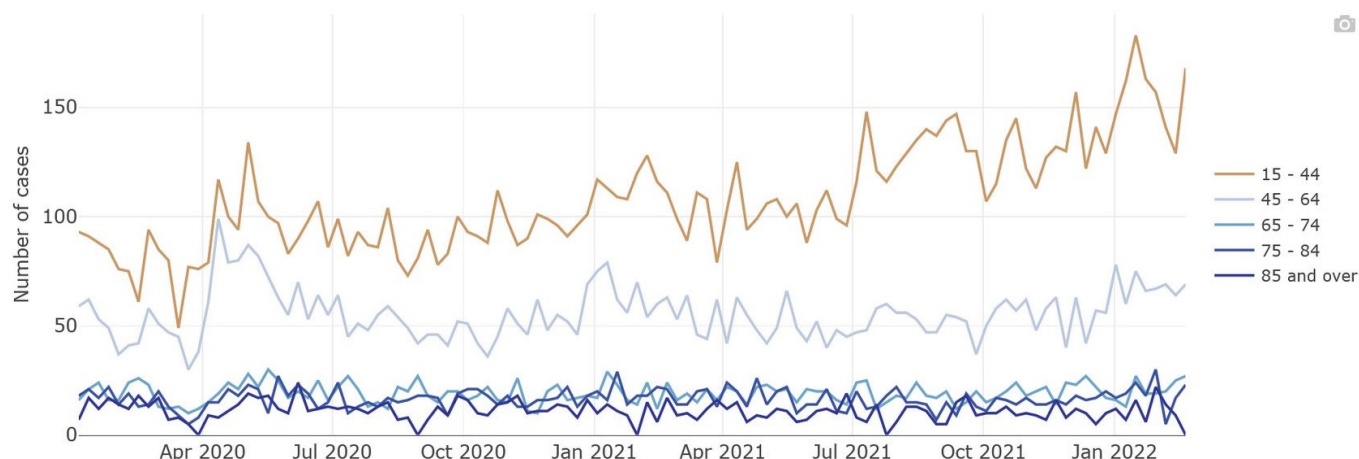

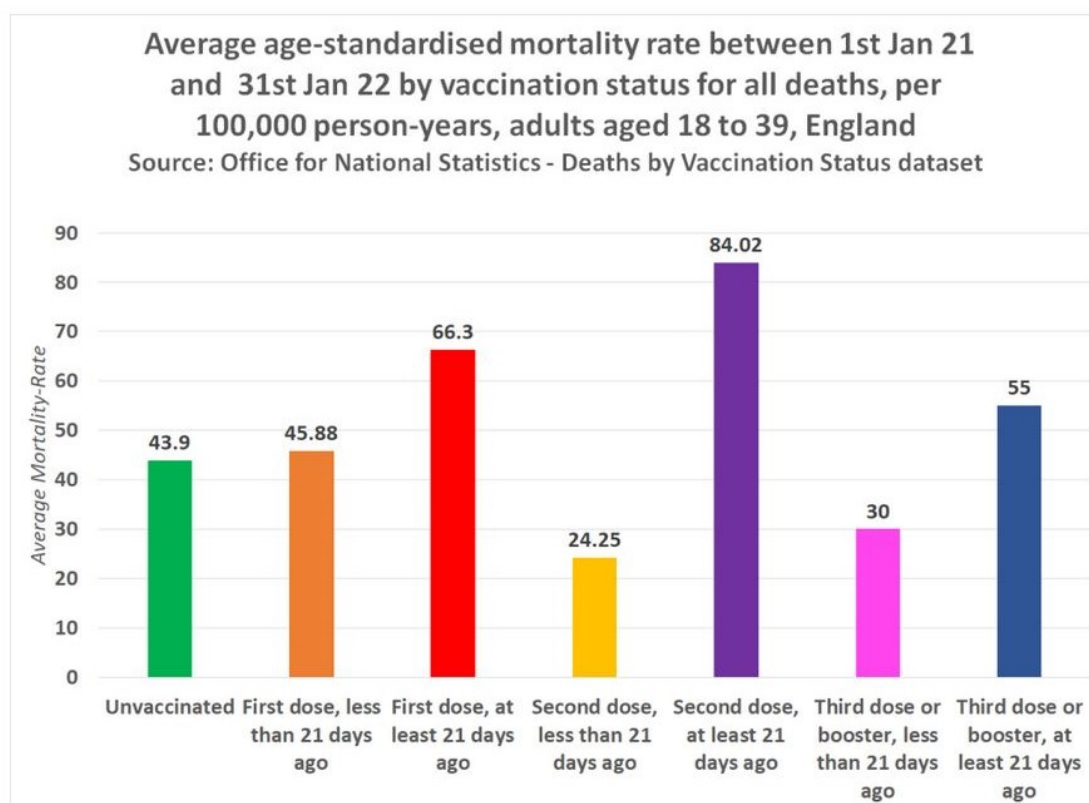

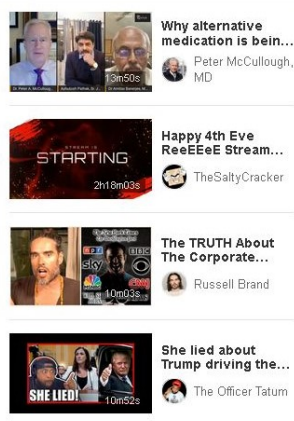

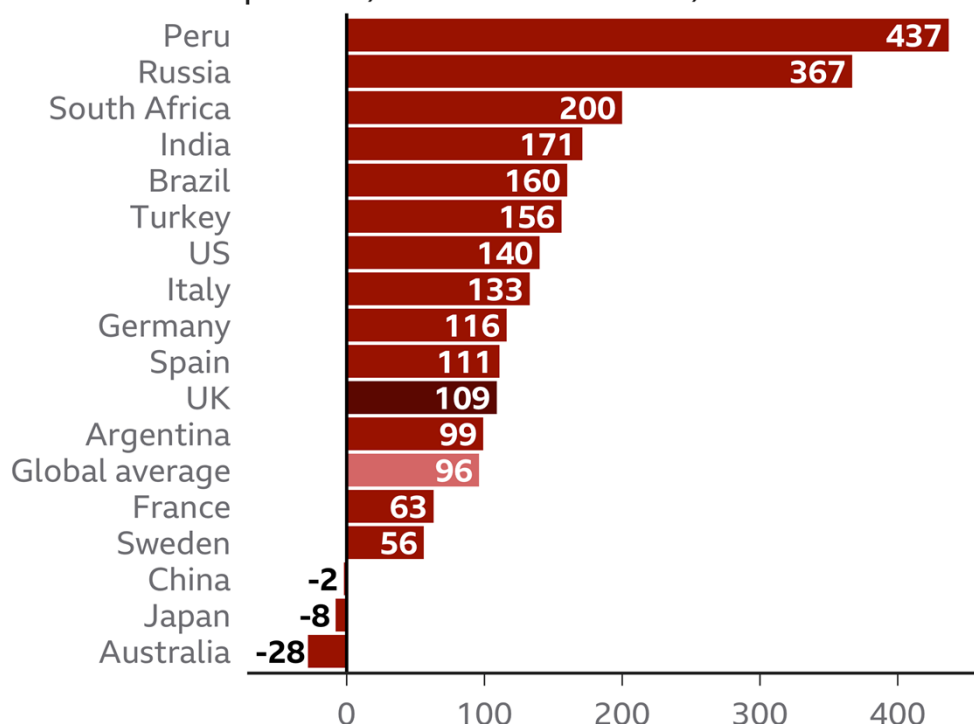

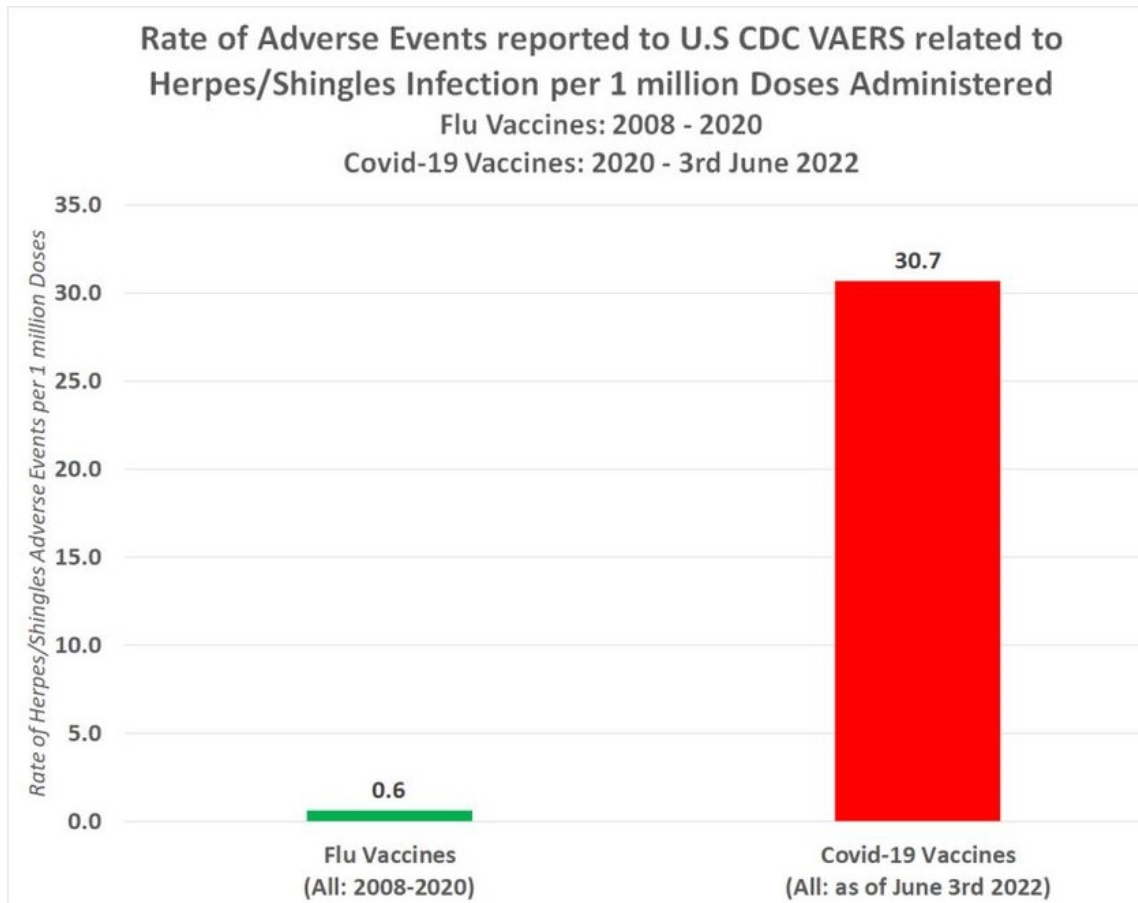
