

More Incriminating Evidence for the Irish Criminal Courts. More Corroboration of the Report ‘Scientific Expert Report on the COVID-19 Epidemic Response in Ireland’ handed into Kevin Street Garda (police) station in Dublin in May 2021.

The first and most important question to be asked is : ‘are the covid19 vaccines working, are they effective?’

And the second important question is : ‘are the vaccines safe ? can they cause injuries or disabilities or deaths ? what is the impact of these covid vaccines on All Cause Mortality and on Excess Mortality?’

And the third question is : did we have safe and effective medicines for covid19 since March 2020? And is naturally acquired immunity relevant here ?

We will answer these questions below using official government data and scientific research data from Ireland and worldwide. This is highly important in light of several governments introducing vaccine passports and apartheid, discrimination, dangerous social divisions, and lockdowns, and breaking the Law, the Constitution, Human Rights Laws, and Democracy. The Science, the Irish Constitution, Human Rights, Civil Rights, Democracy and the Nation must be defended.

Scientific, Medical and Government Reports and Evidence show that Covid19 vaccines are not working and are proving to be ineffective Covid19 vaccines have lost effectiveness and are severely weakening the immune systems of vaccinated people

This fact has been partially admitted to by the government and health authorities in Ireland and abroad, and by their push for boosters. The need for boosters emerges from the fact that the covid vaccines have waned and lost effectiveness and failed. Boosters are a public admission that the covid vaccines are not working, they are ineffective and have defects. Boosters are proving ineffective in the same way the vaccines proved ineffective. Israel being the worst example, now being followed by Gibraltar in Autumn and Winter 2021. Several highly vaccinated countries and states are implementing lockdowns in Winter 2021 and will do so into 2022. Another consideration here is the role of massive

profits from these covid vaccines and the boosters, whether it is 4 boosters, 10 boosters, 20 boosters, etc. and the conflicts of interest of and financial inducements given to politicians, their health advisors, their businesses, and academics who are pushing these vaccines and boosters. Several high profile court cases involving Big Pharma companies being sued for millions / billions o dollars in the past 21 years are of relevance here.

- The official HPSC figures show that the majority of covid19 deaths, 62.7%, are in covid vaccinated people. The covid vaccines are obviously not working. The 62.7% figure is not entirely accurate and is quite misleading. Full covid vaccinations for the majority of the Irish population was not reached until September 2021 so the start of the HPSC Report should be September 1st, 2021 not April 1st, 2021. In April, most people in Ireland were not fully vaccinated. From September 1 to November 13th 2021 the figures for vaccinated deaths are greater than 62.7% and are around 80% - some further research data from the HSPC in the next section below point to this fact.

Vaccination Status of COVID-19 Deaths in Ireland between 1st April 2021 and 13th November 2021

Key points

Between April 1st and November 13th 2021

- 651 persons with a laboratory confirmed COVID-19 infection, were notified to the Health Protection Surveillance Centre (HPSC) as having died due to COVID-19.
- 243/651 (37.3%) deaths were notified in persons who were not vaccinated or not registered as vaccinated on Ireland's national COVID-19 immunisation system (COVAX).
- 408/651 (62.7%) deaths were notified in persons who had received at least one dose of COVID-19 vaccine prior to death.
- 333/651 (51.2%) of the notified deaths had an epidemiological date¹ 14 days or more after receiving both doses of a 2-dose regimen or 1 dose of a 1-dose regimen and are considered as vaccine breakthrough infections – see technical note.

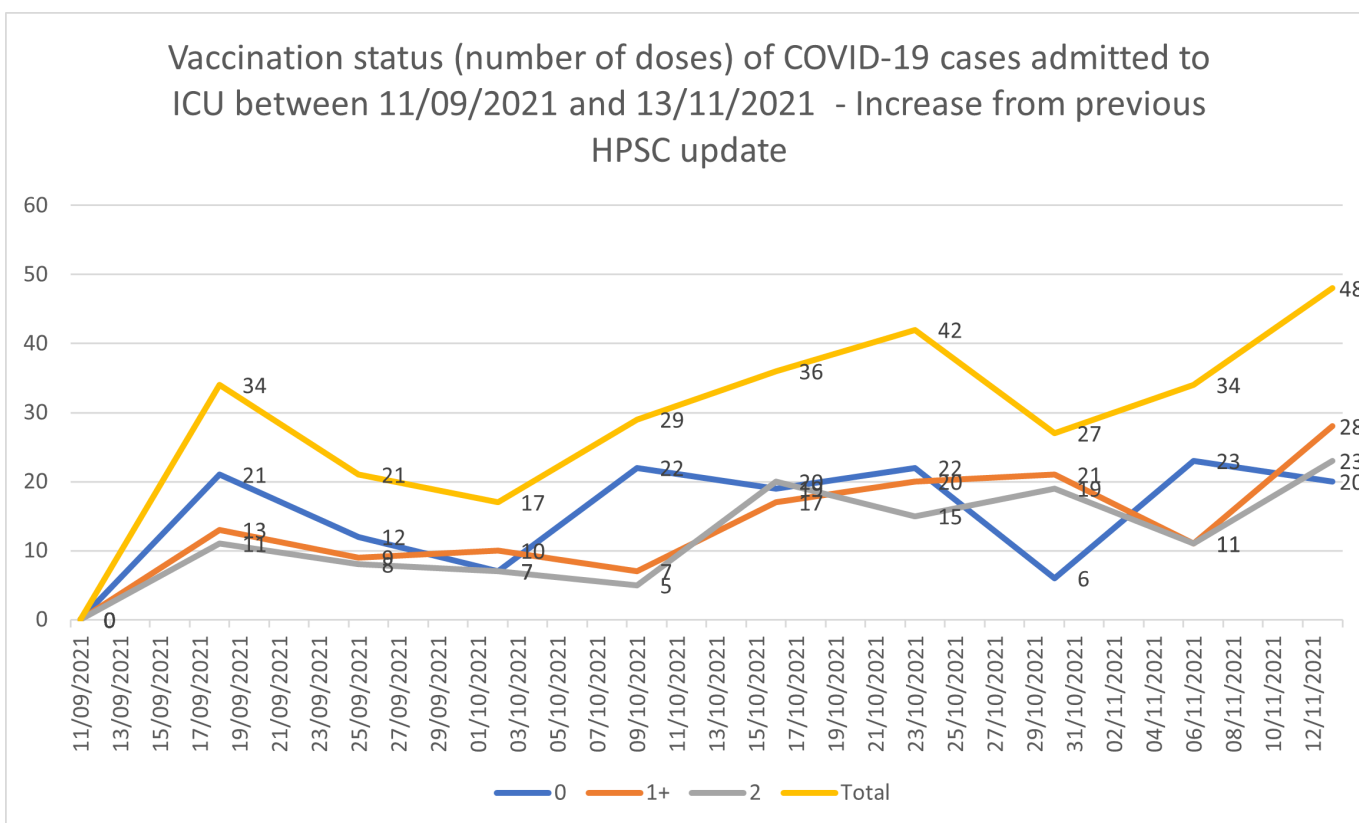
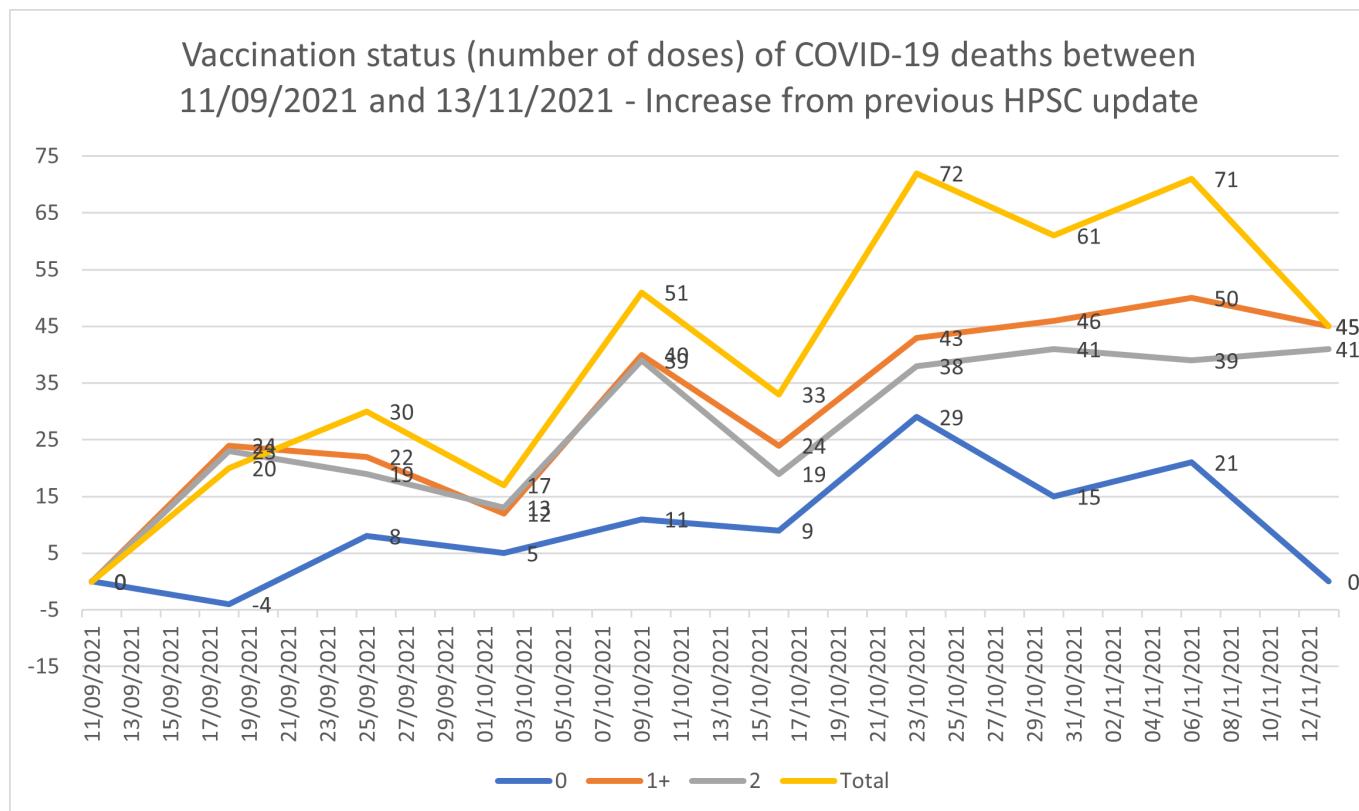
News report: 100% of Covid deaths in last week reported were amongst vaccinated people

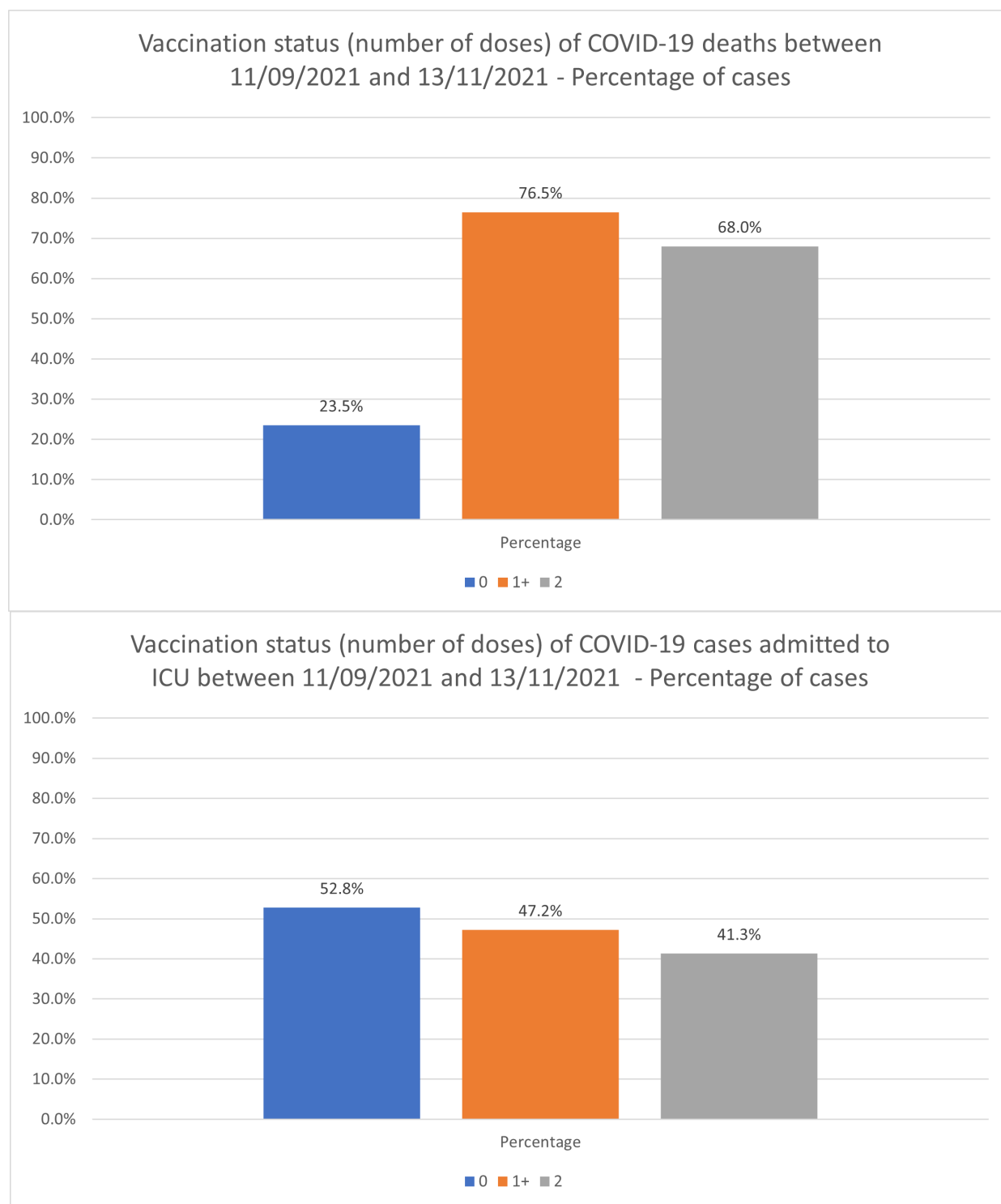

Analysis of Graphs: In November 2021, there were higher ICU admissions and higher covid19 deaths for the vaccinated. The cumulative totals since September 11, 2021 show ICU admissions for the vaccinated and unvaccinated are about the same but covid19 deaths are much higher in the vaccinated population.

Covid19 vaccines are creating new variants which infect both the vaccinated and the unvaccinated, and create problems for both groups depending on the health and number of underlying illnesses each individual has. The variants have evolved and mutated to evade both vaccines and weak immune systems. This is the process of Evolution. ADE in vaccinated individuals is a factor here and it increases the risk of ICU admission and death. This risk rises in the Winter. Also the vaccine-created variants are

a risk to unvaccinated persons with weak immune systems. The covid vaccines are the culprit here and the vaccine-created variants are the key factor as viruses mutate all of the time to defeat obstacles such as vaccines according to top scientists worldwide. The covid19 virus has similar mutation abilities as the flu viruses and cold viruses. And these flu and cold viruses have evaded vaccines for decades. Scientists worldwide are now discovering that covid19 is similar. And covid19 patients both vaccinated and unvaccinated are being denied safe and effective medicines for covid19 such as Ivermectin and Hydroxychloroquine, Zelenko Protocol, Tyson and Fareed Protocol, and other medicines mentioned in prior books of evidence, see www.data-analytica.org/List.pdf with the result that both vaccinated and unvaccinated groups risk ending up in hospital or ICU or dead. Depriving people of these safe and effective medicines amounts to the crime of clinical negligence, assault or murder / manslaughter. Politicians and their health advisors who have conflicts of interest and stand to gain many millions of euros / dollars individually from vaccines and more and more boosters and vaccine certs and mandates and PPE and Contact tracing contracts do not have the legal right to continue banning and blocking these safe and effective medicines.

The vast majority of vaccinated persons admitted to ICU in 2021 had one or more serious underlying conditions according to the HSE and CSO.

Being hospitalized for an underlying condition is not the same as being hospitalized for covid19. The underlying condition must be given priority. Since March 2020, covid19 has been given priority over all underlying illnesses and diseases with the result that many non covid19 illnesses and deaths were mislabeled as "covid19". In 2021 a significant and growing proportion of these underlying conditions are covid vaccine injuries and disabilities. And these are also being mislabeled as "covid19". The HSE and HPRA and CSO and Department of Health needs to provide these exact figures for underlying conditions caused by covid vaccines and ICU admissions for these to the general public on a daily, weekly and monthly basis. And to stop mislabeling non covid19 deaths as "covid19 deaths".

- The official Irish government figures for covid19 cases, covid19 ICU admissions and hospital cases and deaths are inaccurate and misleading. PCR tests have a 97% rate of false positives due to cycle counts set at over 35 cycles in Ireland. This has been stated by top scientists and health authorities around the world, including Dr. Anthony Fauci of the NIH in the USA. The Irish authorities have ignored this. The incompetence of the Irish health authorities is astounding and shocking and has contributed to this fraud where 97% of covid19 cases are not covid19. Many covid19 cases and deaths are actually other diseases and illnesses mislabeled as covid19. **And the result of this is that the incompetent health authorities here in Ireland cannot differentiate between genuine covid19 cases and non covid19 cases and those people injured and disabled by the covid19 vaccines and those experiencing ADE from covid vaccines, as they are all lumped together as "covid19 cases" or "covid19 cases in ICU" or "covid19 deaths". It's a huge mess. And they spout out these false numbers on news channels to create more fear, panic and paranoia, and childish finger pointing.** Also, the HPSC and HSE and CSO are not measuring **All Cause Mortality** for the covid19 vaccines,

which means their statistics are inaccurate and misleading. There is a legal duty on these bodies to provide **All Cause Mortality** figures for the covid19 vaccines and for other vaccines and drugs.

Data from the trial of the Pfizer covid vaccine show that All Cause Mortality was high for the vaccine. For every one person saved from covid19 several die from other illnesses and conditions.

There is a need for governments and independent and accountable authorities to test all of these covid19 vaccines for **All Cause Mortality Risk**. And other independent bodies to investigate and look for conflicts of interest, bribery, lobbying and efforts to conceal facts and evidence in the testing and monitoring of **All Cause Mortality Risk**.

In addition the **Injury and Disability Risk for covid19** vaccines should be established by the new authorities proposed above. This could be done by particular illness such as:

Myocarditis cases – 5 per 100,000 people vaccinated categorized by age group

There are crimes here which involve the fraud of false statistics and this has led to committing of more crimes such as poisoning, assault, bodily harm, coercion, blackmail, lack of informed consent, false broadcasting, discrimination, false arrests, corruption and bribery, murder, manslaughter, treason etc. etc. – these are emerging from this initial fraud. - **Some Evidence from British Government Reports that the covid vaccines are causing a type of Acquired Immune Deficiency Syndrome (AIDS)**

Evidence produced by PHE now renamed UKHSA over several months up to November 2021 clearly show that the covid vaccines are losing effectiveness and have reached minus figures in terms of effectiveness. The minus figures for effectiveness means that unvaccinated people have more protection from covid19 and its variants than vaccinated people. It also shows that the immune systems of vaccinated people are becoming defective, they are developing a type of Acquired Immune Deficiency Syndrome (AIDS). This is serious as we are entering Winter time when those persons with defective or depleted immune systems are at increased risk of getting flus and colds and bacterial or viral pneumonia and fungal infections which in the circumstances could lead to increased hospitalisations and deaths among the vaccinated.

In the last table above, the 80+ year olds and the 70 year olds were the first to receive the Boosters in weeks 41 to 44 and this has led to a light improvement in immunity but this too is declining with time.

The charts above are extremely worrying both for Britain and for Ireland where both populations are highly vaccinated. This loss of vaccine effectiveness and weakening of immune systems is now both a public health matter and a national security matter.

- The British government has exposed the fact that once you get double jabbed, you will never again be able to acquire full natural immunity. In its Week 42 “COVID-19 vaccine surveillance report,” the U.K. Health Security Agency admitted on page 23 that “N antibody levels appear to be lower in people who acquire infection following two doses of vaccination.” It goes on to explain that this antibody drop is basically permanent.

What does this mean?

We know the vaccines do not stop infection or transmission of the virus (in fact, the report shows elsewhere that vaccinated adults are now being infected at much HIGHER rates than the unvaccinated). Dying specifically of covid19 VS Dying with covid19 and other diseases and illnesses and the relevance of this fact to Hospitals and ICU's and Official Death Statistics

In November 2021, the CDC stated that 5% of all "covid19 deaths" were specifically of covid19. While 95% involved an average of 4 diseases or illnesses. These are termed 'underlying conditions'. The vast majority of covid19 deaths were concentrated in the very elderly, those over 70, where dying of all conditions or illnesses is greatly increased especially if they already have 2 or more diseases or illnesses.

For over 5% of these deaths, COVID-19 was the only cause mentioned on the death certificate. For deaths with conditions or causes in addition to COVID-19, on average, there were 4.0 additional conditions or causes per death.

This corroborates our evidence in prior books of evidence supplied to the police. 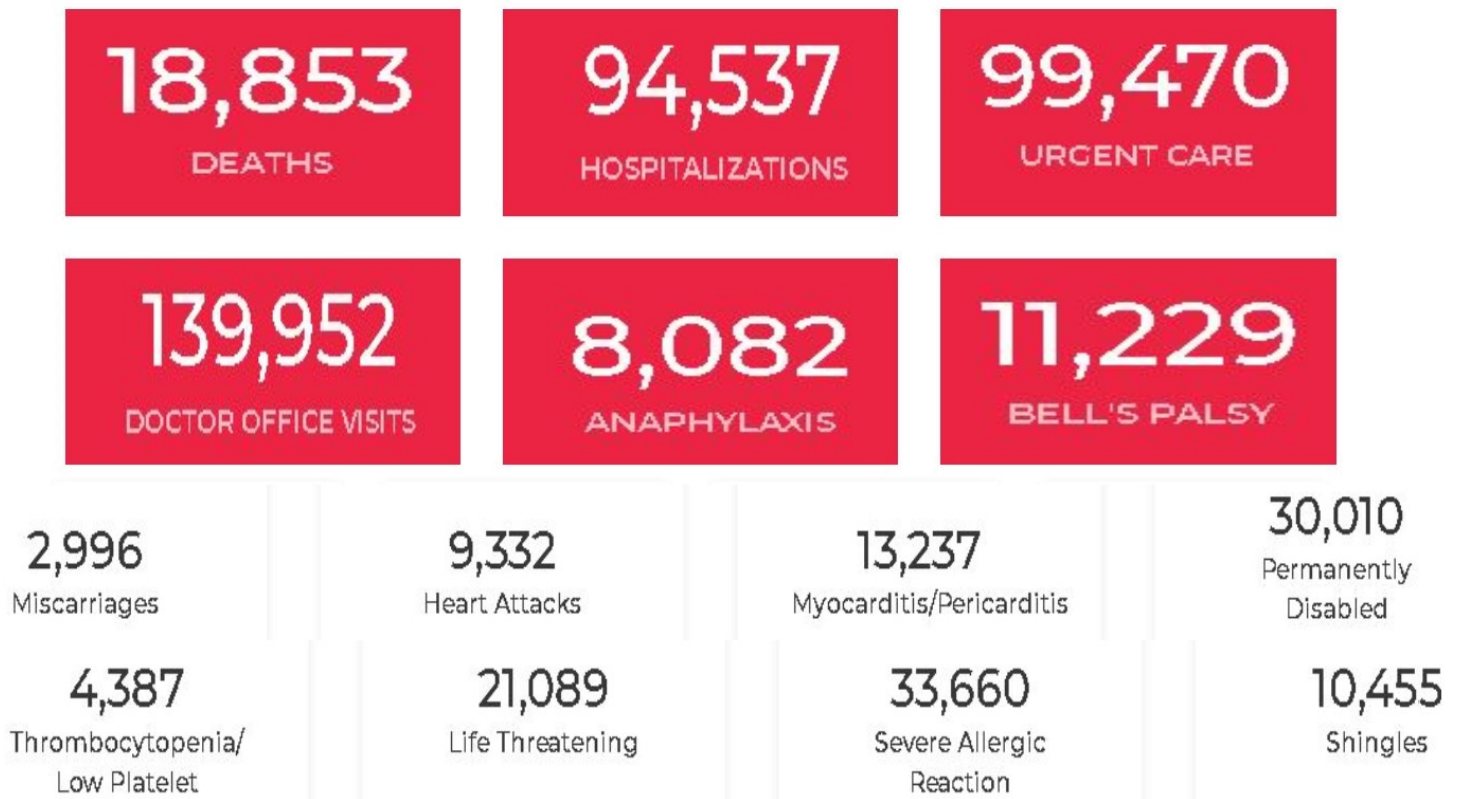

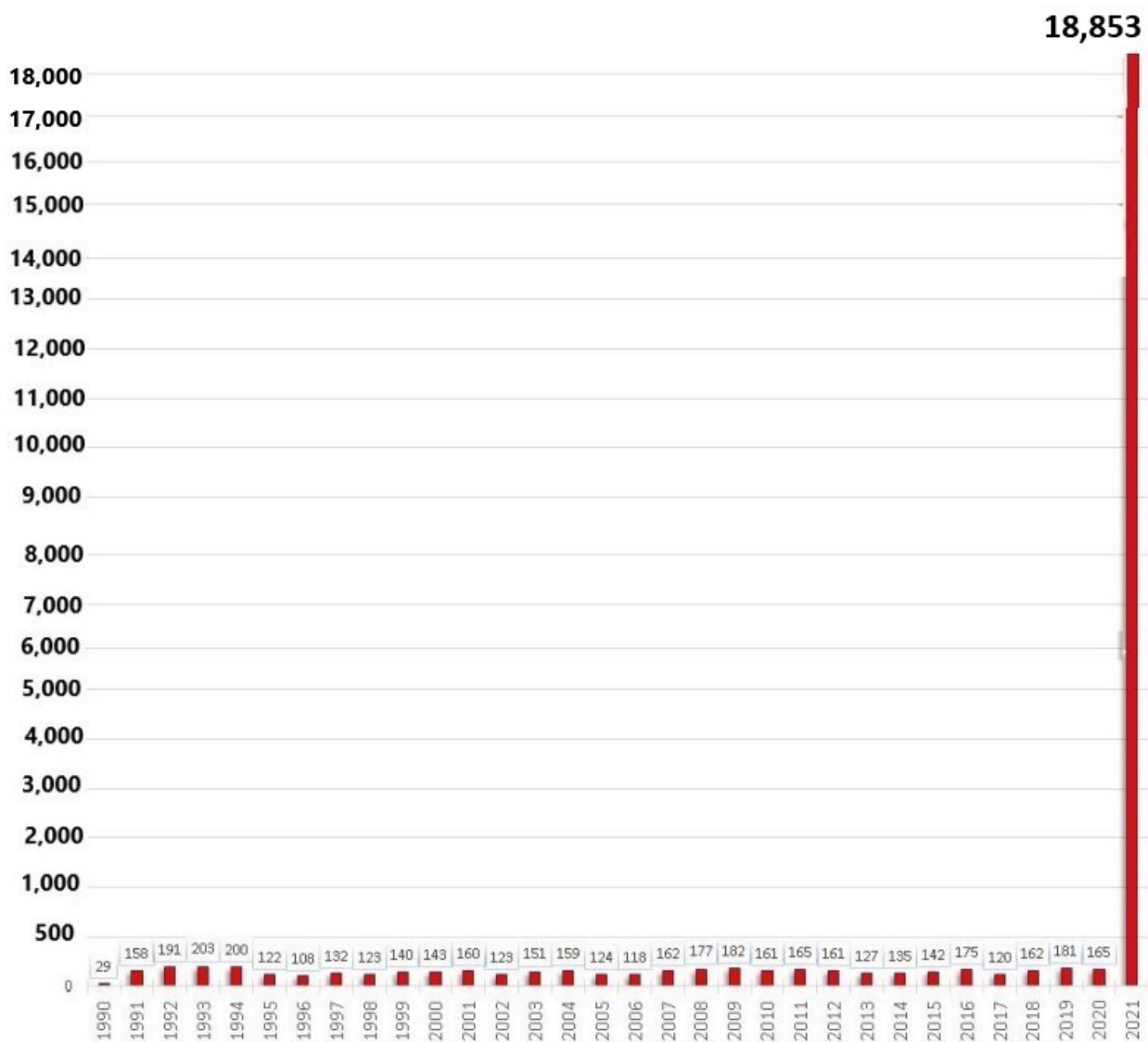

November 2021



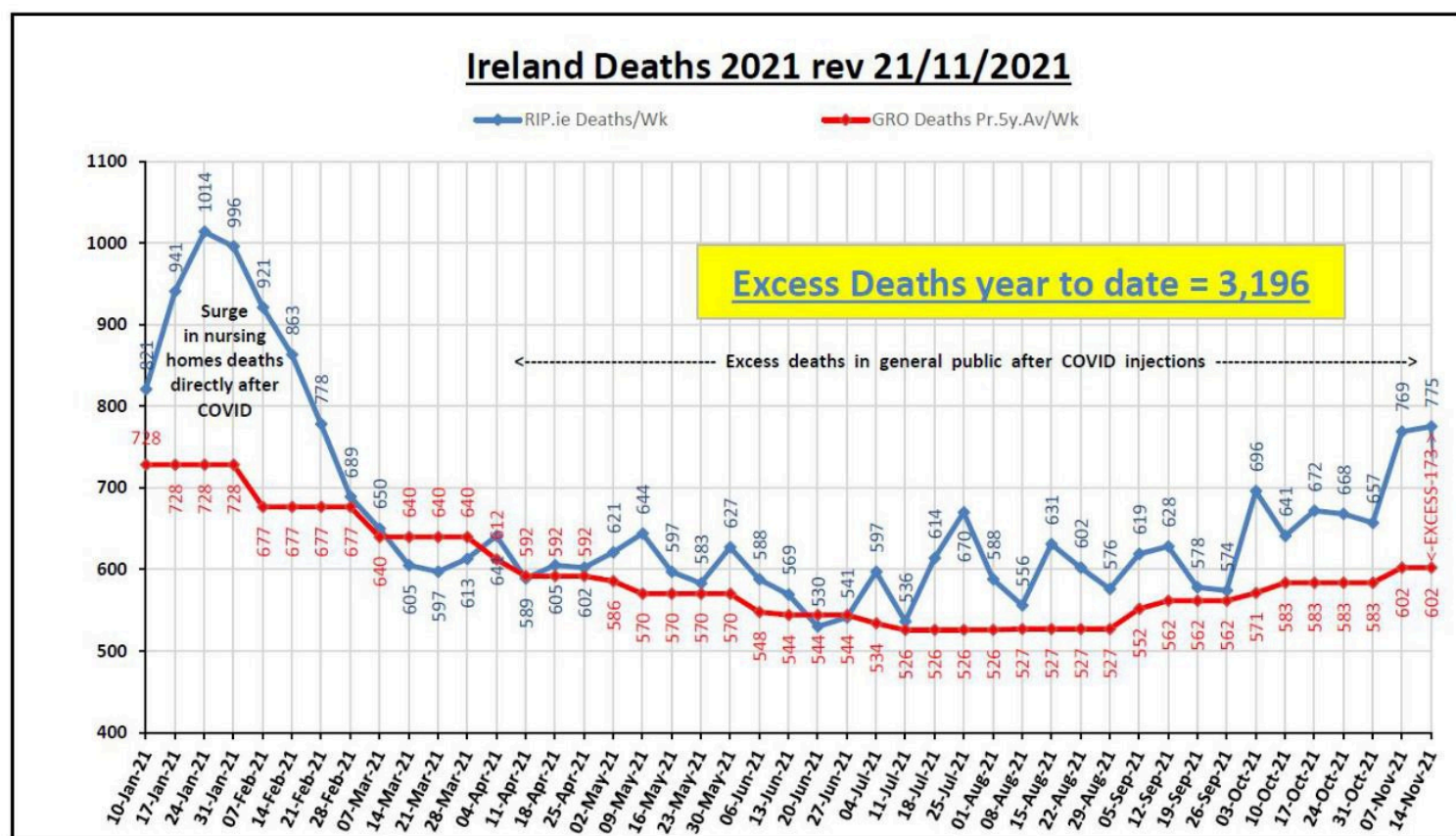
Massive Rise in Excess Mortality in Ireland in 2021

There has been a massive rise in excess mortality in 2021 after the introduction of covid vaccines in January 2021. 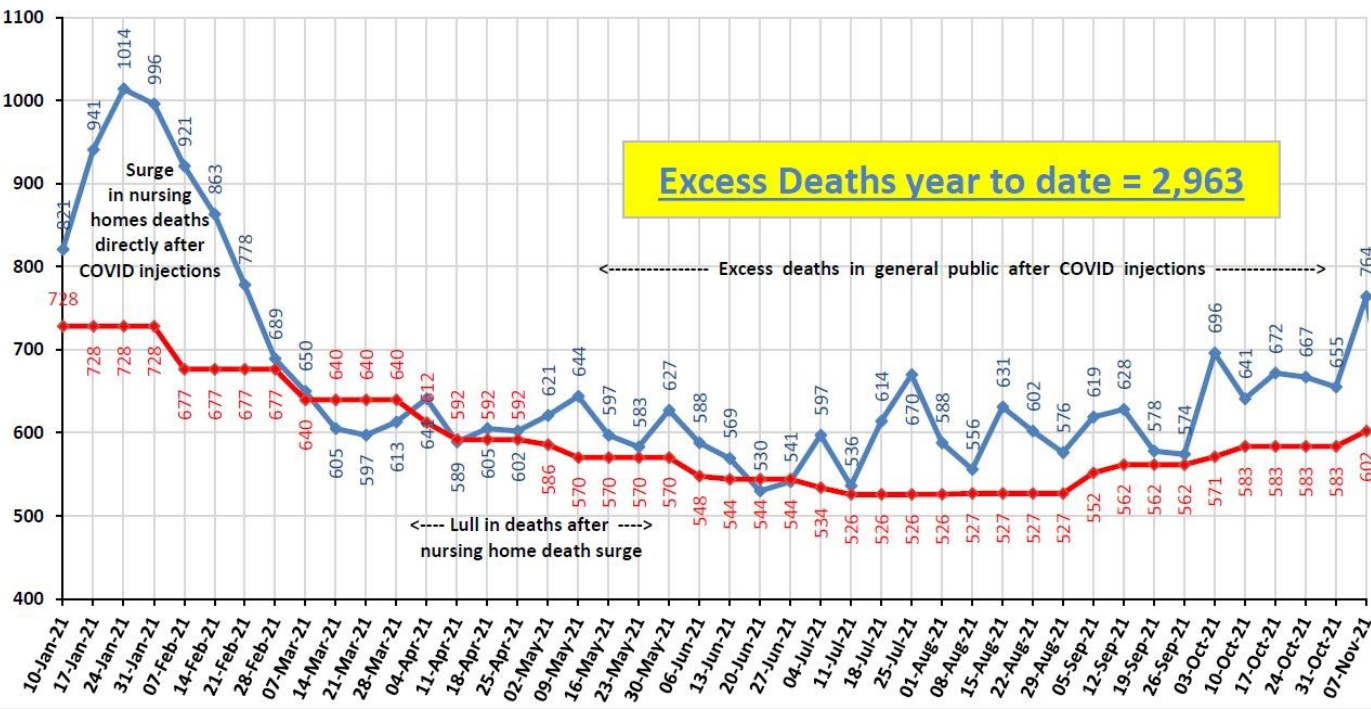

The evidence from Britain in 2021 corroborates this Excess Mortality finding in Ireland in 2021. Again we see a big rise in excess mortality after the introduction of covid vaccines in January 2021. 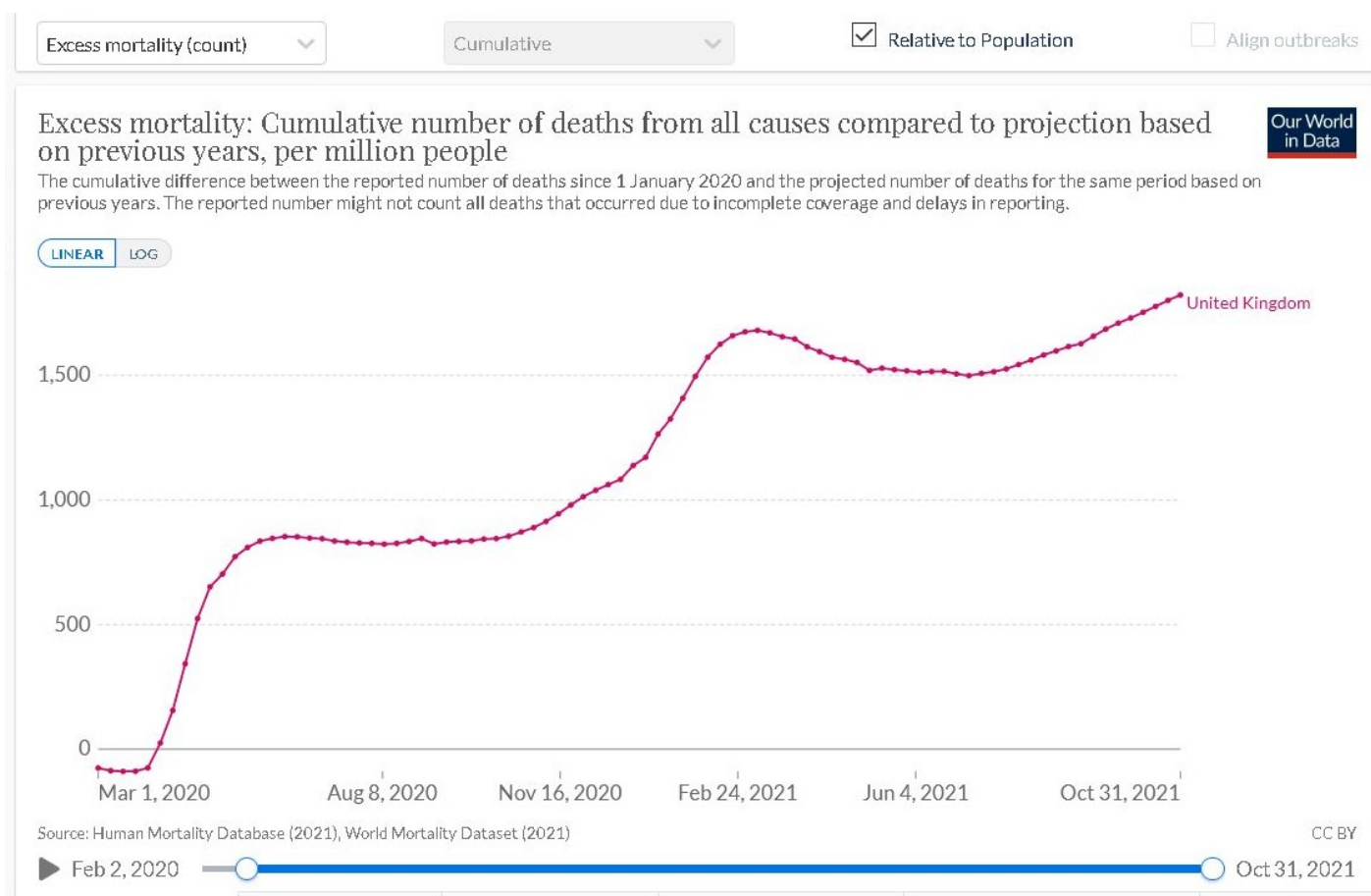

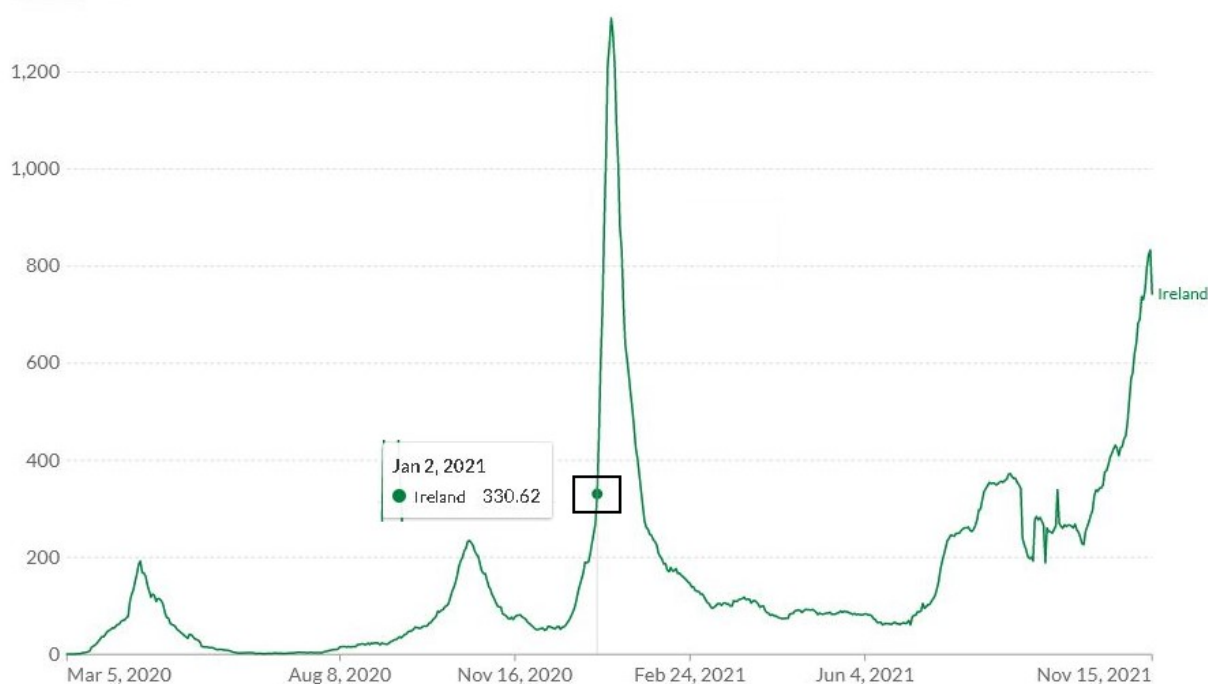

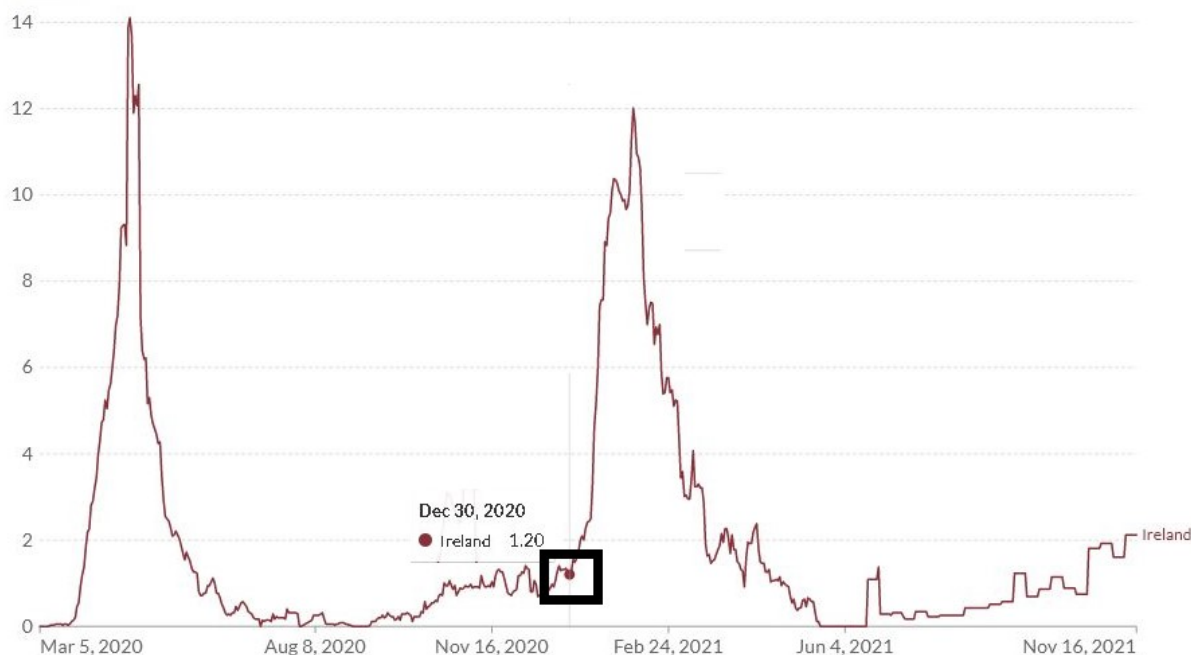

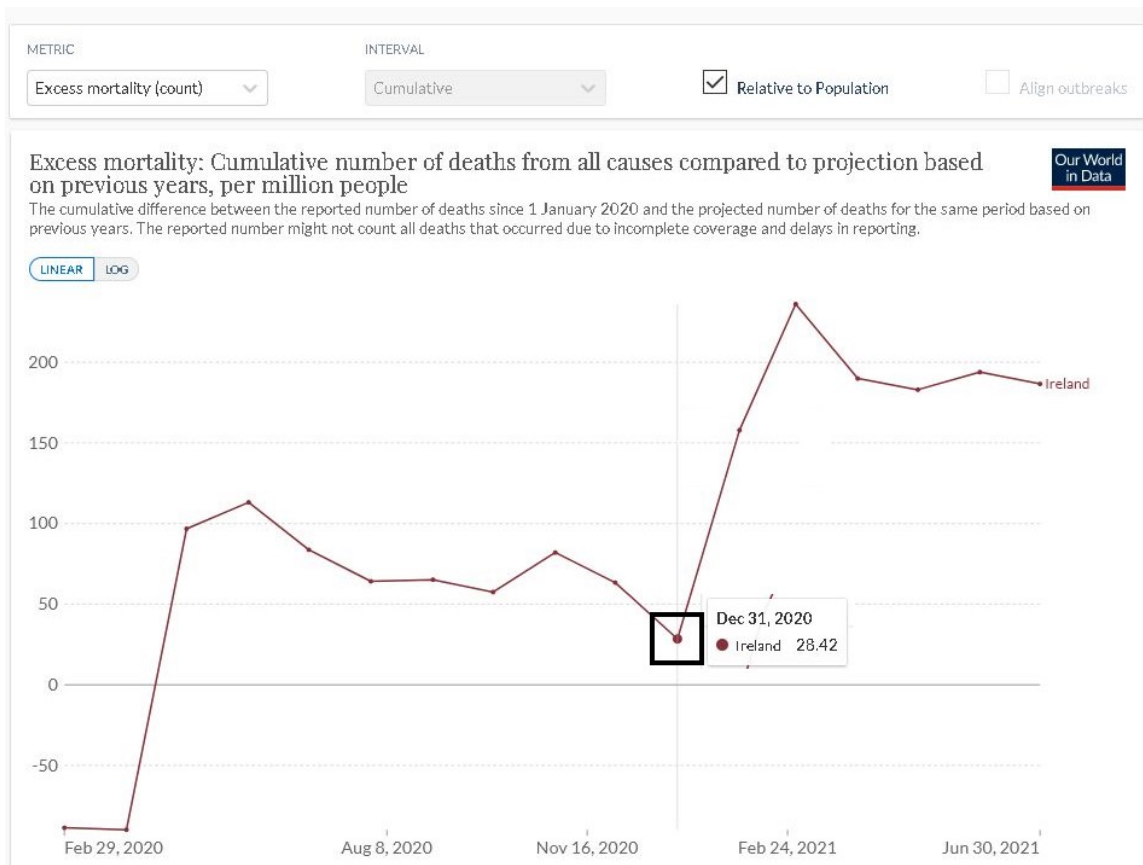

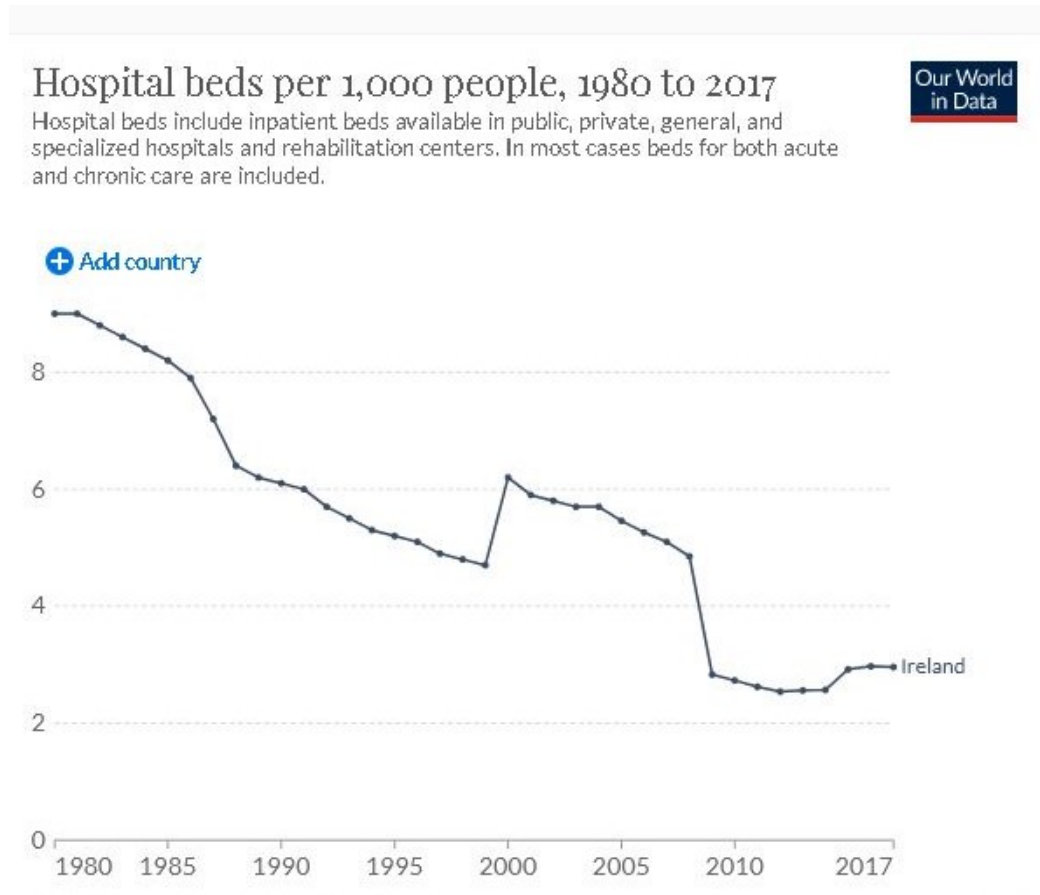

In 2021, the Irish government announced that it was creating 3 concentration camps in Ireland to deal with covid19 issues. Michael "Mike" Anthony Granata February 21, 1965 – November 1, 2021

Michael, a longtime resident of Gilroy, passed away on November 1, 2021. Never a kinder more gentle man did I know than my husband, Michael.

For those who knew Mike, you know that he was a good and honest man. He was kind, considerate, and always polite.

Mike was adamant that people know what happened to him that caused his early and unexpected death. *Message from Mike:* "Many nurses and non-nursing staff begged me and my wife to get the truth out to the public about the Covid-19 vaccines because the truth of deaths from the vaccine was being hidden within the medical profession. I promised I would get the message out. So, here is my message: I was afraid of getting the vaccine for fear that I might die. At the insistence of my doctor, I gave in to pressure to get vaccinated. On August 17th I received the Moderna vaccine and starting feeling ill three days later. I never recovered but continued to get worse. It was constant torture that I cannot describe. I was no longer treated as a human with feelings and a life. I was nothing more than a covid vaccine human guinea pig and the doctors excited to participate in my fascinating progression unto death. If you want to know more, please ask my wife. I wished I would have never gotten vaccinated. If you are not vaccinated, don't do it unless you are ready to suffer and die."

Mike did not deserve the pain and suffering he endured. He was a good man and deserved better.

Mike was born in San Jose, California and moved to Gilroy at age one, where he resided for the last 55 years.

Mike attended Las Animas Elementary and Gilroy High schools. He graduated from both San Jose State University and Santa Clara University earning several scholastic degrees.

Mike was an intelligent man but never flaunted it. Mike chose to clothe himself in humility, kindness and gentleness every day, and preferred to work quietly behind the scenes doing good deeds and expecting nothing in return.

Michael was a licensed professional engineer and the owner of Engineering By Design, Design Engineering and Professional Engineering and Design. For the last 10+ years Michael worked in the Marine industry utilizing his IP for design and engineering that is known and used worldwide.

Michael could be seen twice daily walking his Golden Retriever around the neighborhood or up at Gavilan College for the last 20+ years in his jeans, t-shirt and hat.

Michael was proud to be a gear-head, a true car restoration enthusiast and tinkerer.

Mike loved spending time with his wife, his dog, his cars and playing the drums as he was quite a gifted musician.

Michael was preceded in death by his brothers Anthony Edward Granata and Salvatore Anthony Granata.

Media Release

New COVID 19 Variant detected in Botswana

The Presidential COVID-19 Task Force informs the public that four (4) cases of a new COVID-19 variant now known as B.1.1.529, were reported and recorded on Monday 22nd November 2021. The four (4) cases were detected among travellers who tested SARS-COV-2 positive on routine pre travel testing. The variant tests were carried out as part of the routine genomic surveillance of SARS-COV-2 as prescribed in our COVID-19 response plan.

The preliminary report revealed that all the four had been fully vaccinated for COVID-19. As part of the continuing investigations into the virus to establish and contain its local transmissions, contact tracing has revealed close contacts who are currently awaiting their results and the public will be informed regarding the outcome of the exercise.

The initial investigations on the virus have established that the new variant has a high number of mutations as compared to the locally predominant Delta variant. What this means is still unclear and under investigation. New variants have the potential to affect severity of disease, how effective tests pick up the disease as well as potentially vaccine efficacy. At this moment, real world impact of the variant has not been established. Non-pharmaceutical interventions (wearing of masks, social distancing, and avoiding unnecessary travels etc) remain effective and therefore the public is advised to continue observing these.

The Presidential COVID-19 Task Force wishes to further dispel assertions made by some circulating social media reports associating these cases with HIV+ status of the participants. Contrary to these reports, in which one newspaper claims that one case was from an HIV+ participant, is totally false as no HIV status of the clients was associated with these results. These media reports are unfortunate and factually flawed and should be viewed as such. The variant is still being studied and investigated and therefore, it would be premature to conclusively make these types of assertions at this time.

The public is urged to take necessary precautions to protect themselves from COVID-19 as advised from time to time.

Criminal Offences Related to Vaccination

Firstly, vaccines are not currently mandatory in Ireland i.e. required by law or mandate they are not compulsory, there is no requirement in the emergency legislation to take a vaccine. There are complex legal issues preventing the Government, an Employer or a service provided from making a healthcare procedure mandatory which is why they have not done so. Many other countries have the same legal issues preventing them from mandating vaccines. In the circumstances, Ireland is lucky that it has no covid vaccine mandate when one considers the high and rising number of deaths and injuries and disabilities from the covid vaccines.

Under Irish criminal statute, any person who has been administered a vaccination without informed consent and has suffered an adverse reaction has been Assaulted and/or Poisoned with a Syringe which are all criminal offence, and the person who administered the vaccine is guilty of those offences i.e. the doctor, nurse, pharmacist, etc. Informed consent requires that the person is fully informed of each and every known side effect from each vaccine administered and the recipient has confirmed to the person administering that they are not under duress to take the vaccine e.g. threat of losing their job, media pressure, blocked from accessing services, etc. The information on all known side effects including injuries, disabilities and deaths must be read by, or explained to, the person intending to take the vaccine and they must have confirmed that they understand it before the syringe pierces the flesh of the person. We have presented evidence to the Gardai and DPP since May 7th 2021 that Irish people who received the covid vaccines did NOT give their informed consent as they were NOT given the listing of side effects and deaths and injuries and disabilities caused by the covid vaccines. This means that crimes have been committed against many Irish people. And these crimes must be prosecuted. Any attempt to block, prevent or frustrate the prosecution of these crimes is itself a crime eg. perversion of the course of justice, perjury, theft and fraud offences under existing Irish laws.

Under Irish criminal statute, any person who compels another to receive a vaccine without lawful authority (for which none exists) is guilty of the criminal offence of Coercion. Examples of coercion to take a vaccine without lawful authority include: –

- Managers, supervisors, foremen, etc in a workplace who dismiss or threaten to dismiss persons from employment.
- Shop keepers, waiters, barmen, security staff, etc. who refuse or threaten to refuse entry to a business or hospital or public / private organisation or provide a service.

- Media personalities and politicians who publicly state that unvaccinated people are a risk to others or that they are not doing the right thing (i.e. they are bad people) and who incite hatred and violence against unvaccinated people

Your local station of An Garda Síochána are the body responsible for investigating criminal acts. If you are a victim of assault and/or poisoning with a Syringe or Coercion you should go to your local Garda Station and make a formal complaint. You should bring a trusted family member or friend plus the originals the following evidence to show Gardaí and retain the originals:

- Name and home or work address of the person who inserted the syringe into your flesh.
- Any documents or information provided to you prior to the syringe being inserted into your flesh.
- Vaccination Card(s) or any other official proof of vaccination.
- GP or hospital reports which detail illnesses you developed after the vaccine.
- Copies of media articles or broadcasts (video/audio) that compelled you to take the vaccine with journalist or presenter's name and business address.
- Email, memo, record of phone call of person who instructed you that you could no longer work unless you took the vaccine.
- Proof of denial of entry to a public place or refusal to provide services e.g. video, photographs, voice recordings. You must have informed the person that they were being recorded for this type of evidence to be valid.

Insist that you want to give a formal statement, which you may be asked to return to give at a later date, take the full name and identification number of the Garda you make the report to and request the Garda to phone you with a PULSE incident number as soon as he can generate one. You can request updates on your complaint from your local Garda Victim Service Office using this PULSE number. Also give copies of all of the evidence etc, to your trusted family member or friend for safe keeping and ask them to make a complaint of unlawful killing with the investigating Garda in the event that you should die.

Criminal Law

Non-Fatal Offences Against the Person Act, 1997

Section 2, Assault; states that a person shall be guilty of the offence of assault who intentionally or recklessly directly **applies force to on the body of another without the consent of the other** and

“force” includes application of matter in liquid form. Consent in the instance of a medical procedure is informed consent.

Section 6, Syringe, etc.; states that **a person who injures another by piercing the skin** of that other with a syringe where there is a likelihood of **causing that other to become infected with disease** as a result of the injury caused shall be guilty of an offence.

Section 9 – Coercion; states that a person who, **with a view to compel another** to do any act which that other has a lawful right to do or to abstain from doing, wrongfully and **without lawful authority intimidates that other person**, shall be guilty of an offence. There is currently no lawful authority or mandate to take a vaccine in Ireland.

Section 12, Poisoning; states that a person if, knowing that the other does not consent to what is being done, he or she intentionally or recklessly **administers to or causes to be taken by another a substance which he or she knows to be capable of interfering substantially with the other’s bodily functions**, shall be guilty of an offence.

For consent to be valid, the service user must have received sufficient information in a comprehensible manner about the nature, purpose, benefits and risks of an intervention / service or research project, **not be acting under duress**, have the capacity to make the particular decision, the potential risks and the likelihood of success of a proposed intervention, as well as that of any available alternative, whether a proposed investigation or treatment is experimental or part of a research project. A general rule is to provide information that a reasonable person in the service user’s situation would expect to be told, such information includes the likelihood of side effects or complications of an intervention.
