

**Note:** there is a False Positive rate for covid19 of 97% in Ireland due to PCR cycle counts of 40 - 45 cycles. This skews the numbers for vaccinated and unvaccinated numbers. Also a person is deemed to be vaccinated until 14 days after a vaccination. This also skews the data for unvaccinated persons. Some covid vaccine deaths are being mislabelled as 'covid19'. The official HSE and HPSC numbers for vaccinated and unvaccinated and wrong.

#### **Analysis of Evidence**

The covid vaccinated are suffering far higher rates of death, cases, ICU admissions and hospitalisation than the unvaccinated. It is obvious that the vaccines are not working and the boosters which are the same as the vaccines will not work either in this country as we have seen in other countries such as Israel where the 3<sup>rd</sup> vaccine or 'booster' did not work and they are planning a 4<sup>th</sup> vaccine or 'booster'.

Covid19 patients have continued to be deprived of safe and effective medicines for covid19 since April 2020 and early treatment of such and use of these as preventatives and prophylactics due to government, NPHET and HSE policies which banned or blocked them. These medicines would have reduced hospital admissions by 50% or more according to top medical experts and which we have seen in other places such as Florida, where Governor DeSantis introduced Regeneron as an early treatment. This must be factored into the hospital numbers mentioned above. The best solution is to provide the vaccinated and unvaccinated with the safe and effective medicines for covid19 which have been available since April 2020 and been used and highly recommended by medical doctors in the USA and a few other countries and mentioned in our prior books of evidence given to the gardai (Irish police). Deploy early treatments and also use them as Preventives and Prophylactics and Use the Focussed Protection advised by the Great Barrington Declaration and Save Lives instead of killing them and take the pressure off the hospitals. But the Irish government and NPHET and HSE have refused to do this and are refusing to do so. This is totally unethical and provides more evidence of their criminal actions criminal intent criminal behaviour and criminality which requires prosecutions in court. Please note that the European headquarters of Regeneron is in Dublin and the supply of Regeneron as an early treatment was not allowed in Ireland, yet one could get this early treatment under a compassionate plea only and again and this was not broadcast by the Irish government and media. In November 2021, the European Medicines Agency approved Regeneron for use in European Union countries such as Ireland. Yet it continues to be blocked in Ireland.

Death is the most serious outcome of covid19 or any illness and this is much higher in the covid vaccinated than in the unvaccinated. These only measure covid19 deaths and not **All Cause Mortality** in the vaccinated. 



#### The Key Factor for Irish Hospitals

Covid19 patients have continued to be deprived of safe and effective medicines for covid19 since April 2020 and early treatment of such and use of these as preventatives and prophylactics due to government, NPHET and HSE policies which banned or blocked them. 

### More evidence that the covid vaccines and vaccine certs or passports are not working and will not work and are not justifiable on Legal and Scientific grounds


The graph below corroborates the evidence in our prior books of evidence that the covid vaccines are not working and the vaccine certs or passports are not working.



Willful misconduct requires that the covered person acted


(i) intentionally to achieve a wrongful purpose;



In the graph it is stated that in the 0-14 age group there have been no deaths from March 2020 to December 10, 2021. And only 6 deaths in the 15 to 24 ager group. These deaths occurred after mass covid vaccinations of this age group in September and October 2021. This information has been stated by the Central Statistics Office (CSO) and is highly reliable.

In the 2 graphs below which cover March 2020 to November 2021 there were no deaths in the 0-14 age group and 5 deaths in the 15-24 age group by November 12<sup>th</sup> 2021 and 6 deaths by November 26, 2021.
