Exhibit 150 - Grounds for Causality

The grounds for Causality were outlined in the affidavits, exhibits, statement of truth, and books of evidence filed in the High Court since December 2022.

1. The **Bradford Hill criteria** for proving causality are used in this document. These criteria are recognised worldwide as reliable scientific criteria for assessing, evaluating and proving Causality for over 50 years. We go well beyond the dictum of 'correlations suggest causality' to show close relationships between many factors and outcomes linked to mass covid19 vaccinations and boosters. This includes autopsy findings, despite the efforts of some governments to censor Coroners and Pathologists and block autopsies and post mortems of dead covid19 vaccinated people and block efforts to establish how the vaccine and/or spike protein is killing people.

Summary of Causality Factors below

The Causality factors and evidence cited in this document are consistent and coherent with each other, they corroborate each other, and all point to one causal agent. All of these **Causality Factors** when combined together satisfy the **Bradford Hill criteria for Causality**. The Bradford Hill criteria have been met as elucidated in the following points :

- multiple correlations using vast amounts of people and data across many countries and continents all pointing to one factor over the same time period. A large association between this one factor and

certain adverse events or outcomes which did not exist at this high rate or high level prior to the introduction of this one factor. Very low P factors, below 0.05, which show that there are no coincidences or random events or errors taking place.

- the cause and effect being tightly linked together temporally in time and pointing to the same factor across many countries and continents. It can take from a few hours to a week to 6 months for effects to fully emerge or become known to the person. And effects here include “sudden death”. And these health effects did not exist in the person prior to being injected.
- the types of deaths and illnesses and disabilities caused by this one factor are consistent across many countries and continents
- the biological mechanisms between cause and effect in terms of deaths caused and illnesses and disabilities caused have been described in published peer reviewed scientific studies and autopsy evidence and embalmer evidence and is the subject of ongoing scientific research and autopsy research worldwide.
- the autopsy and post mortem findings are consistent with this causal agent worldwide. At present Coroners and Pathologists are being blocked or stopped from investigating deaths caused by the covid19 vaccines. This interference in Science is illegal, unlawful, unConstitutional and anti science.
- this same factor has been identified in embalming and forensic examinations and forensic evidence and examination of inflamed tissues from dead people. Also the same type of inflammation has been found at the injection site on the arm as in the heart. There was no forensic evidence of this type prior to this one factor being introduced or injected into the general population.
- the damage caused by this one factor fulfills Koch’s Postulates. There is a high level of consistency internationally.
- repeated doses of or exposure to this one factor causes a worsening of outcomes, illnesses or more deaths
- the same factor and cause is identified in blood tests. Comparisons of covid19 vaccinated blood and unvaccinated blood shows many abnormalities in vaccinated blood making the vaccinated person more vulnerable to illnesses, disability and premature death.
- Specificity is proven through comparisons of unvaccinated people with vaccinated people. The differences are significant and large. Comparisons between the vaccinated and unvaccinated show higher death rates and hospitalization rates for the vaccinated in late 2021 and into 2022. This was particularly true in Winter 2022 and into 2023 and caused one of the worst hospital crisis ever in Ireland, Britain, Germany, Canada, the USA and Australia.
- the same factor has been identified in over 1,200 published scientific studies detailing injuries, illnesses, disabilities and deaths caused by this one factor, and is consistent across many countries and continents

- studies of cause and effect can be replicated to prove causality and some are in the 1,200 published scientific studies cited above. The same applies for autopsy evidence. At present Coroners are being blocked or stopped from investigating deaths caused by the covid19 vaccines. This interference in Science is illegal, unlawful, unConstitutional and anti science.
- Deaths from all causes shortly after getting the vaccine and comparing this to deaths from covid19 infections prior to vaccinations
- Pfizer internal documents released under a Federal court order in the USA show that the covid19 vaccines cause these illnesses, disabilities and premature deaths. And this corroborates the 1,200 published scientific studies and autopsy evidence above, and the evidence on government databases worldwide including VAERS, MHRA, Eudragilance and others. And the fact that they and the FDA tried to cover up this for 75 years, but were prevented from doing so by a federal court order in the USA in late 2021 provides more proof of Causality. This is called multiple corroboration of evidence and provides excellent proof of Causality.
- confidential documents released by the EMA in Europe and Medicare in the USA point to this causal factor and corroborate the injuries, illnesses, disabilities and deaths caused by it.
- comparisons between the covid19 vaccines and other vaccines on similar population sizes which are referenced on government databases worldwide show that there are far more illnesses and disabilities and deaths associated with the covid19 vaccines compared to other vaccines in the past. This is strong evidence that the covid19 vaccines are less safe than other vaccines and are in fact dangerous. This corroborates the other factors mentioned here.
- a big rise in the numbers of healthy young people under 40 dying suddenly during the period of mass covid19 vaccinations in highly vaccinated countries. The term “sudden deaths” is widely used to describe the sudden and unexpected deaths of young vaccinated people including children.
- extremely rare illnesses suddenly became more common for vaccinated persons and after the introduction of this vaccine. And scientific and medical research is underway to provide a biological explanation for this.
- there is coherence between laboratory data and epidemiological data and statistical data. Mortality figures and excess mortality figures have risen by high and significant amounts after this one factor was administered to the general population and this has occurred in many countries
- all other causes including coincidences are ruled out by probabilities of many trillions to one
- conflicts of interest have served to deny, dismiss, cover up, and ignore this vast amount of scientific, medical, autopsy, forensic, and statistical evidence. People with conflicts of interest have blocked and stopped Coroner’s Inquests and autopsies into vaccine deaths, blocked and censored the reporting of vaccine injuries, illnesses, disabilities and deaths in the press and media and in scientific journals,

ridiculed and dismissed the vaccine injured, and censored and threatened medical doctors, nurses, scientists and politicians. They have failed in their attempts to reduce all of these vaccine induced deaths, injuries, illnesses and disabilities down to “coincidences”, random events, after-effects of lockdowns, lack of statins, lack of ambulances or hospital beds, poor funding of healthcare, etc.. Lies and denials cannot hide scientific, medical, autopsy, and statistical facts and evidence and reality.

The Bradford Hill criteria are satisfied when the factors above are taken as a whole, and this is sufficient to prove Causality for these covid19 vaccines. Causality relates here to excess mortality, and vaccine deaths, injuries, illnesses and disabilities and higher risk of premature death at present and into the future which are having wide ranging negative effects on many countries including Ireland.

2. Large Rise in Excess Mortality in Ireland and other highly vaccinated countries during the period of mass Covid19 vaccinations and boosting

Evidence of a sudden, massive rise in excess mortality in highly covid19 vaccinated countries in 2021 and 2022 and 2023 has been provided in affidavits and exhibits and statements of truth and books of evidence filed by us in the High Court since December 2022. And a statement of truth filed in the court in 2023.

This sudden large increase in excess mortality occurred in very close proximity to the mass covid19 vaccinations and boosters in 2021 and 2022 in many countries. There is a strong time or temporal connection between the two. Statistical charts below show a correlation between covid19 vaccinations and a big rise in deaths and in excess mortality. And also tables of high vaccination rates for countries correlate to tables of big rises in excess mortality and the reverse is true. I refer to evidence and statistics filed in the court since December 2022.

- 3.** Our sworn affidavits and exhibits filed in the High Court and our books of evidence show the side effects of the covid vaccines which amount to over 100 pages long according to the WHO database, Vigiaccess and other official sources. And one Pfizer internal document released under a US court order showed over 1,200 deadly illnesses, diseases, disabilities, and types of deaths caused by this vaccine. And other Pfizer documents tracked many thousands of people suffering serious illnesses and disabilities caused by this vaccine, including 1,223 people killed by the Pfizer covid19 vaccine and the 40,000 people who got serious injuries, illnesses and disabilities in the first 90 days of the vaccination of the general public. These type of deaths and injuries, illnesses and disabilities occurred on a mass scale in all highly covid19 vaccinated countries including Ireland from mid 2021 onwards, up to the present, leading to the big rise in excess mortality and sudden deaths during this time period.

The massive rise in vaccine injuries, illnesses, disabilities and deaths caused by the covid19 vaccines and registered on government databases worldwide including VAERS, V-Safe, DMED, Eudravigilance, MHRA and others is detailed in the affidavits and exhibits we filed in the High Court since November 2022 and in our books of evidence proves that these covid19 vaccines are NOT safe. Yet these numbers are less than one tenth of the actual injuries, illnesses, disabilities and deaths according to scientific studies. So the real numbers are ten times worse ! In comparison to other vaccines and similar population numbers vaccinated in the past, the covid19 vaccines have been the deadliest in the last 50 years, and have had more illnesses, disabilities and deaths than other vaccines combined together over the last 30 years according to VAERS and other government databases. The Irish government and health authorities did not reveal these facts to the Irish people and those people who got vaccinated.

For example, in the USA the DMED data for the US military is shocking showing a massive increase in vaccine injuries, serious illnesses, disabilities and deaths caused by covid19 vaccines to young, fit, strong and healthy US military personnel in 2021 and 2022. This has caused a massive national security problem for the USA. A US Senator Ron Johnson sent an important letter about this to the US Secretary of Defense demanding information on shockingly high COVID-19 vaccine injury among military personnel

Senator Ron Johnson's letter confirmed lawyer Thomas Renz's presentation to the US Senate earlier. The Senator set a deadline for Secretary Austin to provide information regarding vaccine injury among military personnel until February 15, 2022. I quote from this letter:

"Based on data from the Defense Medical Epidemiology Database (DMED), Renz reported that these whistleblowers found a significant increase in registered diagnoses on DMED for miscarriages, cancer, and many other medical conditions in 2021 compared to a five-year average from 2016-2020.² For example, at the roundtable Renz stated that registered diagnoses for neurological issues increased 10 times from a five-year average of 82,000 to 863,000 in 2021," Sen. Johnson wrote.

Senator Johnson included in his letter the following medical conditions presented by Renz:

Hypertension – 2,181% increase

Diseases of the nervous system – 1,048% increase

Malignant neoplasms of esophagus – 894% increase

Multiple sclerosis – 680% increase

Malignant neoplasms of digestive organs – 624% increase

Guillain-Barre syndrome – 551% increase

Breast cancer – 487% increase

Demyelinating – 487% increase

Malignant neoplasms of thyroid and other endocrine glands – 474% increase

Female infertility – 472% increase

Pulmonary embolism – 468% increase

Migraines – 452% increase

Ovarian dysfunction – 437% increase

Testicular cancer – 369% increase

Tachycardia – 302% increase

These are stunning numbers.

At the end of his letter, Senator Johnson Secretary Austin the following questions:

Is DoD aware of increases in registered diagnoses of miscarriages, cancer, or other medical conditions in DMED in 2021 compared to a five-year average from 2016-2020? If so, please explain what actions DoD has taken to investigate the root cause for the increases in these diagnoses.

Have registered diagnoses of myocarditis in DMED been removed from the database from January 2021 to December 2021? If so, please explain why and when this information was removed and identify who removed it.

At an earlier US Senate hearing, several world-renowned doctors, scientists and medical experts spoke during a panel discussion titled “Covid-19: A Second Opinion” in Washington DC on January 24, 2022, which was hosted by Senator Ron Johnson (R-WI). During the event, Ohio attorney Thomas Renz presented DOD medical billing data from the Defense Medical Epidemiology Database (DMED). Renz exposed the disturbing truth about what is happening to the health of our service members since the rollout of the jab a year ago. According to Renz, there was an astronomical increase in several serious illnesses and disorder diagnoses in the US military since the rushed rollout of the Covid-19 vaccine.

The whistleblowers came forward because of what they were seeing on the job as they treated military personnel, leading them to investigate the DMED system for anomalies related to the increase they had seen in their clinical experience, Renz said during the discussion. In Autumn 2022, due to pressure from Senator Johnson and others, the US military ended the mandate for covid19 vaccinations. And several elected representatives across political parties in the US Congress

are investigating the non disclosures and frauds associated with these covid19 vaccines and the massive number of injuries, serious illnesses and deaths caused by these vaccines.

Over 1,000 published and peer reviewed scientific studies are showing and continue to show a massive rise in serious illness, disabilities and premature deaths associated with covid19 vaccinations and boosters and a strong link between the sudden development of several deadly illnesses and premature deaths or “sudden deaths” and excess mortality on one side and covid19 vaccinations on the other side. The link is strong and is being proven by more and more evidence.

The Irish government and health authorities did not reveal these facts to the Irish people and those people who got vaccinated. The Irish government and health authorities did not communicate the data from VAERS, V-Safe, DMED, MHRA and Eudravigilance and others showing a high number of injuries, serious illnesses, disabilities and deaths caused by these vaccines to the Irish public and to those people who got the covid19 vaccines. They parroted the words “safe and effective” for these vaccines continuously in the press and media and in medical leaflets but refused to tell the Irish public about the risks and dangers. This in itself was fraud and they used fraud and deception to get the informed consent of people for these vaccines in Ireland. This has had devastating consequences for many people around Ireland in terms of vaccine injuries, serious illnesses, disabilities and premature deaths.

4. I further say that the Pfizer internal documents released under Federal Court order in the USA in 2022 corroborate the evidence we have given in sworn affidavits and books of evidence to the High Court in this court case. The following has recently been revealed in these Pfizer documents :

- 300 reports of stroke within 41 days of covid19 vaccination
- 50% of strokes occurred in the first 48 hours
- All 300 reports were classified as "serious"
- One in five (61 of the 300) strokes was **fatal**, 32% did not resolve, 28% had an “unknown” outcome, and three suffered very rare deep brain clots (cerebral venous sinus thrombosis).

And what was Pfizer’s conclusion? “This cumulative case review does not raise new safety issues.”

Pfizer Ignored this horrific Stroke Safety Signal 90 Days After Vaccine Rollout in 2021. Both Pfizer and the FDA ignored this. And the EMA in Europe and Irish regulator who had access to these FDA documents and data also ignored these dangers and refused to inform the general public. This has been uncovered by a special team of investigators who are trawling through the Pfizer documents on a site online at

The HPRA and NIAC in Ireland ignored these important facts while spouting “the vaccines are safe and effective” to the general public. They have proven themselves not interested in the scientific, medical and statistical facts and evidence and informing the general public. These covid19 vaccines are highly profitable for those people in positions of power and of dominance over others and this and conflicts of interest may be the deciding factor here.

5. The forensic evidence supports the above points. Pathology reports by top pathologists clearly show spike protein damage to the organs and blood vessels in the dead bodies of covid vaccinated people. And embalmers and scientists have removed large clots from the bodies of covid vaccinated people only. And they only started seeing this after mass covid vaccinations began in 2021 and 2022. **Points below go into this in more detail.**
6. I further say that on the topic of “Information is Power”, it is equally true that concealment of information and non Disclosure of information disempowers the people, and places their lives at serious risk of injury, illness, disability or death from vaccines. On this very point, an official EU Safety Report on the Pfizer mRNA vaccine reveals damning data and corroborates our evidence that the covid19 vaccines are not safe and have caused a high number of injuries, illnesses, disabilities and deaths. Many illnesses and disabilities caused by the covid19 vaccine were identified in the Pfizer trial and also in the post authorisation period. This EU Report was kept secret and hidden from the general public. It was only released via an FOIA request and then provided to the public by an anonymous person, being provided to the Austrian science and political blog, TKP.

The following is an overview of the total number of cases - post-marketing and clinical trial data - of the 6 month reporting period:

- 327,827 case reports (individuals) containing 1,172,887 events (adverse events)
- Three times more cases reported for women than for men
- Highest number of reported cases in the 31-50 age group
- A third of all case reports were classified as serious
- 44% of case reports were classified with outcomes as either unknown or unresolved
- 84% of case reports had no history of comorbidities
- 5115 deaths occurred after vaccine was administered
- 46% of fatal outcome cases occurred in those without any comorbidities

22 people under 17 died, and had no underlying illnesses. Out of 26 pregnancy cases in the trial, 15 ended in miscarriages and 5 resulted in live births with birth defects.

This important information was hidden from the public and kept secret and NOT provided by the EU authorities, the EMA and the Irish government and health authorities to the general public and to people who got covid19 vaccinations. There was NO full and valid informed consent for these vaccinations.

This is another ground for fraud we are adding to the existing grounds for fraud.

The mRNA and spike proteins last for a long time in the body, scientists believe it could be for years or decades. This risk extends to young girls aged 5 to 11 who will over time mature into women of child bearing age and boys aged 5 to 11 who will mature into men. The risk is long term and significant.

7. A Pfizer internal document released under Federal court order in the USA and titled 'PREGNANCY AND LACTATION CUMULATIVE REVIEW' viewable at

https://phmp.org/wp-content/uploads/2023/04/125742_S2_M1_pllr-cumulative-review.pdf

filed with the Regulators including the FDA in the USA and the EMA in Europe and HPRA in Ireland shows the dangers of the Pfizer covid19 vaccine to pregnant women and their unborn babies. These dangers were not revealed to the general public by Pfizer or by the FDA in the USA and the EMA in Europe and HPRA in Ireland when they became known in April 2021. These dangers were concealed, hidden and covered up, while the Regulators in Europe, Ireland, the USA and other countries and the Irish government and health authorities claimed the vaccine was "safe and effective" and encouraged pregnant women to get vaccinated.

Up to 28 February 2021, 673 cases were identified involving pregnant or breast feeding women. 458 of these involved vaccine exposure to the mother or fetus during pregnancy and 215 involved exposure during breast-feeding. (Remember all the fact checkers saying babies can't be exposed during breast-feeding, even though Pfizer had this data).

Out of the 458 cases involving exposure to the mother or fetus, 210 were reported with no associated adverse events. Of the remaining 248 cases there were 53 spontaneous abortions which represents 12% of the total.

It should be noted that pregnant women were excluded from the Pfizer covid19 vaccine trial as there were fears of damage to the women and /or unborn baby. This means the mass vaccinations of pregnant

women was an illegal and unlawful experiment on pregnant women and their unborn babies. The deliberate non disclosure of this to general public promoted deprivation of full informed consent and the vaccine fraud.

8. Medicare data as strong and irrefutable evidence

I further say that on the subject that 'Information is power' that concealment of certain important information can be very damaging to people's health and lethal in many cases. And it also prevents the obtaining of full and valid informed consent for vaccines. On this point, Medicare data in the USA conclusively proves that the covid19 vaccines increase a persons' risk of dying. The data for this is irrefutable as it from Medicare, which is run by the US government and is one of the biggest data gathering organizations in the world. This Medicare data was deliberately concealed from the general public in the USA and hidden from medical doctors and scientists, and was kept hidden and secret until February 2023. This Medicare data was supplied to Mr. Steve Kirsch in the USA, and he has put this information up on his web page and also provided statistical analysis of this data. This proves that the covid19 vaccines cause premature deaths and that the vaccines are unsafe and ineffective.

This Medicare data is Exhibit 100 for the High Court

- Non Disclosure of the Pfizer internal documents filed with the FDA in the USA and Regulators in many countries including the FDA in the USA and the EMA in Europe and HPRA in Ireland. These Pfizer documents were filed with the Regulatory authorities, and thus should have been made available to the Irish public, but were not. These documents were supposed to be covered up and never released to the

public. After one US Federal court case in Texas in 2021 this was changed to release them to the general public over 75 years. This was later amended by another court order in 2022 to release them immediately and deliver 55,000 pages every month to the public with a projected total release of all documents within 2 years. These Pfizer documents were released to the public from February 2022 onwards under this US court order in Texas in the USA in 2022. I enclose **Exhibit 113** which is a copy of this US court order. These Pfizer documents showed over 1,200 deadly illnesses, diseases, disabilities, and types of deaths caused by this vaccine. These filled 9 pages and are truly shocking. This certainly shows that the covid19 vaccines are NOT safe. And other Pfizer documents tracked many thousands of members of the public suffering serious illnesses and disabilities caused by this vaccine, including 1,223 people killed by the Pfizer covid19 vaccine and the 40,000 people who got serious injuries, illnesses and disabilities in the first 90 days of the vaccination of the general public.

This is in Exhibits 1 and 2 filed by us in the High Court.

I further say that these Pfizers internal Reports released under Federal court order in the USA in January 2022 continue to show that the covid19 vaccine causes serious illnesses and disabilities including autoimmune illnesses where the immune system attacks the organs in the human body.

This team of experts, the Daily Clout, produced Report 66 titled '1,077 Immune-Mediated/Autoimmune Adverse Events in First 90 Days of Pfizer mRNA "Vaccine" Rollout, Including 12 Fatalities. Pfizer Undercounted This Category of Adverse Events by 270 Occurrences'.

This has had serious adverse consequences for many vaccinated people. This is further proof that the covid19 vaccine is not safe and that the vaccine induced mass production of spike proteins in the human body is the main factor in this unsafety. These risks of serious illnesses, disabilities and deaths from the vaccine were NOT disclosed by the Irish government and health authorities to the general public and to vaccine recipients in Ireland. Indeed there was a deliberate attempt by Pfizer and the Regulators in North America and Europe to hide and conceal these documents and never reveal them to the public.

9. I say that Pfizer internal documents and documents they submitted to the FDA in the USA and to the EMA in Europe did not disclose to the public the details about a trial of the vaccine on rats which showed that the vaccine was unsafe and carried serious risks.

In the USA, ICAN's attorneys reviewed a startling 2,237-page report from June 2020 (amended in September 2020) that Pfizer submitted to the FDA concerning its mRNA COVID-19 vaccine. The study looked at the toxicity of Pfizer's vaccine using four different doses (including the one eventually authorized for emergency use, BNT162b2) and involved 255 rats (219 received vaccine, 36 received control) for a test period of 10 to 17 days with "3 additional weeks for the animals scheduled for the recovery period."

While the Pfizer claims in the report that the rats tolerated the vaccines "without evidence of systemic toxicity," its detailed findings indicate that was anything but the truth, as the following issues in major organs groups were observed:

- Enlarged spleens
- Enlarged adrenal glands
- Enlarged lymph nodes
- Kidney and liver congestion
- Increased fibrinogen concentration

And two rats died during the study, this was 1% of them. The study was 6 weeks only, and was very short term and did not assess the risks and deaths from the vaccine over the medium term and long term. The damage to the organs of the rats and the excessive blood clotting would have lead to premature deaths for many of the rats over the medium to long term. The same effects are now being observed in vaccinated humans.

All of these issues clearly show effects beyond the injection site. Of particular concern is the increased fibrinogen concentration; fibrinogen is made in your liver and helps your blood clot. Increased fibrinogen is associated with blood clotting, heart disease, blood vessel dysfunction, heart attacks and stroke. These issues were also seen with the dose level that was eventually licensed for humans.

10. In our affidavits, exhibits, and books of evidence filed in the High Court since November 2022 and into 2023, we have provided pictures and videos from medical doctors, scientists, embalmers, funeral directors, and pathologists of long and large blood clots pulled out of the dead bodies of covid vaccinated people which correlates to the excessive abnormal blood clotting and abnormal blood structures observed by scientists and doctors under microscopes in living people who are vaccinated. The blood of covid vaccinated people was compared to the blood of unvaccinated people and major differences were established between the two. The vaccinated blood had excessive blood clotting and several foreign particles in it while the unvaccinated blood did not have this and was normal. The evidence of excessive clotting in living covid vaccinated people is well established and the pathology evidence from the dead bodies of vaccinated people confirms this. Excessive clotting is playing a major role in these sudden deaths of covid19 vaccinated people. This corroborates the other evidence here to confirm causality. More evidence of this is provided in points below.
11. I cite the well known dictum “information is power” and this is very true today, as information or the concealment or hiding of information can determine life or death. And matters of life and death are taken very seriously by the Irish courts. In the case of experimental covid19 vaccines, the relevance of information to life or death is extremely important. I say that informed consent and accompanying bodily integrity is based on information, on the information received or not received, or not given or deliberately hidden. On this point, Pfizer gave a Press Release on January 27th 2023 where they finally admitted that the covid19 vaccine causes many of the serious illnesses and disabilities which can lead to premature deaths or “sudden deaths” we have mentioned in this affidavit and previous affidavits filed in the High Court and in our books of evidence, and that this corroborates the evidence in this affidavit and our previous affidavits and our books of evidence. Pfizer have decided to admit to this after knowing about this for over one and a half years and this has placed the lives of millions of people in serious danger, a danger now manifested in the high number of vaccine injuries, illnesses, disabilities and premature deaths and excess deaths been seen in many countries including Ireland.

And Pfizer and their servants and vassals in the government and health authorities and “government advisers” and “experts” deprived millions of people in Ireland and abroad of full and valid informed

consent for these vaccines and boosters. Great damage and physical harm, emotional and psychological harm and financial harm has been done to millions of people by depriving them of full and valid informed consent for these vaccines.

It takes from 5 to 10 years to establish the safety and effectiveness of vaccines and other medical products. No property safety studies have been conducted to measure all cause mortality over the short, medium and long term from these vaccines. The vaccine companies have been operating in the dark not knowing vital data about the vaccines and governments and their health advisors and the HSE have been parroting or copying them and are also in the dark. Their presumptions and allegations of "safe and effective" are groundless and worthless.

Statistics provided by our World in Data shows high excess mortality in highly vaccinated countries and highly boosted countries in 2021 and 2022

I present to this court Statistical Tables of excess mortality, covid19 vaccination rates per country and booster rates per country which are provided in the following documents, this is Exhibit 12b which show a correlation between covid vaccinations and a big rise in excess mortality

In 2016 the Society of Actuaries performed a study looking at the years 2010 through 2013, in which they compared the mortality rates of people on Group Life Insurance policies to the general population. And they found that the Group Life cohort died at about one-third the rate of the general population for each respective age group within working-aged years.

But "that inverted in 2021." Instead, Group Life policyholders (employed with well-paying jobs) suffered 40% excess mortality, whereas the general population experienced 32% excess mortality — an 8% difference.

2.) The U.S Bureau of Statistics Disability Data

15. Big rise in Excess Mortality statistics for highly covid vaccinated countries across the world shortly after mass covid19 vaccinations in Spring 2021.

Excess Mortality statistics for Britain show a sudden large rise in Excess Mortality in children aged 0 to 14 years old from Quarter 3 2021 into 2022. This correlates to mass covid19 vaccinations of children from Quarter 3 2021 and into 2022. The statistics show that there was negative excess mortality for this age group up until Quarter 3 2021 and then suddenly there was a large increase in excess mortality after this and the rising covid19 vaccinations line correlates with this rise in excess mortality. The best scientific and medical explanation of causality is given by Dr. Michael Palmer and Dr. Sucharit Bhakdi, a medical doctor and former professor of Medicine in Germany who are members of Doctors for Covid Ethics have set out what they deem “irrefutable proof of causality” that mRNA vaccines are causing vascular and organ damage. From studies and autopsy evidence the medical experts show:

1. mRNA vaccines don’t stay at the injection site but instead travel throughout the body and accumulate in various organs;

- 19.** These covid vaccine injuries, illnesses, disabilities and deaths are consistent across countries and continents and they all occurred after mass covid vaccinations began in 2021. The same is true for the big rise in excess mortality figures which have occurred across countries and continents. The common factor is mass covid19 vaccinations.

I say that an important scientific paper published in Norway and under peer review at present points to a mathematical correlation between mass covid19 vaccinations and rises in Excess Mortality for the months of 2022. I cite the scientific paper below

Is there a Link between the 2021 COVID-19 Vaccination Uptake in Europe and 2022 Excess All-Cause Mortality?

It was an Analyses of 31 countries, from January to September, 2022 involving 31 EU member states, plus Norway, Iceland, Liechtenstein, Switzerland. All-cause mortality increased more the higher the 2021 vaccination uptake. Countries with more covid19 vaccinations in 2021 had higher excess mortality in first 9 months of 2022. Positive correlation between vaccination in 2021 and excess deaths in 2022

A one percentage point increase in 2021 vaccination uptake, was associated with a monthly mortality increase in 2022 by 0.105% (95% CI, 0.075-0.134). This provides strong grounds for Causality.

- 20.** Official government statistics from Japan show that mortality and excess mortality were normal for the years prior to 2020 and were very low in 2020 during the covid19 pandemic but there was a massive increase in mortality and excess mortality after covid19 boosters were given to the Japanese in December 2021. Over 80% of the Japanese got the booster. The rise excess mortality in 2022 in Japan is the highest in over 50 years. Something killed large numbers of Japanese people in 2022.

I present Exhibit 61 to the court showing this massive rise in excess deaths and the high rate of covid19 boosters taken by the Japanese in 2022

Non-COVID excess deaths correlate very strongly with newly administered vaccine doses in all German federal states during the time between calendar week 8/2021 and calendar week 27/2021 (Pearson correlation coefficient on the national level: 0.980).

95.8% of the variance in weekly, nationwide non-COVID excess deaths is explained by the number of administered vaccine doses in Germany per week (Standard Error: 78.7 deaths per week).

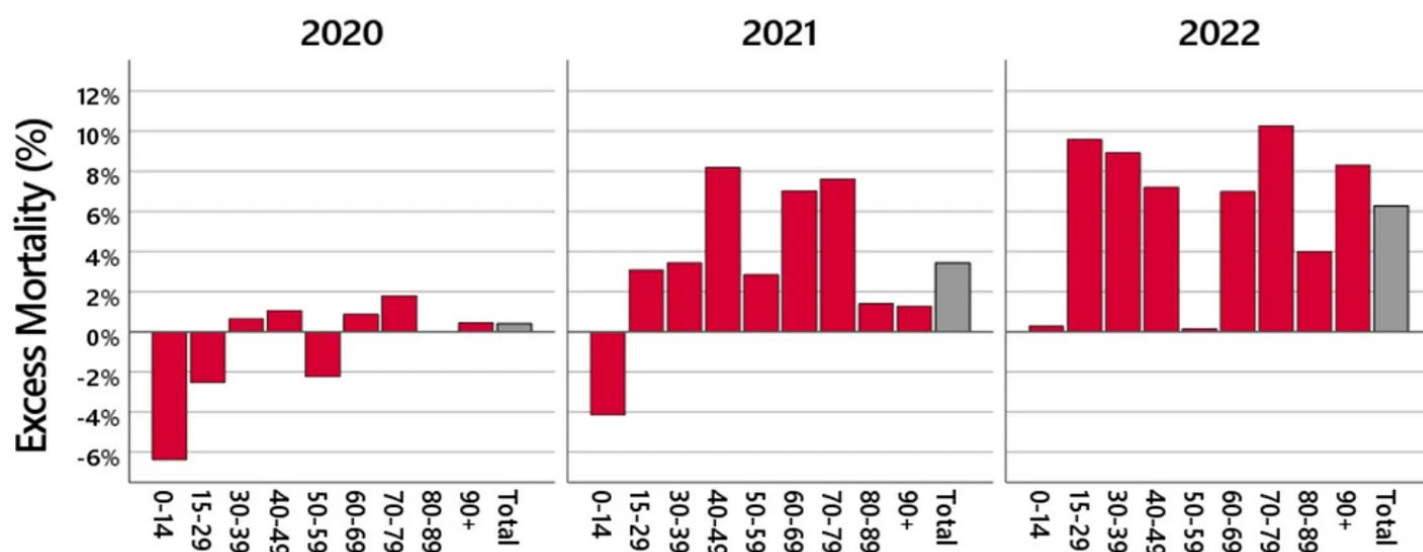
The correlation is strong enough to suggest a causal link. The insights we have gained into the pharmacodynamics of the nucleotide-based COVID-19 vaccines throughout the past years support the notion of a causal link between non-COVID excess deaths and administered vaccine doses.

One excess death occurred for every 1642 administered vaccine doses (95% CI: 1477-1808 doses).

Between the time of their introduction to the market until the end of 2022 a total of 191,029,491 COVID-19 vaccine doses were administered in Germany according to RKI figures. 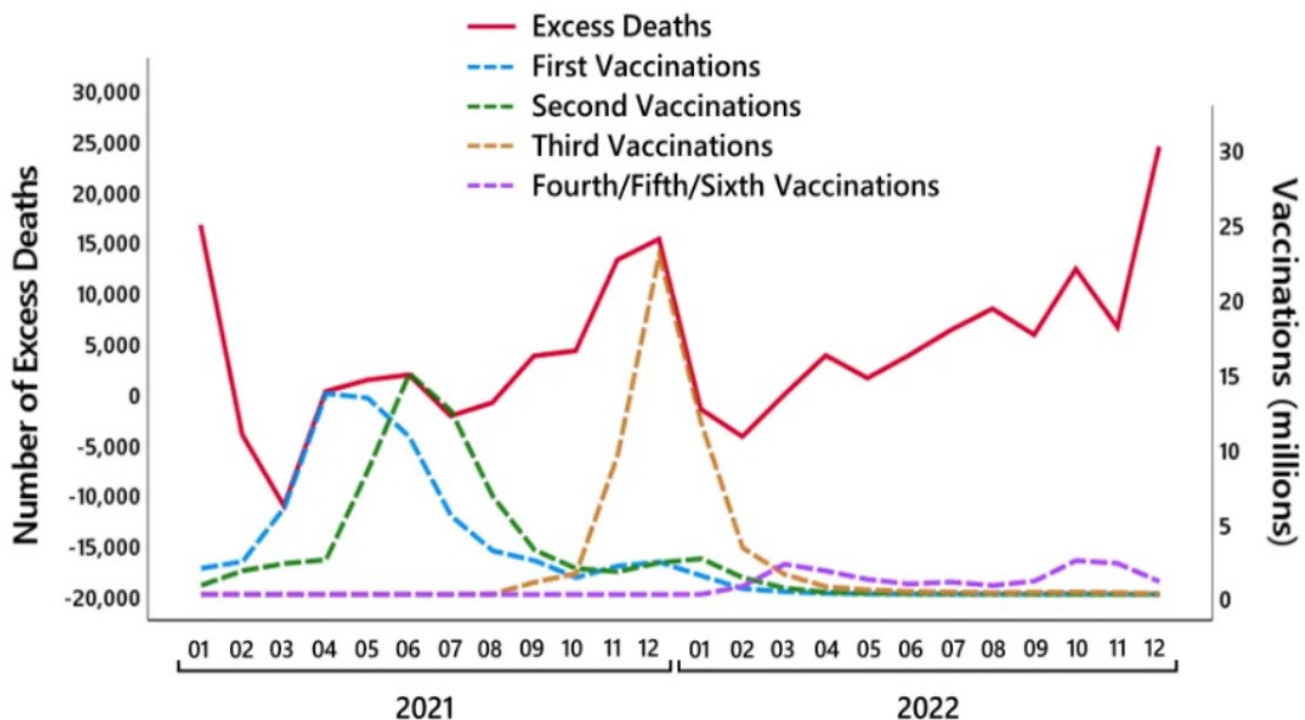

21. I further say that an important scientific study by Professor Christof Kuhbandner of excess mortality figures in Germany shows far greater excess mortality across all groups for 2021 and 2022 than during 2020 the year of the pandemic. I further say that the work and findings of Professor Norman Fenton and Martin Neil who are well known statisticians and analysts in Britain confirm a strong correlation between covid19 vaccinations and boosters and the rise in excess mortality in several countries, and that this is more strong proof of Causality. Using linear regression analysis and other statistical tools, they comprehensively looked at the impact of Covid itself, Long Covid, vaccines, and lockdown stringency, on total mortality for several countries. And Igor Chudov uses these findings to present them in a statistical graph and detailed statistical analysis, and he also provides statistical graphs showing a close correlation between covid19 vaccinations and boosters and excess mortality around the world. And similar statistical analysis for Britain by Igor Chudov confirms this same correlation. A previous affidavit filed by me in December 2023 presented Chudov's statistical findings for many countries and this has been updated for weeks 20 to 44 of 2022 and with new data for 2022.

In fact dose dependency is one the strongest and most convincing factors proving Causality and this has been the case for many years and decades.

25. Official statistics from the Office for National Statistics in Britain show that the covid19 vaccinated accounted for 92% of all covid19 deaths in 2022

There were 28,041 Covid-19 deaths in England between 1st January 2022 and 31st December 2022, and shockingly, 25,758 of those deaths were among the fully vaccinated population, while just 2,273 deaths were among the unvaccinated population. 92% of covid19 deaths were among the covid19 vaccinated. And there were 45,191 Covid-19 deaths in England between 1st April 2021 and 31st December 2022, and 38,884 of those deaths were among the fully vaccinated population, while just 6,307 deaths were among the unvaccinated population. 86% of all covid19 deaths were among the covid19 vaccinated. 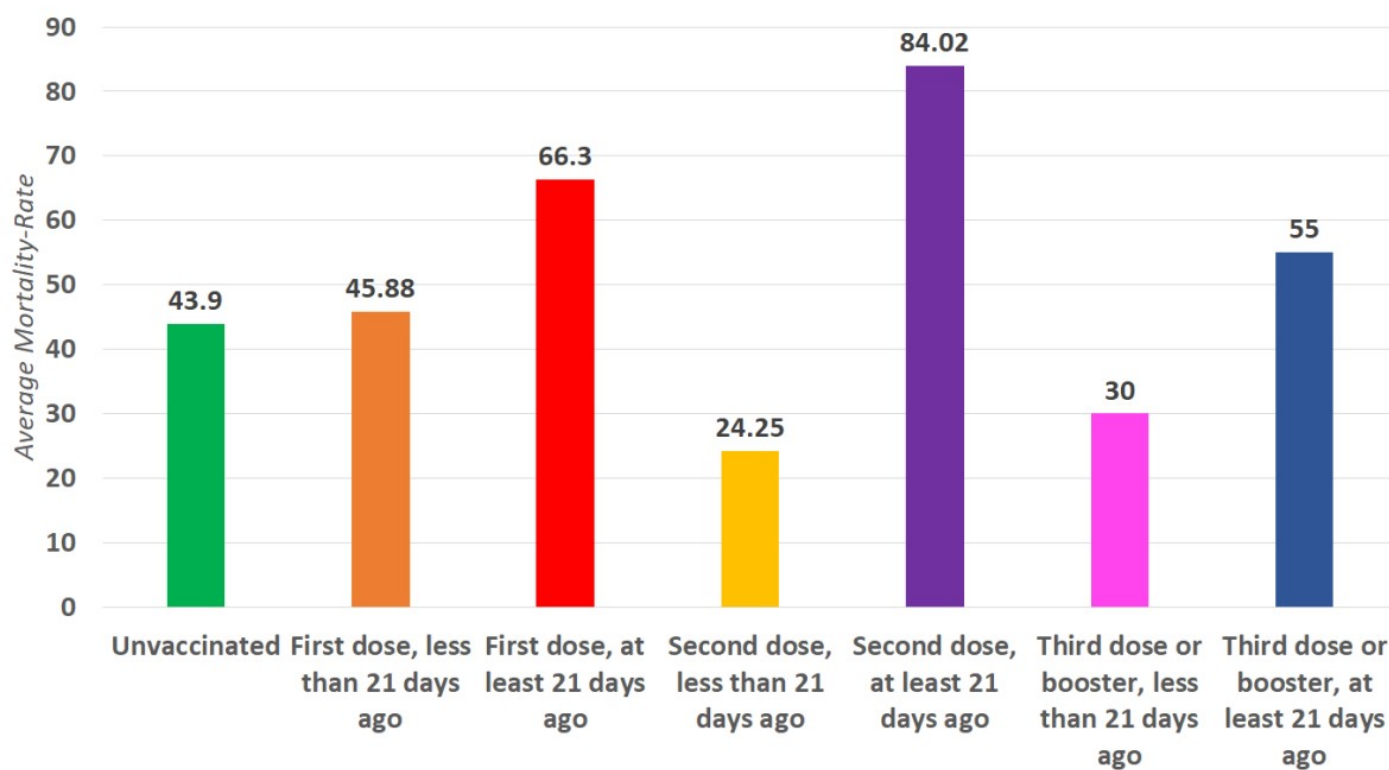

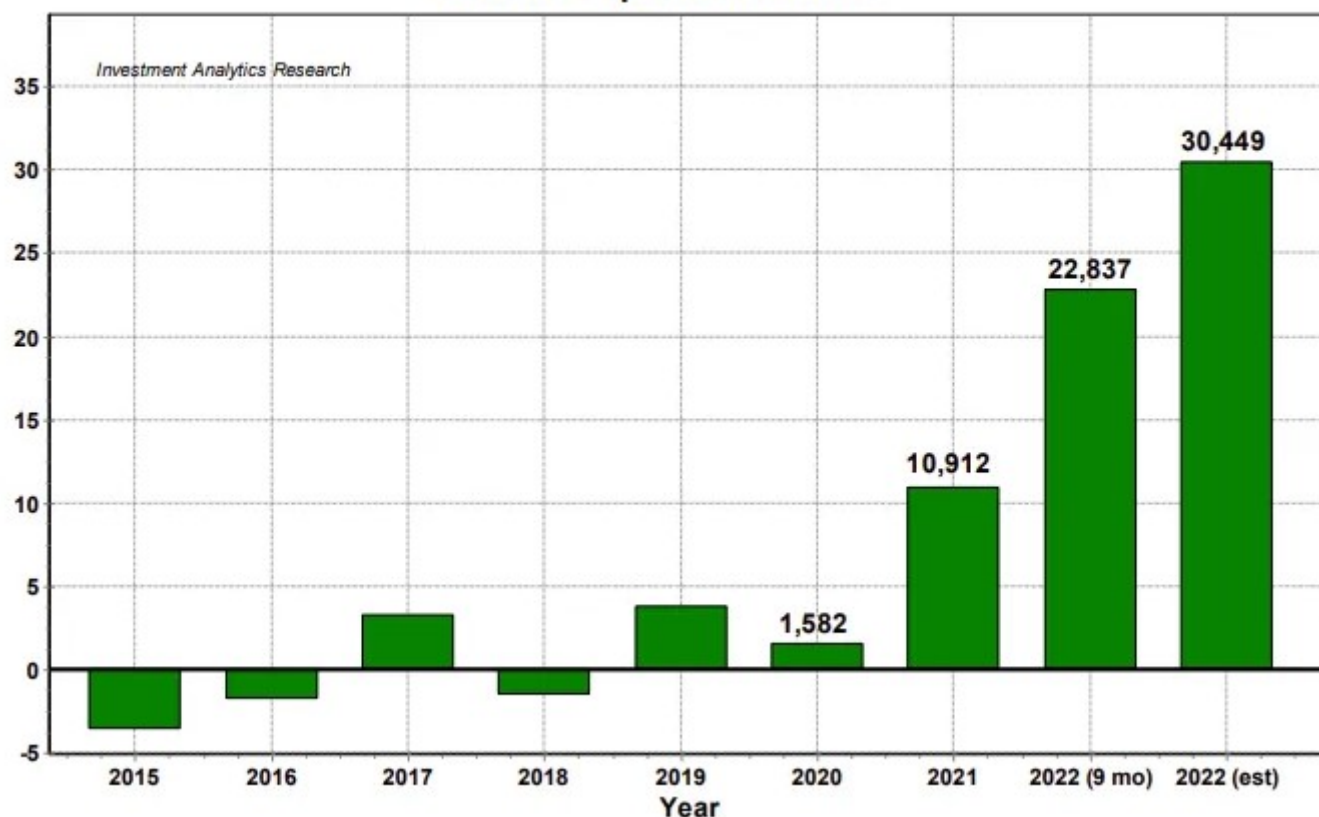

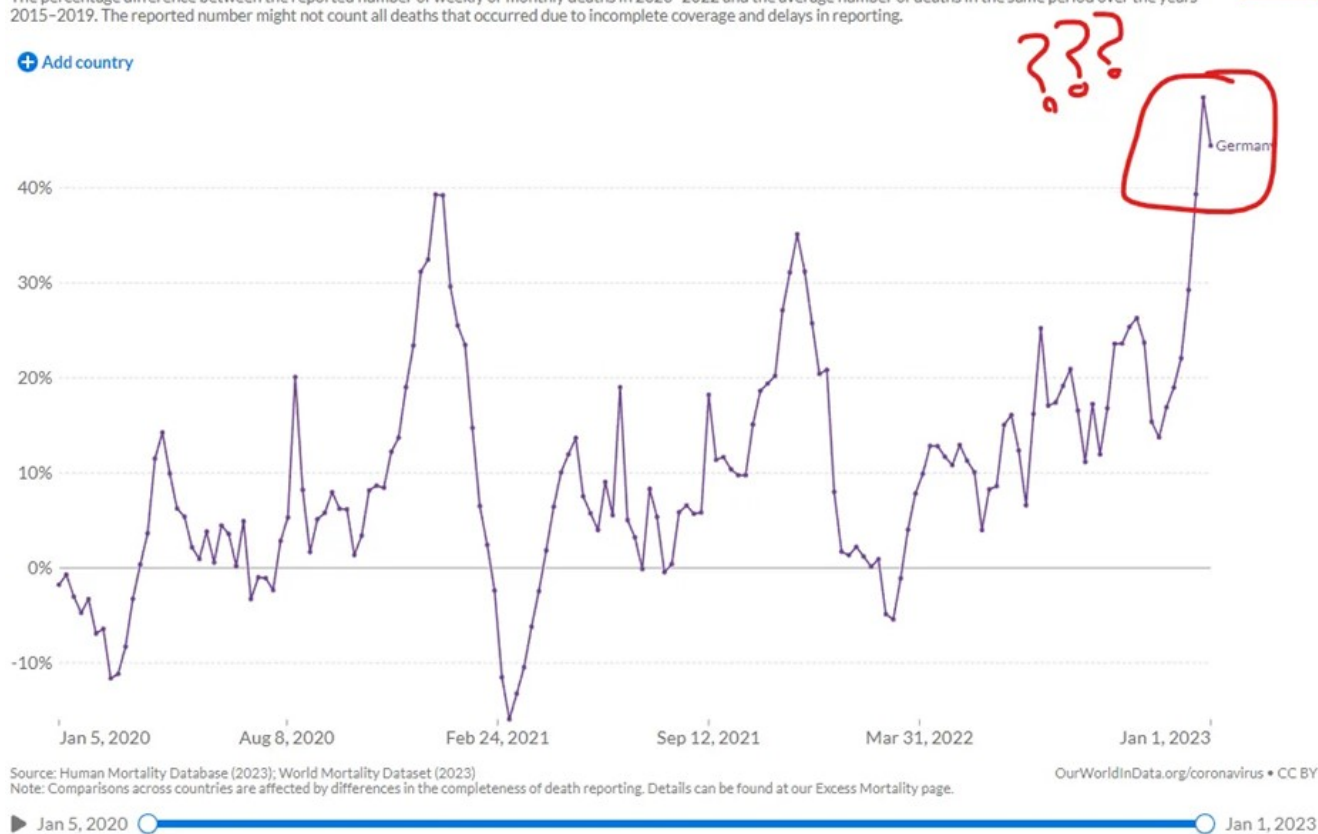

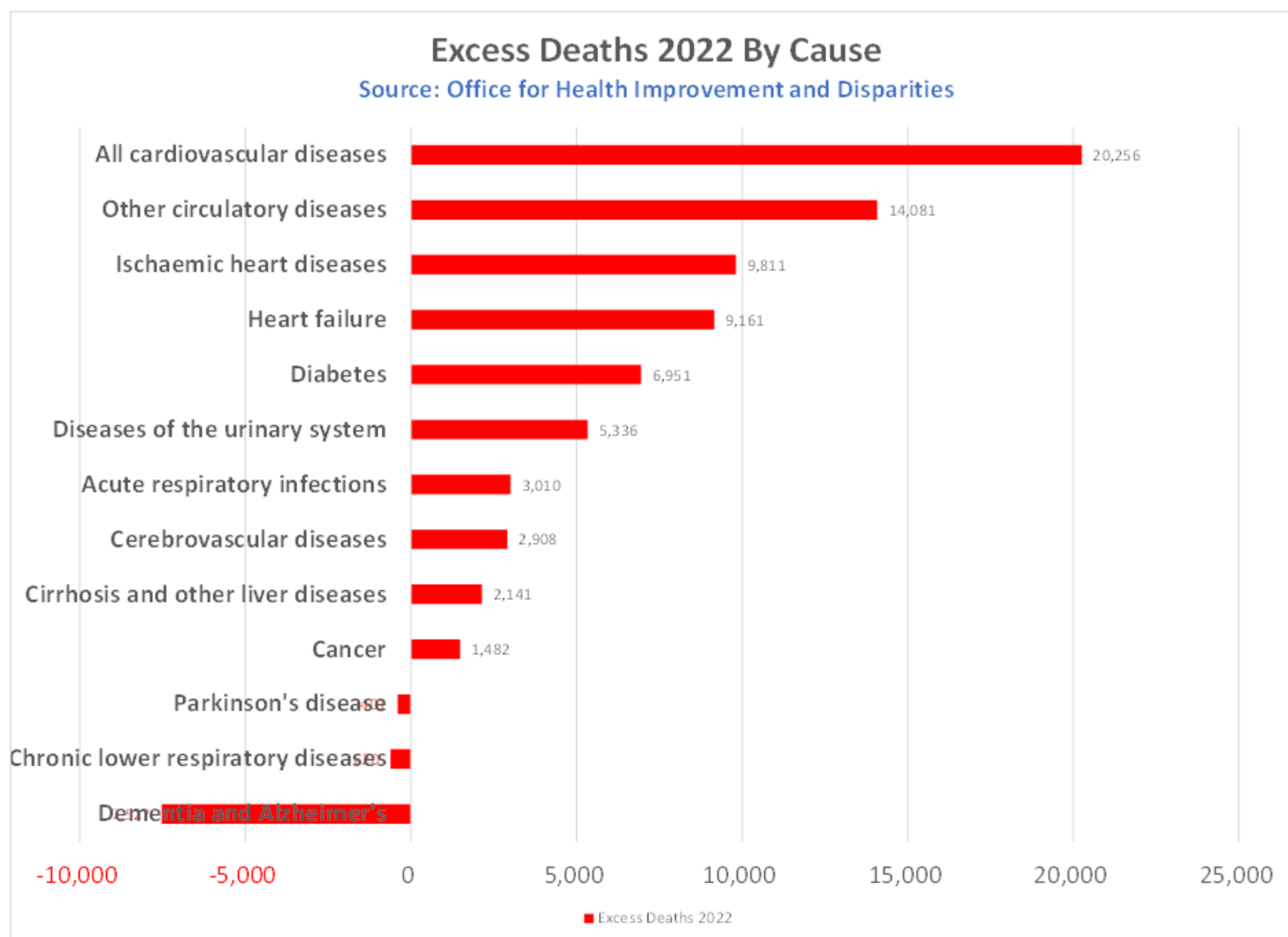

I further say that the following information was deliberately withheld and hidden from the general public, and was released only because of pressure from organizations who launched FOI requests for this data in the USA. And none of this data was communicated to the general public and to vaccine recipients and to parents and guardians prior to vaccinations. There was no full and valid informed consent given for these vaccines.

The CDC in the USA was forced to release the following data for covid19 vaccines in January 2023 and this corroborates our evidence and further supports our statements to the High Court and our case for an Injunction.

The analyses cover VAERS reports for mRNA COVID-19 vaccines from the period from the vaccine rollout on Dec. 14, 2020, through to the end of July 2022.

- Centers for Disease Control and Prevention's (CDC) Vaccine Adverse Event Reporting System (VAERS) safety signal analysis based on reports from Dec. 14, 2020 – July 29, 2022, for mRNA COVID-19 vaccines shows clear safety signals for death and a range of highly concerning thrombo-embolic, cardiac, neurological, hemorrhagic, hematological, immune-system and menstrual adverse events (AEs) among U.S. adults.
- There were 770 different types of adverse events that showed safety signals in ages 18+, of which more than 500 (or 2/3) had a larger safety signal than myocarditis/pericarditis.
- The CDC analysis shows that the number of serious adverse events reported in less than two years for mRNA COVID-19 vaccines is 5.5 times greater than all serious reports for vaccines given to adults in the U.S. since 2009 (~73,000 vs. ~13,000).
- Twice as many mRNA COVID-19 vaccine reports were classified as serious compared to all other vaccines given to adults (11% vs. 5.5%). This meets the CDC definition of a safety signal.

This important evidence should be released to the public but there are conflicts of interest which are preventing this from happening. And this is also undermining full and valid informed consent for the covid19 vaccines.

I say that the scientific, medical and statistical evidence for the covid19 vaccines causing myocarditis and other serious heart injuries and illnesses is strong and growing worldwide. This corroborates the evidence in this affidavit and other affidavits filed with the High Court and our books of evidence. And the general public in Ireland including those who are vaccinated have not been informed about this evidence and risk by the government and health authorities. And that this denied people full and valid informed consent for these vaccines. I cite the following from **Exhibit 70** which is an open letter signed by over 100 medical professionals and academics in Britain

‘ There are a significant number of signals that COVID-19 vaccines have led to cardiac pathology, which warrants an urgent review of their safety:

1. The Pfizer trial saw four cardiac arrests in the vaccination group but only one in the placebo group after 6 months (although the numbers are too small to be statistically significant, this was a signal that should have been followed up).
2. The evidence for vaccine-induced myocarditis is well established and in older patients this may be misdiagnosed as any of the more common forms of heart disease. The rate of myocardial infarction was disproportionately high in the first three days after vaccination.
3. Studies in Thailand and Switzerland have shown rises in troponin levels consistent with damaged heart muscle in 3% of those vaccinated. Heart cells cannot be replaced and the resulting scarring can lead to electrical conduction issues and sudden death. 30% of the children in the Thailand study had cardiac signs or symptoms.
4. Vaccine-derived spike protein was detected in the heart biopsies of 9 out of 15 patients with post-vaccination myocarditis.
5. Vaccinated people had a rise in cardiovascular risk factors that would predict a significantly increased risk of heart disease (from 11% to 25% risk of a heart attack in 5 years). This study has been criticised for not having a control group but is the equivalent of an early phase clinical trial in demonstrating a safety concern.
6. An Israeli study showed a 25% increase in acute coronary syndrome and cardiac arrest calls in 16- 39 year olds associated with the first and second doses of vaccine but not with COVID-19 infection.

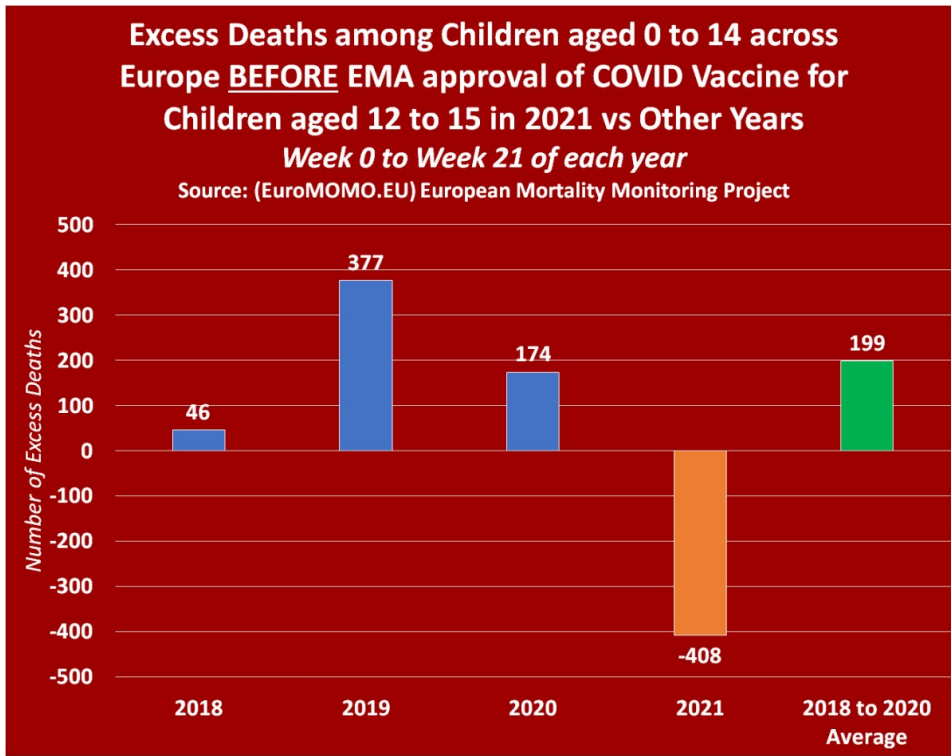
7. There were 14,000 more cardiac arrest calls to ambulances in England in 2021 than 2020.
8. There has been a rise in cardiac excess deaths and excess deaths have been disproportionately seen in more highly vaccinated groups e.g. less deprived cohorts and people of white ethnicity.
9. In a report of 35 autopsies in Germany, there were 5 deaths confirmed as caused by a COVID-19 vaccine and a further 20 deaths where a contribution from the vaccination could not be excluded.
10. Post mortem studies have shown inflammation of the coronary arteries after vaccination, causing death four months later.
11. A separate post mortem report showed vaccine-derived spike protein in heart muscle, in the absence of COVID-19 infection, in a subject who had myocarditis before he died.
12. Australian hospitals have experienced intense service pressure since Summer 2021, despite no significant COVID-19 infection rates or reduction in healthcare capacity at that time.
13. Australians have seen a similarly timed rise in excess non-Covid deaths, with ischaemic heart disease being the biggest contributor. This was despite no significant volume of COVID-19 cases or reduction in healthcare before Omicron as was seen in the UK.
14. Systematic exploratory analysis of the possible causes in the rise in excess deaths by comparing countries suggests a link to healthcare quality cannot be excluded but there is no link to COVID-19 or Long Covid. There is a weak link to lockdown severity but a strong correlation with vaccination. ‘

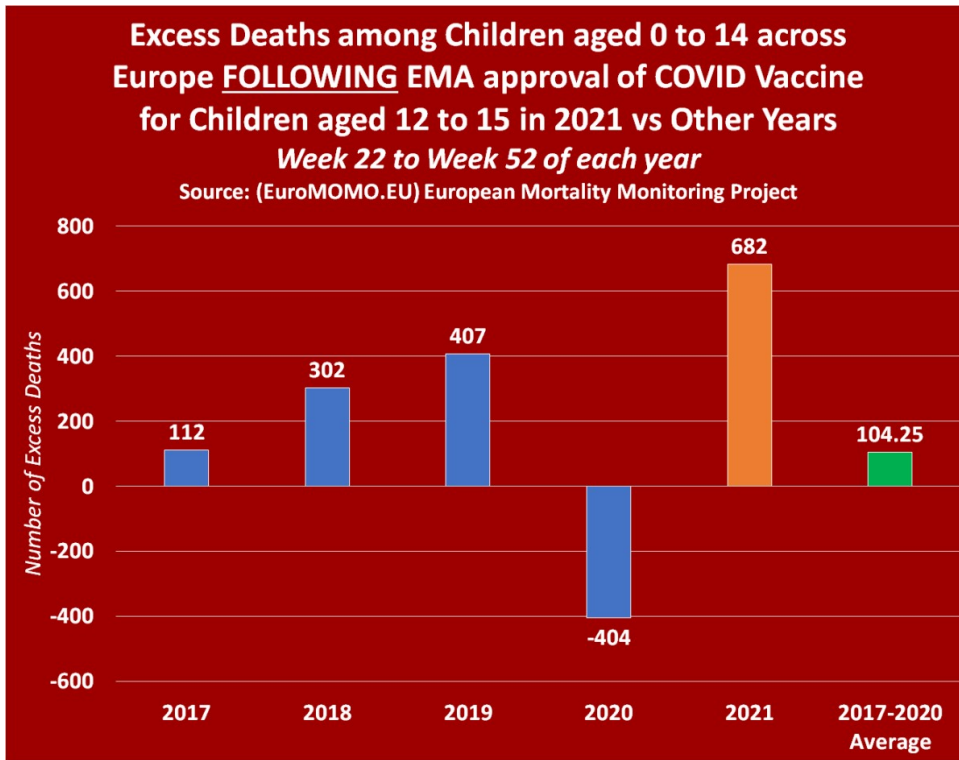

The High Court must address this point and the fact that this vitally important information has been concealed and hidden from the parents and guardians of children in Ireland and throughout the European Union. 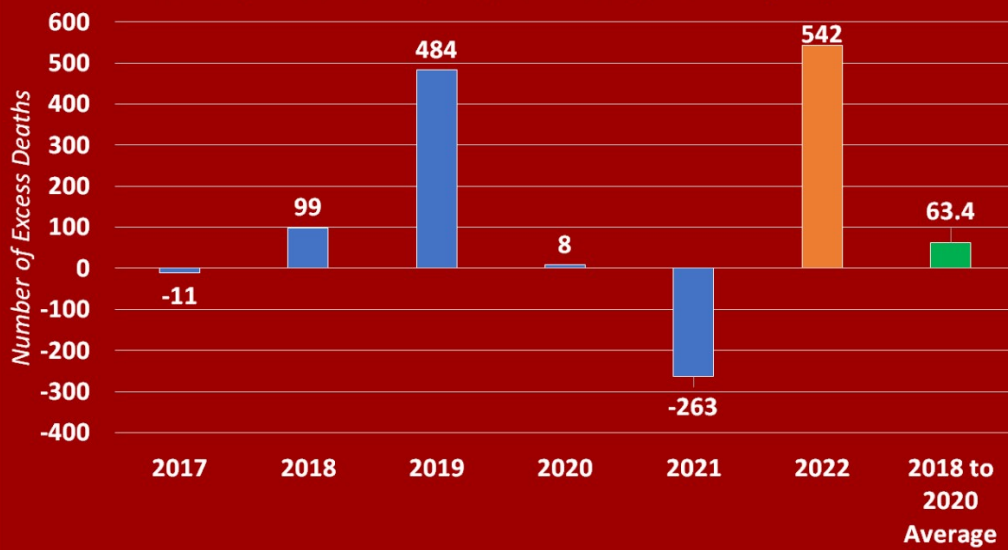
After covid19 vaccinations of children

Week 0 to Week 33 of each Year

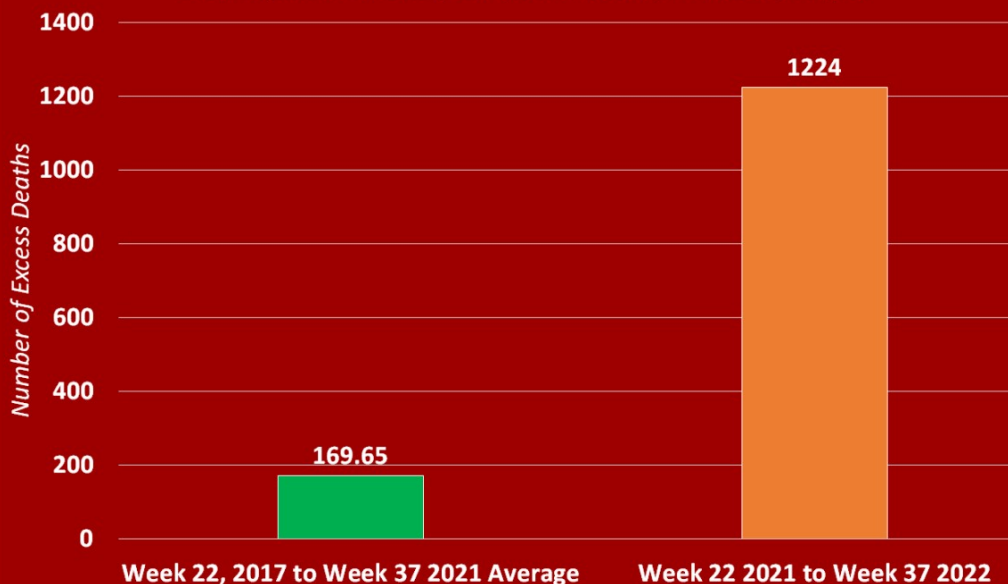

I also refer the court to Exhibit 30a which are charts from Euromomo which show a big rise in excess mortality for all age groups in the European Union from mid 2021 to the present in 2023 which correspond to mass covid19 vaccinations. And in the second chart and third chart the rise in Excess Mortality for

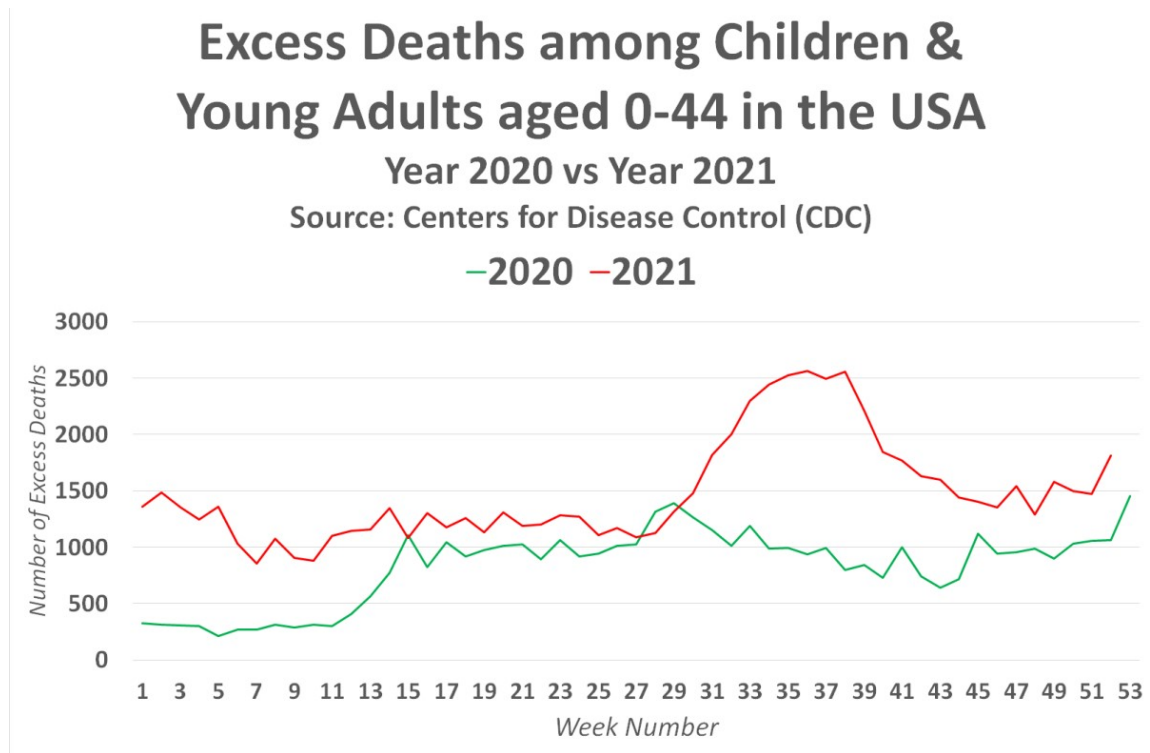

This is mass killing of children. This is illegal, unlawful, unethical and unConstitutional both in Britain and in Ireland. Parents and guardians should have been told about this but were not told. 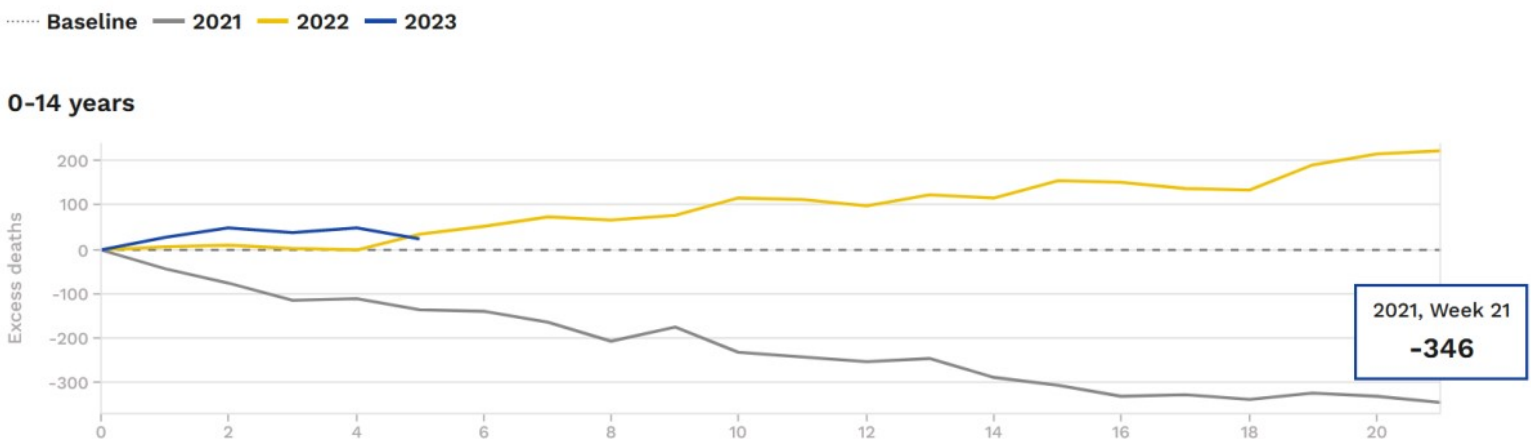

The UK Government and the UK Health Security Agency announced it would no longer offer the Covid-19 vaccine to healthy 5 to 11-year-old children in September 2022. This is very significant.

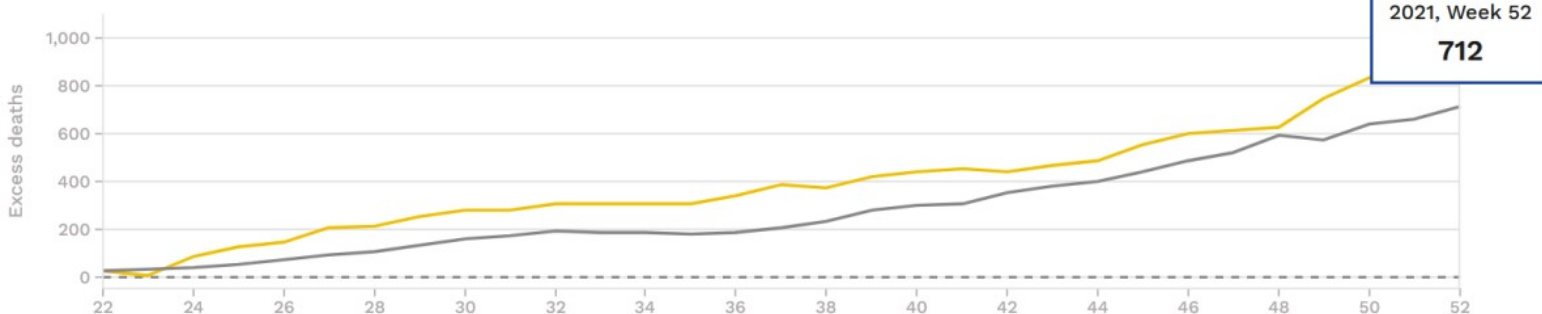
First 21 weeks of 2021



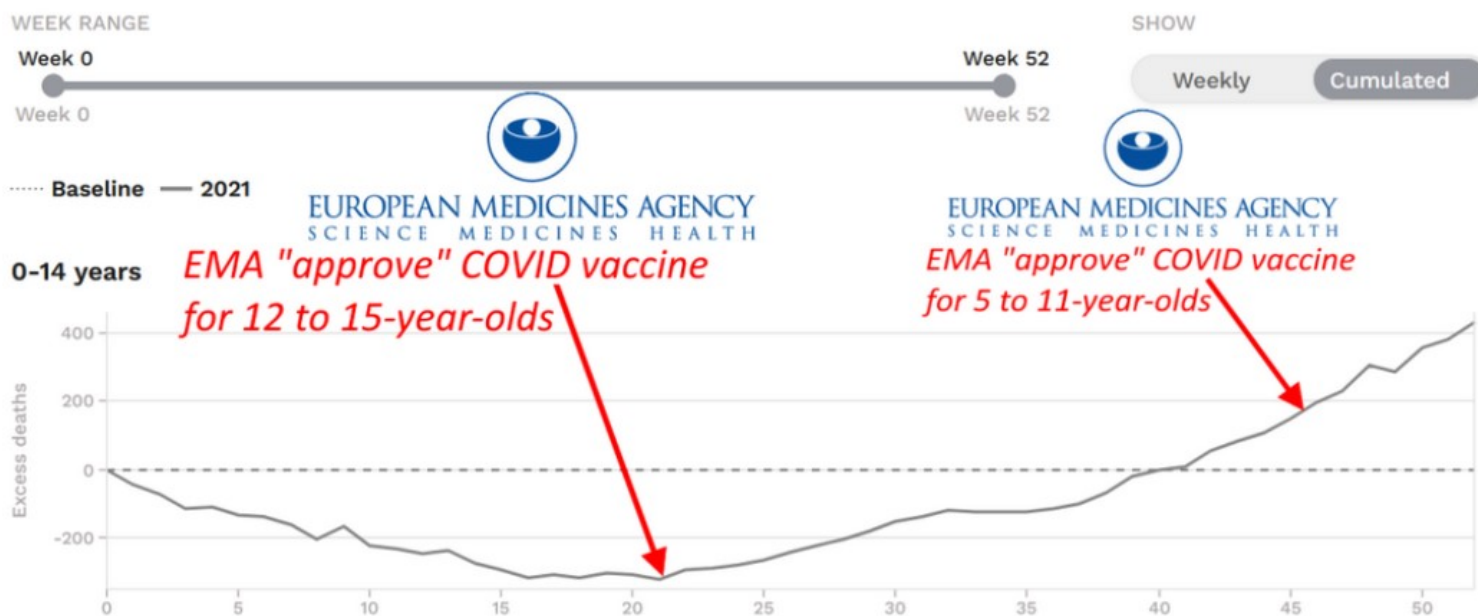

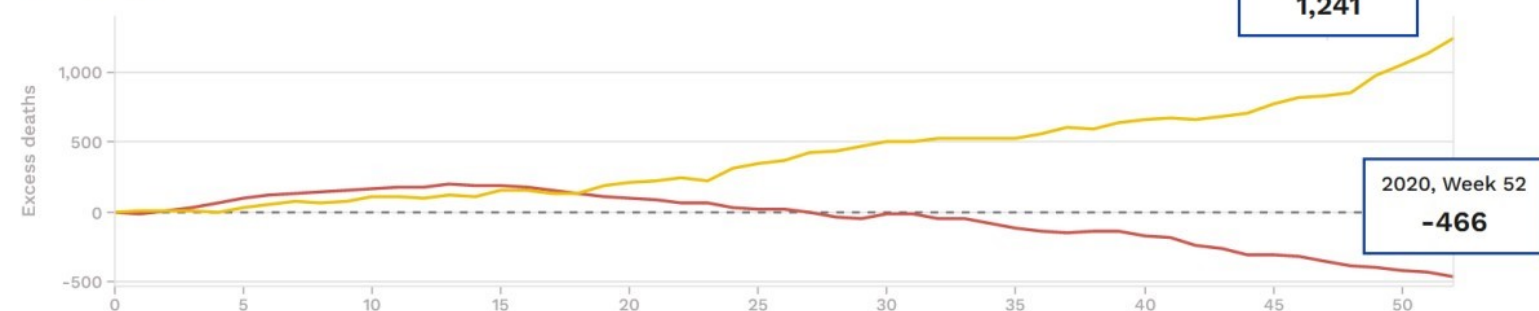
Correlation between rise in excess mortality for children and the approval of covid19 vaccines for them

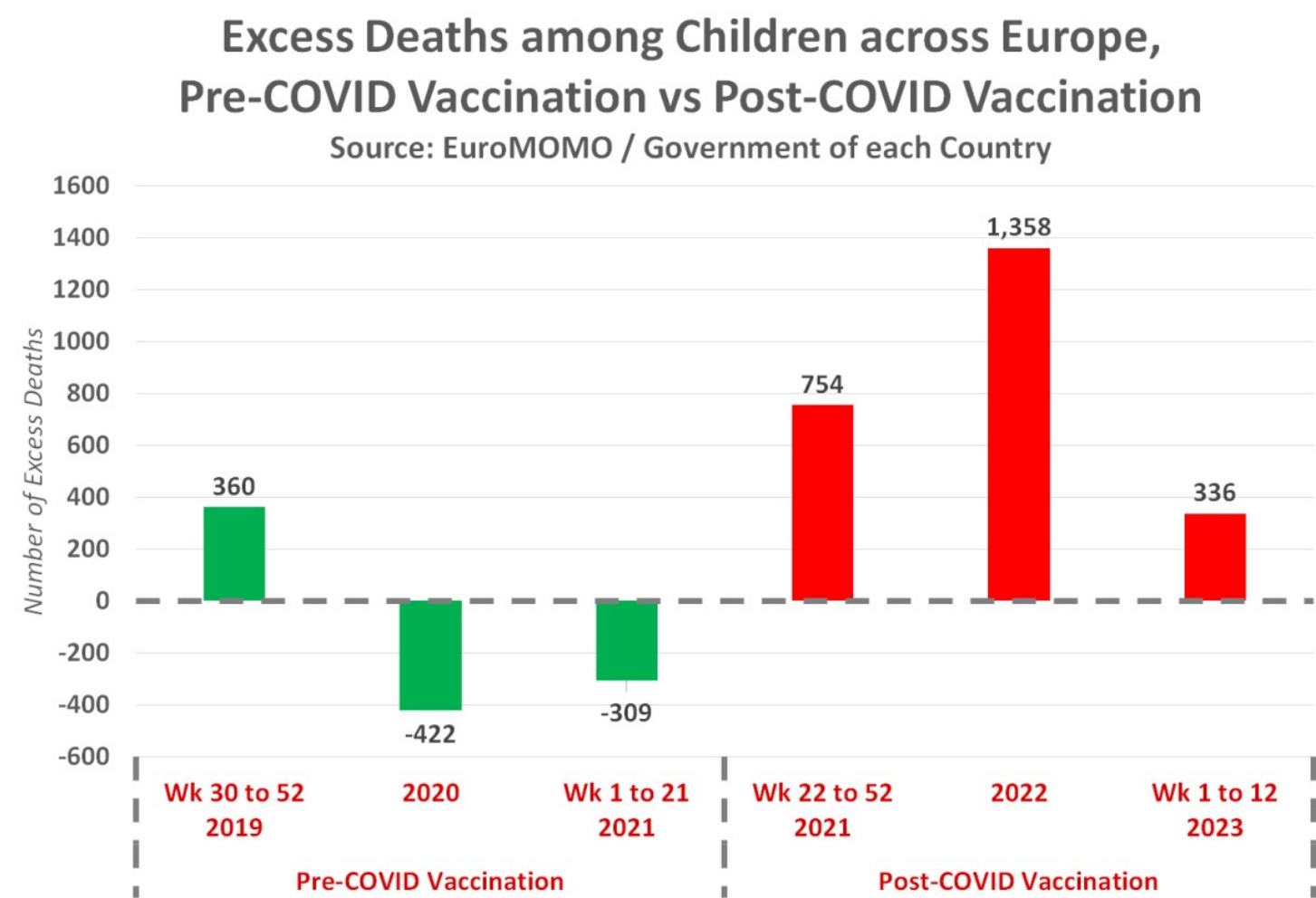

I further say that England and Wales suffered the highest number of excess deaths in over 50 years in 2022, and a non-stop weekly rally of excess deaths since week 16 of 2022 that equates to 62,543 excess deaths as of March 2023. And the main cause of this huge increase in deaths is COVID-19 vaccination.

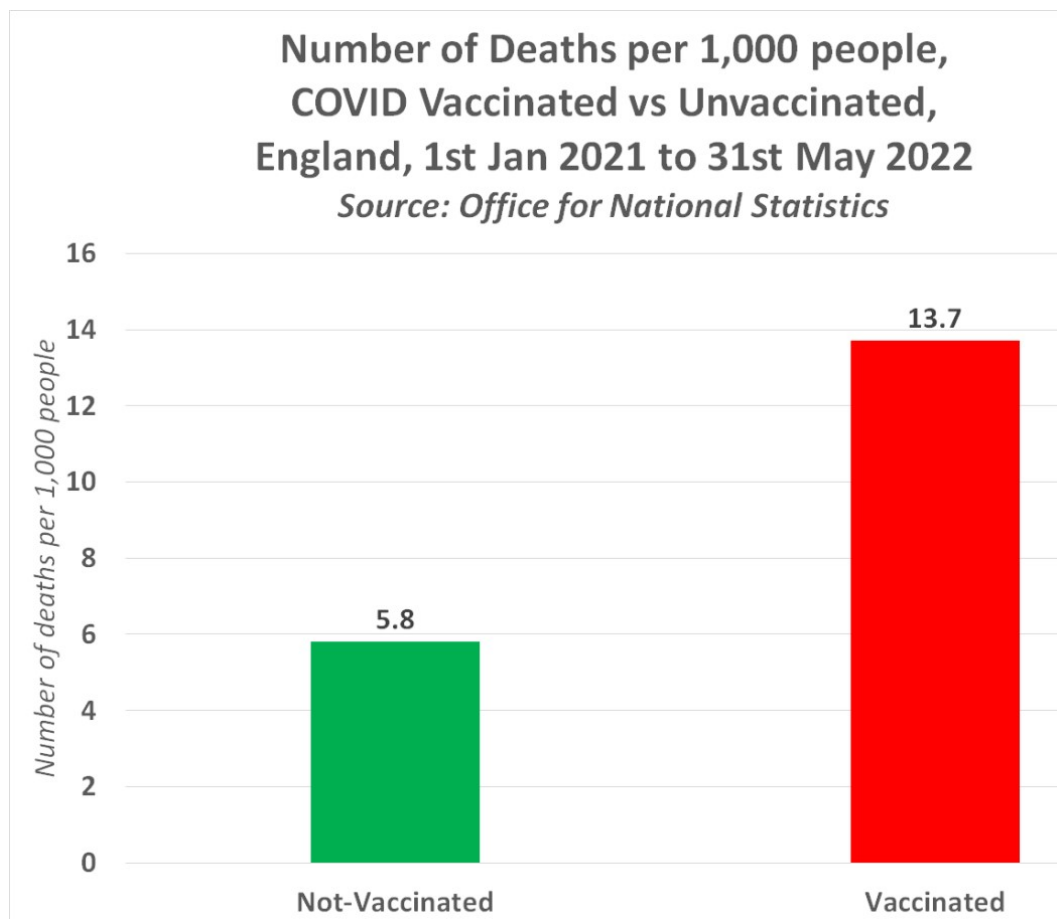

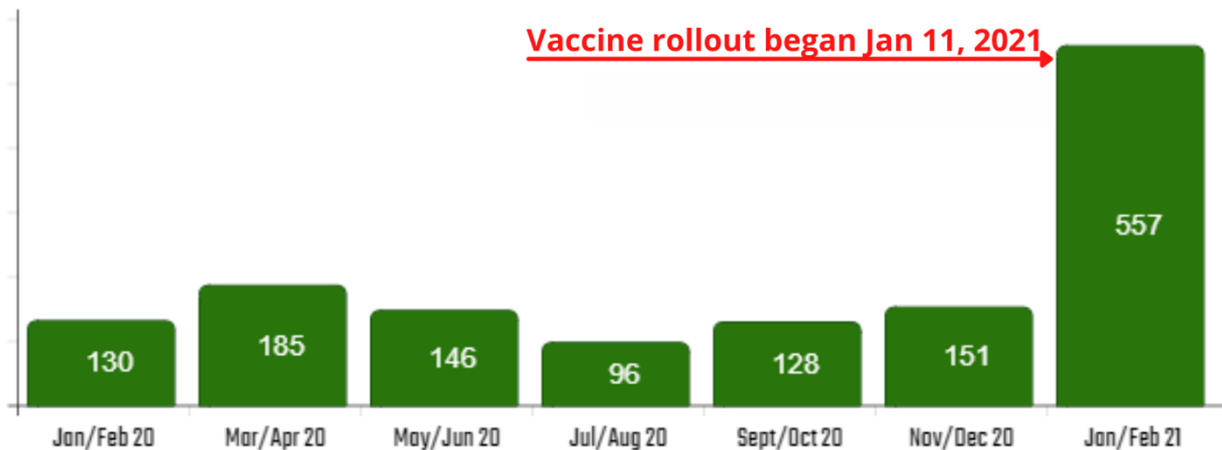

2020 - 2021



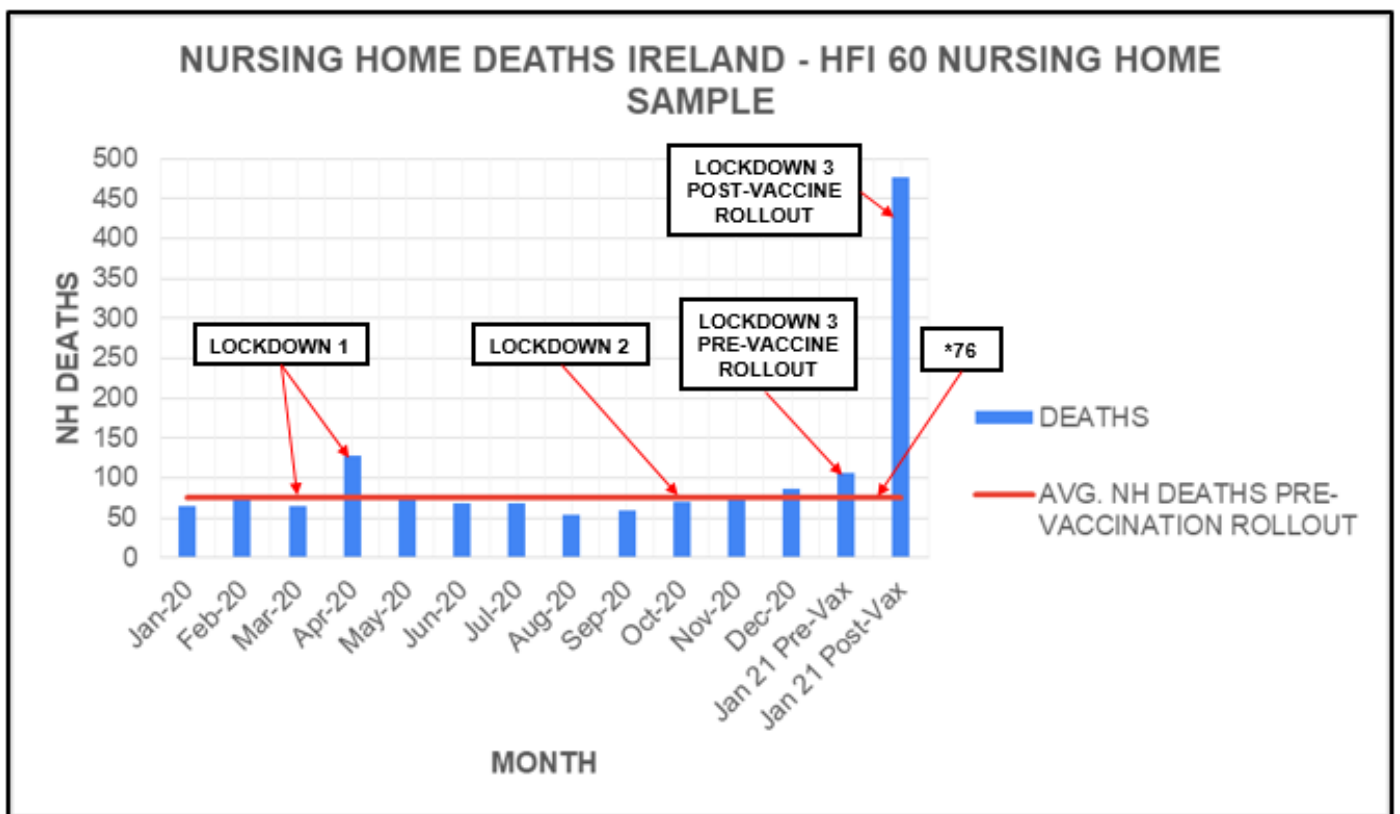

59. A scientific study in New Zealand in 2022 found a close temporal relationship between covid19 vaccination of a certain age group and excess deaths in that age group in 2021. This supports Causality.

61. More doses or repeated exposure leads to a worsening of outcomes

In paragraph 22 and Point 3 on page 68 in the previous affidavit filed with the High Court in December 2022, it was stated that more doses of the covid19 vaccine including boosters lead to higher mortality and illness and disability. This is proven further in Point 6a in January 2023 affidavit and in Exhibit 4c and Exhibit 66 showing that more doses of this vaccine led to higher all cause mortality in children. I quote from Point 6a again

“ - For those who get their two does of the covid19 vaccine they are dying at over **15 times** the rate of unvaccinated children. This is all cause mortality.

- For those who are triple vaccinated they are dying at over **45 times** the rate of unvaccinated children. This is all cause mortality. And they are **120 times** more likely to die of covid19.

Other Data from the Office for National Statistics in Britain up to march 31st 2022, shows that fully covid vaccinated children are dying at **80 times** the rate of unvaccinated children. This is all cause mortality. And they are **300 times** more likely to die of covid19. The same Pfizer covid19 vaccine is being used in Ireland and Britain for children. **These statistics are presented in Exhibit 66 for the court.”**

And an important new scientific study below also proves this and shows that more doses of a covid19 vaccine increases the risk of Myocarditis by 9 times.

CONCLUSIONS AND RELEVANCE: Results of this large cohort study indicated that both first and second doses of mRNA vaccines were associated with increased risk of myocarditis and pericarditis. For individuals receiving 2 doses of the same vaccine, risk of myocarditis was highest among young males (aged 16-24 years) after the second dose. These findings are compatible with between 4 and 7 excess events in 28 days per 100 000 vaccinees after BNT162b2, and between 9 and 28 excess events per 100 000 vaccinees after mRNA-1273.

In the above scientific study, for 16-24 year old males, post vaccination myocarditis rates were 6 (pfizer-pfizer) to 19 (moderna-moderna) to 28 (pfizer-moderna) times HIGHER than males aged 12-15. This is massive increase in risk of myocarditis for children and young adults.

In the covid19 vaccinated community itself those who got the boosters have a higher mortality than those who did not get the booster. In other words, repeated exposure to a vaccine increases mortality more. This was found by the office for National statistics in Britain in 2022. And the majority of serious harms and deaths occur within a day or a few days of receiving the vaccine. These are strong indicators of causality.

I present Exhibit 18 and Exhibit 25 to the court. Chart 3 in Exhibit 25 shows quick onset of harms.

I submit Exhibit 4c to the court providing statistical charts of data from the Office for National Statistics in Britain which show that the more covid19 vaccines children get the greater their risk of dying.

And **Exhibit 65** shows a relationship between doses of vaccine received and increased hospitalizations in Australia in 2022. This has been replicated in Ireland, Britain, Germany, EU countries, Canada and the USA. This is a good indication of Causality.

The Bradford Hill criteria show that if repeated doses or more doses of a vaccine or drug or substance leads to a worsening of known outcomes then this is significant evidence of Causality.

I further say that Joel Smalley a statistician based in Britain carried out a statistical analysis of official government statistics in Britain for the period 2020 to 2023 and found a strong correlation between covid19 vaccine doses and rises in excess mortality there. The fact that this correlation is dose dependent

fulfills an important point of the Bradford Hill criteria for Causality. In fact dose dependency is one the strongest and most convincing factors proving Causality and this has been the case for many years and decades.

I further say that at a US Senate hearing hosted by Senator Ron Johnson on December 7th 2022, that a senior insurance industry analyst named Josh Stirling testified and presented a shocking conclusion from official UK government health data. He presented statistical findings showing that those people vaccinated against COVID-19 have a 26% higher mortality rate on average compared to those who declined the jab – and the death toll is even more staggering for vaccinated people under 50 years old, where mortality is 49% higher than for those unvaccinated. And he showed that the people who only took one dose of the vaccine have an approximately “145% worse mortality rate” . I further say that in respect of risk analysis and Cost Benefit Analysis, that a top insurance research analyst, Mr. Josh Stirling, has found a 7% aggregate mortality increase for each covid19 vaccine dose received, meaning a “fully vaccinated” individual who took 5 doses increased their risk of death by 35%. 62. An international scientific and medical conference in Stockholm on 21-22 January 2023 gathered 15 leading doctors, researchers and lawyers from the US, Canada, UK, Germany, France, Belgium, Switzerland, Israel, Ukraine and Norway, and Sweden. The scientific and medical evidence they presented is shown on videos on the following web site - <https://lakaruppropet.se/international-conference-pandemic-strategies/>

Their scientific and medical findings corroborate the evidence in our affidavits filed in the High Court and our books of evidence in relation to covid19 vaccines.

63. We will present an army of covid19 vaccine injured to the High Court in this High Court case to give their testimony to the High Court. These people did not give their full and valid informed consent for these vaccines, as they were not told about the dangers and risks of these vaccines and the high number of vaccine injuries, illnesses, disabilities, and deaths. And they will state that all they told was that the vaccines were "safe and effective" by the Irish government and health authorities and by their parrots in the press and media. Now these vaccine injured people are suffering the consequences in terms of new illnesses and disabilities, loss of income and career, and the higher risk of premature death.
64. We will present top scientists and medical doctors as expert witnesses for this High Court case who will confirm and verify the evidence we present to the court, and the harms caused by the covid19 vaccines and the fact that full and valid informed consent was not given for these vaccines.
65. An analysis of sudden deaths of healthy young persons aged under 45 from mid 2021 to the present in 2023 in Ireland reveals a rising trend in this type of death among that age group. There was a big rise in the sudden deaths of healthy young people under 45 during the period of mass covid19 vaccinations. The web site www.rip.ie and statistics in the CSO and HSE which have not been released to the public yet

confirm this trend. The same is happening in the USA and in the UK and many other countries during this time period. The period of mass covid19 vaccinations.

What is causing this high number of healthy young people under 45 to die suddenly in that period of time, which is the same period of time as mass covid19 vaccinations ? and why is it occurring in many countries which are highly vaccinated during that period of time ? and why is not occurring in countries with very low covid19 vaccination rates ? the government and health authorities are unable or are refusing to answer that question. They have so called “experts” with many qualifications and much prestige but they are unable to answer this very important question. 66. These experts testified about the dangers of the covid19 vaccines and that the vaccines are unsafe and ineffective and have led to record number of vaccine injuries, illnesses, disabilities and deaths. 67. I further say that more evidence of antibody dependent enhancement or immune priming and the virus mutating to escape the vaccine and continue infecting people is emerging all the time. This corroborates Point 31 above and the evidence in our previous affidavits and books of evidence.

In Exhibit 101, official government statistical data from Scotland, New Zealand, and Canada is presented showing higher rates of covid19 infection and deaths among the vaccinated.

68. Extremely rare diseases suddenly becoming more common after mass covid19 vaccinations. And this happening across many countries and continents during the same time period. Myocarditis and pericarditis and heart inflammation and heart attacks are extremely rare in children but these have suddenly become more common after mass covid19 vaccinations of children from mid 2021 onwards. Also one finds a relationship between more doses of this vaccine and a higher risk of developing these heart abnormalities or worsening of them and dying. Also CJD is very rare and is typically seen at a rate of 1 or 0.5 in a million. The protein misfolding being attributed to the effects of the spike protein in covid19 vaccines has led to a big rise in CJD type diseases in 2021 and 2022. Data from Germany shows a massive and sudden increase in CJD in 2021 after mass covid19 vaccinations. It goes completely against the trend

of previous years.

The fact that CJD is very rare and now suddenly it is becoming more common after mass covid19 vaccinations in 2021 and 2022 points to the role of this vaccine.

A search on VAERS of the CDC (search for “Creutzfeldt”) discovered from 1990-2020, a total of 12 cases of CJD had been reported, most of which did not have causation asserted by the reporter, whereas in 2021, 33 cases were reported, and 40 have thus far been reported in 2022 (December 4th). Of these 73 cases, most noted a temporal correlation suggesting CJD resulted from the vaccine, and 72 were listed as being from a COVID-19 vaccine, while one was listed as unknown.

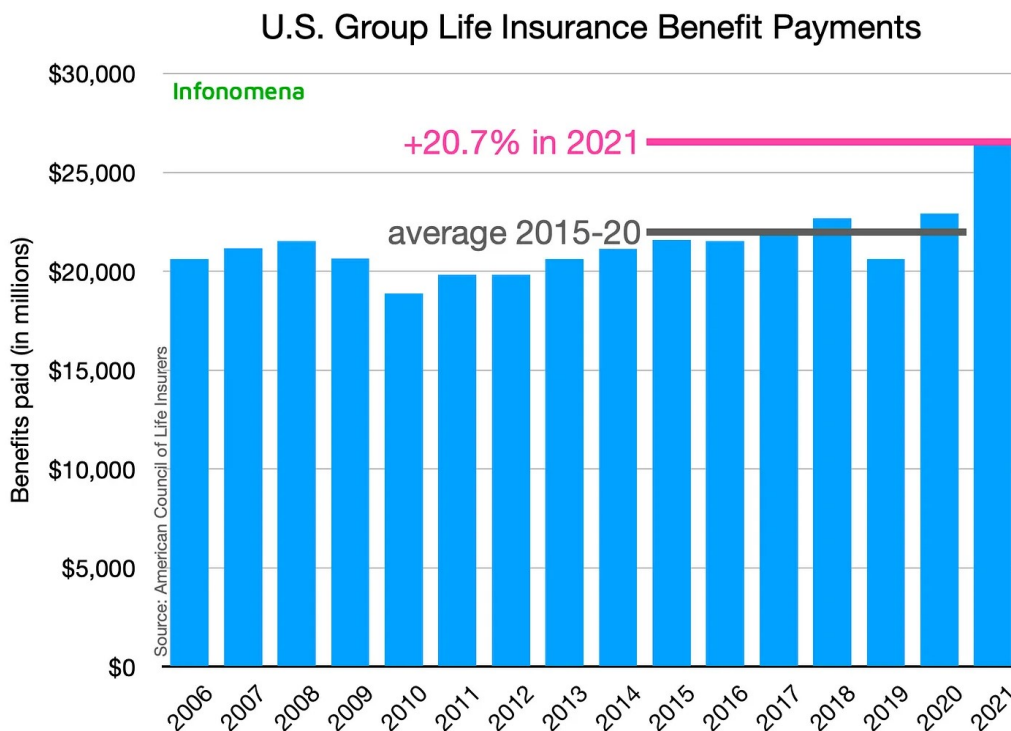

I further say that the rise in excess mortality figures is reflected in the life insurance data showing increased deaths of young adults and working age people, and that confirms and corroborates evidence in our sworn affidavits and books of evidence. Official insurance and US government statistics provided by Bret Swanson on <https://infonomena.substack.com/p/whered-all-the-workers-go> show massive rises in deaths of young adults and working age people in 2021 and 2022 after mass covid19 vaccinations. A chart of group life insurance payments presented on his site is shown below. This along with other evidence proves the point.



This is corroborated by life insurance data and information provided by top life insurance firms in the USA and Europe showing a sudden big rise in the deaths of persons of working age and those people under 40 years old after mass covid19 vaccinations began in Spring 2021. - 72.** I say that the evidence in our affidavits filed in the High Court since November 2022 and into 2023 and in our books of evidence clearly point to a strong link between mass covid19 vaccinations and the development of vaccine injuries, serious illnesses, disabilities and deaths and a big rise in excess mortality

and a big rise in disability figures since mid 2021. It all points to mass covid19 vaccinations across many countries and continents from mid 2021 to the present in 2023.

73. I say that there is more corroborating evidence of mass killing in 2021 and 2022.

On 12th December, 2022, the AFD party in Germany hosted a press conference to unveil the data on 72 million patients (the 90% of Germans with statutory health insurance) they had obtained from the Association of Statutory Health Insurance Physicians (KBV), the association which represents all physicians who receive insurance in Germany. German parliamentarian Martin Sichert and data analyst Tom Lausen forced this data to be released via an FOI. This data summarises the number of times all ICD-10 (an international standard) diagnostic codes were used by German healthcare providers for these patients (***outside of hospitals***) from the first quarter of 2016 to the first quarter of 2022. The years 2021 and 2022 show a massive increase in sudden deaths and deaths within 24 hours of symptoms. This increase is far greater than previous years. I present Exhibit 34 to the court which is a statistics chart of the data on 72 million patients (the 90% of Germans with statutory health insurance) in Germany the AFD party obtained from KBV, the association which represents all physicians who receive insurance in Germany. The second chart on page 2 shows that most of these increased deaths are cardiovascular related.

I present Exhibit 35 to the court which is a statistics chart from the aforementioned dataset from Germany above which shows that there was a large increase in sudden cardiac deaths in 2021 and 2022 in Germany.

In the conclusion of his presentation to the German public, Tom Lausen calls for the immediate suspension of the COVID jabs until correlation between the shots and death can be conclusively ruled out. He also calls for:

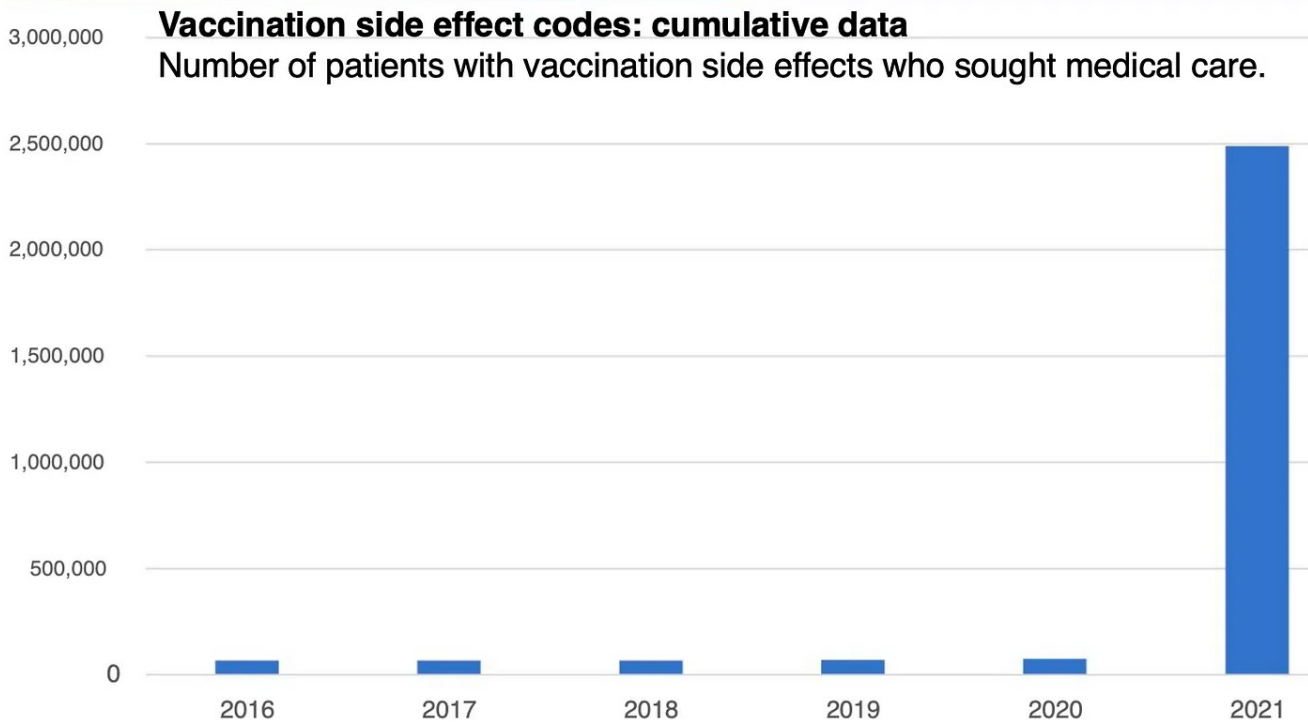
- Autopsies on all who died suddenly to determine what the massive increase is due to

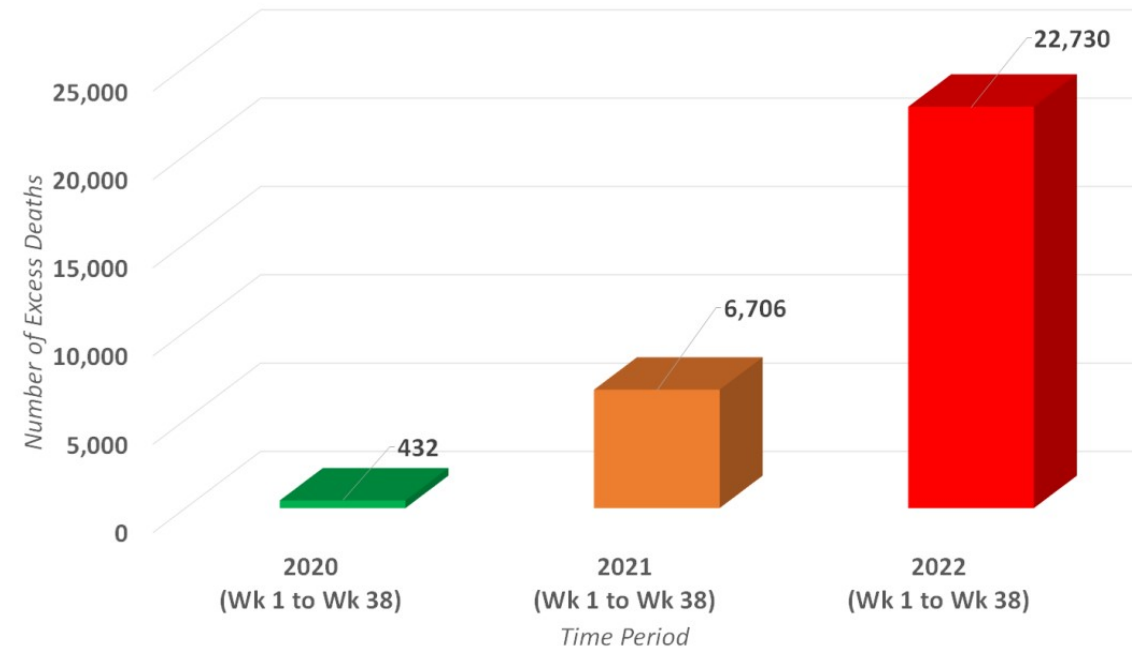

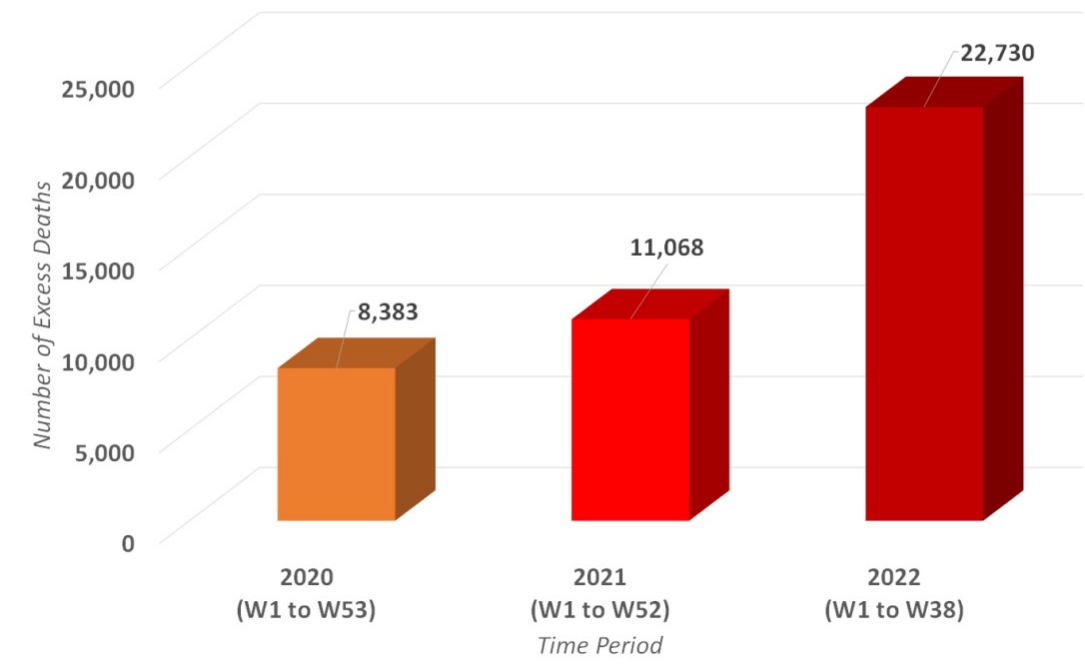

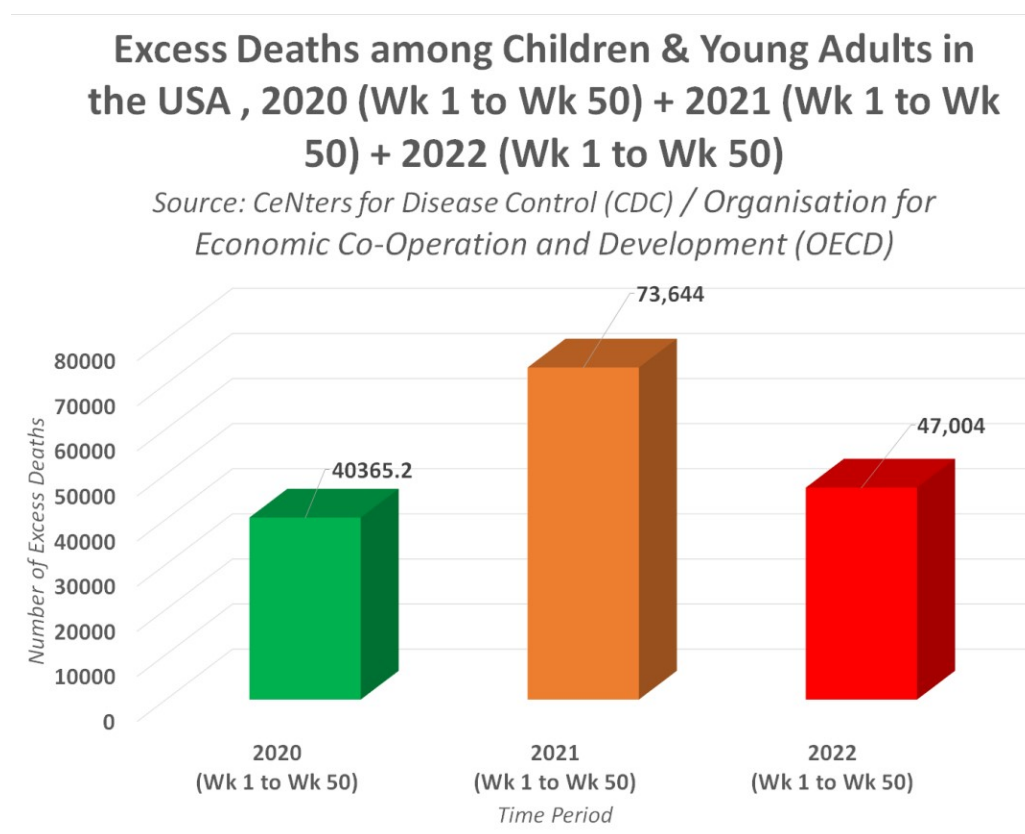

Australia suffered a shocking 5,162% increase in excess deaths in the first 38 weeks of 2022 following the rollout of the Covid-19 vaccinations compared to the first 38 weeks of 2020, at the height of the Covid-19 pandemic, and prior to the rollout of a single Covid-19 vaccinations. 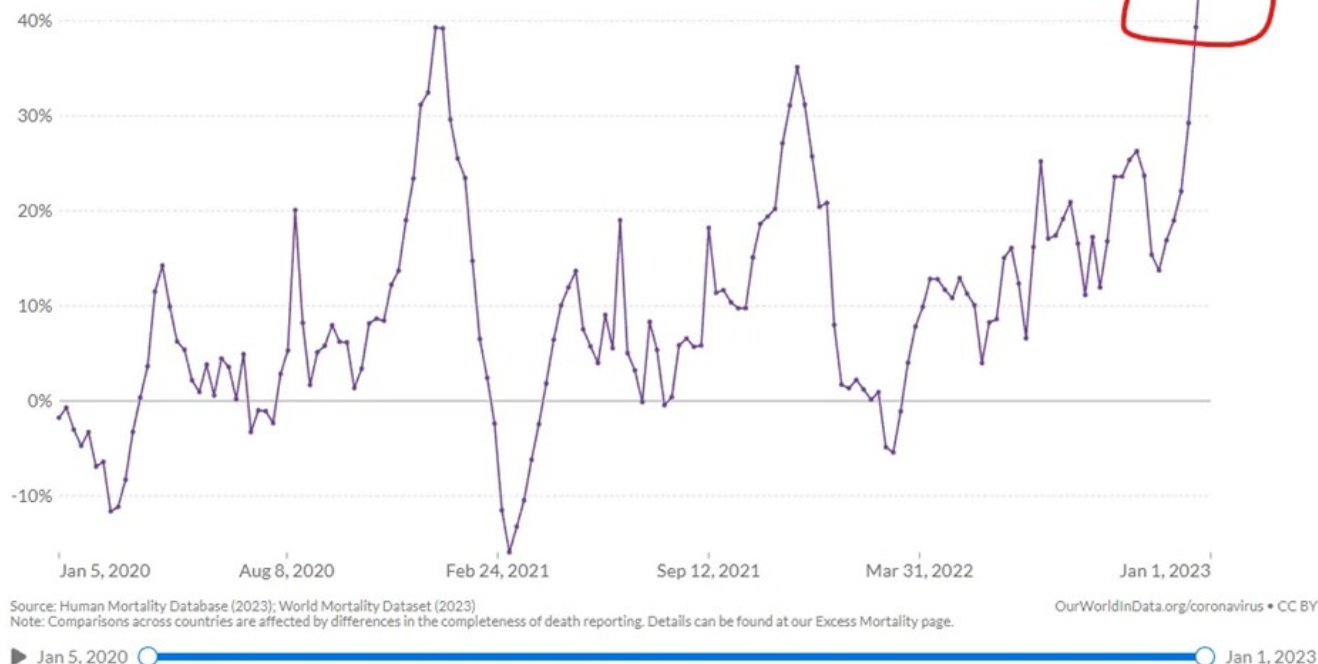

I further say that Ireland is also experiencing a big rise in excess deaths in 2023 and that figures obtained on RIP.ie and analyzed by the *Irish Examiner* newspaper show that deaths were 42% higher from 1 December 2022 to 25 January 2023 (9,718 deaths) compared to the 8 weeks to 25 January 2019 (6,802 deaths).

Mayo solicitor Pat O'Connor says he has never seen so many deaths in 30 years as a coroner as in the past few months.

He has just filed his figures for last month to the Department of Justice – 89 deaths were reported to him in January, up from 56 in January 2022, an increase of almost 60 per cent. The 1,008 deaths recorded in all of last year is almost double the 541 deaths recorded before the Covid pandemic, in 2018.

There have been calls for parliamentary investigations and official investigations into these excess deaths in Ireland and in Britain. But, this is being ignored by both governments and by state bodies. No credible reason has been given for this. The evidence shows that a cover up is in place. From July to December 2022 overall deaths are up 162 (41%) compared to July to December 19. That's 324 extra deaths in a full year, over six a week.

July to December 2022 sudden deaths are up 46 (131%) compared to July to December 19, nearly two extra a week.

He has provided statistical charts of this and these are presented in **Exhibit 74 for the High Court**.

These charts show a massive increase in excess mortality in 2022. This correlates to the combination of mass covid19 vaccinations in 2021 and mass boosters in 2022.
